November 10, 2005, Introduced by Senators HARDIMAN, JOHNSON, CASSIS, CROPSEY and GOSCHKA and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411u.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411U. (1) A PERSON SHALL NOT DAMAGE, DESTROY, DISCONNECT,
- 2 OR OTHERWISE PREVENT ACCESS TO A TELECOMMUNICATIONS DEVICE TO
- 3 PREVENT THE USE OF THAT TELECOMMUNICATIONS DEVICE TO REPORT
- 4 DOMESTIC VIOLENCE OR TO OBTAIN MEDICAL, LEGAL, OR OTHER ASSISTANCE
 - THAT IS REQUIRED OR DESIRED AS A RESULT OF DOMESTIC VIOLENCE.
 - (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CRIME AS FOLLOWS:
 - (A) EXCEPT AS PROVIDED IN SUBDIVISION (B), THE PERSON IS
- 9 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
 - THAN 90 DAYS OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.

- 1 (B) IF THE DOMESTIC VIOLENCE RESULTS IN INJURY TO OR THE DEATH
- 2 OF ANY PERSON, THE PERSON VIOLATING THIS SECTION IS GUILTY OF A
- 3 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A
- 4 FINE OF NOT MORE THAN \$5,000.00, OR BOTH.
- 5 (3) THIS SECTION DOES NOT PROHIBIT THE PERSON FROM BEING

- 13 (B) "TELECOMMUNICATIONS DEVICE" MEANS A DEVICE DESIGNED OR
- 14 INTENDED TO BE USED FOR COMMUNICATIONS THROUGH A COMMUNICATIONS
- 15 SERVICE.
- 16 (C) "COMMUNICATIONS SERVICE" MEANS THAT TERM AS DEFINED IN
- 17 SECTION 102 OF THE MICHIGAN TELECOMMUNICATIONS ACT, 1991 PA 179,
- 18 MCL 484.2102.
