HOUSE SUBSTITUTE FOR SENATE BILL NO. 1576

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

by amending section 3341 (MCL 500.3341), as amended by 2002 PA 656.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3341. As part of its secondary or merit rating plan, the
- 2 facility shall provide for premium surcharges for any or all
- 3 coverages, other than comprehensive coverage, for convictions for 1
- 4 or more of the following, when that information becomes available
- 5 to the facility:
- 6 (a) A violation of section 904 of the Michigan vehicle code,
- 7 1949 PA 300, MCL 257.904.
- 8 (b) A violation of section 904a of the Michigan vehicle code,
- 9 1949 PA 300, MCL 257.904a.

- 1 (c) A violation of section 91 of the Michigan penal code, 1931
- 2 PA 328, MCL 750.91, resulting from or in connection with the
- 3 operation of a motor vehicle.
- 4 (d) A violation of section 316 of the Michigan penal code,
- 5 1931 PA 328, MCL 750.316, resulting from or in connection with the
- 6 operation of a motor vehicle.
- 7 (e) A violation of section 317 of the Michigan penal code,
- 8 1931 PA 328, MCL 750.317, resulting from or in connection with the
- 9 operation of a motor vehicle.
- 10 (f) A violation of section 321 of the Michigan penal code,
- 11 1931 PA 328, MCL 750.321, resulting from or in connection with the
- 12 operation of a motor vehicle.
- 13 (g) A violation of section 324 of the Michigan penal code,
- 14 1931 PA 328, MCL 750.324, OR SECTION 601D OF THE MICHIGAN VEHICLE
- 15 CODE, 1949 PA 300, MCL 257.601D.
- 16 (h) A violation of section 382 of the Michigan penal code,
- 17 1931 PA 328, MCL 750.382, resulting from or in connection with the
- 18 operation of a motor vehicle.
- 19 (i) A violation of section 413 of the Michigan penal code,
- 20 1931 PA 328, MCL 750.413.
- 21 (j) A violation of section 626c of the motor MICHIGAN vehicle
- 22 code, 1949 PA 300, MCL 257.626c.
- 23 (k) A violation substantially similar to any of the violations
- 24 listed in subdivisions (a) through (j) under the laws of another
- 25 state or a local unit of government of this state or another state.
- 26 Enacting section 1. This amendatory act does not take effect
- 27 unless Senate Bill No. 104 of the 94th Legislature is enacted into

- 1 law.
- Enacting section 2. This amendatory act takes effect October 2
- **3** 31, 2010.
