- 1 SEC. 66. (1) IF A PERSON HAS CUSTODY OF A DOG OR WOLF-DOG
- 2 CROSS AND THE PERSON KNOWS OR HAS REASON TO KNOW THAT THE DOG OR
- 3 WOLF-DOG CROSS HAS BITTEN ANY INDIVIDUAL, THE PERSON SHALL
- 4 IMMEDIATELY DO BOTH OF THE FOLLOWING:
- 5 (A) PROVIDE THE INDIVIDUAL WHO WAS BITTEN WITH ALL OF THE
- 6 FOLLOWING INFORMATION:
- 7 (i) HIS OR HER NAME AND ADDRESS AND, IF THAT PERSON DOES NOT
- 8 OWN THE DOG OR WOLF-DOG CROSS, THE NAME AND ADDRESS OF THE DOG'S OR
  - WOLF-DOG CROSS'S OWNER.
