SUBSTITUTE FOR HOUSE BILL NO. 5364

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding part 55A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 55A. ARTHRITIS PREVENTION AND CONTROL
- 2 SEC. 5551. THIS PART SHALL BE KNOWN AND MAY BE CITED AS THE
- 3 "ARTHRITIS PREVENTION AND CONTROL ACT".
- 4 SEC. 5555. THE PURPOSES OF THIS PART ARE AS FOLLOWS:
- 5 (A) TO CREATE AND FOSTER A STATEWIDE PROGRAM THAT PROMOTES
- 6 PUBLIC AWARENESS AND INCREASES KNOWLEDGE ABOUT THE CAUSES OF
- 7 ARTHRITIS, THE IMPORTANCE OF EARLY DIAGNOSIS AND APPROPRIATE
- 8 MANAGEMENT, EFFECTIVE PREVENTION STRATEGIES, AND PAIN PREVENTION
- 9 AND MANAGEMENT.
- 10 (B) TO DEVELOP KNOWLEDGE AND ENHANCE UNDERSTANDING OF
- 11 ARTHRITIS BY DISSEMINATING EDUCATIONAL MATERIALS, INFORMATION ON

- 1 RESEARCH RESULTS, SERVICES PROVIDED, AND STRATEGIES FOR PREVENTION
- 2 AND CONTROL TO PATIENTS, HEALTH PROFESSIONALS, AND THE PUBLIC.
- 3 (C) TO ESTABLISH A SOLID SCIENTIFIC BASE OF KNOWLEDGE ON THE
- 4 PREVENTION OF ARTHRITIS AND RELATED DISABILITY THROUGH
- 5 SURVEILLANCE, EPIDEMIOLOGY, AND PREVENTION RESEARCH.
- 6 (D) TO UTILIZE EDUCATIONAL AND TRAINING RESOURCES AND SERVICES
- 7 DEVELOPED BY ORGANIZATIONS WITH APPROPRIATE EXPERTISE AND KNOWLEDGE
- 8 OF ARTHRITIS AND TO USE AVAILABLE TECHNICAL ASSISTANCE.
- 9 (E) TO EVALUATE THE NEED FOR IMPROVING THE QUALITY AND
- 10 ACCESSIBILITY OF EXISTING COMMUNITY-BASED ARTHRITIS SERVICES.
- 11 (F) TO HEIGHTEN AWARENESS ABOUT THE PREVENTION, DETECTION, AND
- 12 TREATMENT OF ARTHRITIS AMONG STATE AND LOCAL HEALTH OFFICIALS,
- 13 HEALTH PROFESSIONALS AND OTHER HEALTH CARE PROVIDERS, AND POLICY
- 14 MAKERS.
- 15 (G) TO IMPLEMENT AND COORDINATE STATE AND LOCAL PROGRAMS AND
- 16 SERVICES TO REDUCE THE PUBLIC HEALTH BURDEN OF ARTHRITIS.
- 17 (H) TO ADEQUATELY FUND THE PROGRAMS DESCRIBED IN SUBDIVISION
- 18 (G) ON A STATE LEVEL.
- 19 (I) TO PROVIDE LASTING IMPROVEMENTS IN THE DELIVERY OF HEALTH
- 20 CARE FOR INDIVIDUALS WITH ARTHRITIS AND THEIR FAMILIES, THUS
- 21 IMPROVING THEIR QUALITY OF LIFE WHILE ALSO CONTAINING HEALTH CARE
- 22 COSTS.
- 23 SEC. 5557. UPON APPROPRIATION OF NECESSARY FUNDING, THE
- 24 DIRECTOR OF THE DEPARTMENT SHALL DO ALL OF THE FOLLOWING:
- 25 (A) PROVIDE SUFFICIENT STAFF TO IMPLEMENT THE ARTHRITIS
- 26 PREVENTION AND CONTROL PROGRAM.
- 27 (B) PROVIDE APPROPRIATE TRAINING FOR THE STAFF OF THE

- 1 ARTHRITIS PREVENTION AND CONTROL PROGRAM.
- 2 (C) IDENTIFY THE APPROPRIATE ORGANIZATIONS TO CARRY OUT THE
- 3 PROGRAM.
- 4 (D) BASE THE PROGRAM ON THE MOST CURRENT SCIENTIFIC
- 5 INFORMATION AND FINDINGS.
- 6 (E) WORK TO INCREASE AND IMPROVE COMMUNITY-BASED SERVICES
- 7 AVAILABLE TO PEOPLE WITH ARTHRITIS AND THEIR FAMILY MEMBERS.
- 8 (F) WORK WITH GOVERNMENTAL OFFICES, NATIONAL VOLUNTARY HEALTH
- 9 ORGANIZATIONS AND THEIR LOCAL CHAPTERS, COMMUNITY AND BUSINESS
- 10 LEADERS, COMMUNITY ORGANIZATIONS, AND HEALTH CARE AND HUMAN SERVICE
- 11 PROVIDERS TO COORDINATE EFFORTS AND MAXIMIZE STATE RESOURCES IN THE
- 12 AREAS OF PREVENTION, EDUCATION, DETECTION, PAIN MANAGEMENT, AND
- 13 TREATMENT OF ARTHRITIS.
- 14 (G) IDENTIFY AND, WHEN APPROPRIATE, USE EVIDENCE-BASED
- 15 ARTHRITIS PROGRAMS AND OBTAIN RELATED MATERIALS AND SERVICES FROM
- 16 ORGANIZATIONS WITH APPROPRIATE EXPERTISE AND KNOWLEDGE OF
- 17 ARTHRITIS.
- 18 SEC. 5559. (1) UPON APPROPRIATION OF NECESSARY FUNDING, THE
- 19 DEPARTMENT SHALL ESTABLISH, PROMOTE, AND MAINTAIN AN ARTHRITIS
- 20 PREVENTION AND CONTROL PROGRAM IN ORDER TO RAISE PUBLIC AWARENESS,
- 21 EDUCATE CONSUMERS, EDUCATE AND TRAIN HEALTH PROFESSIONALS,
- 22 TEACHERS, AND HUMAN SERVICES PROVIDERS, AND FOR OTHER PURPOSES.
- 23 (2) UPON APPROPRIATION OF NECESSARY FUNDING, THE DEPARTMENT
- 24 SHALL CONDUCT A NEEDS ASSESSMENT TO IDENTIFY ALL OF THE FOLLOWING,
- 25 AS IT RELATES TO ARTHRITIS:
- 26 (A) EPIDEMIOLOGICAL AND OTHER PUBLIC HEALTH RESEARCH BEING
- 27 CONDUCTED WITHIN THE STATE.

- 1 (B) AVAILABLE TECHNICAL ASSISTANCE AND EDUCATIONAL MATERIALS
- 2 AND PROGRAMS NATIONWIDE AND WITHIN THE STATE.
- 3 (C) THE LEVEL OF PUBLIC AND PROFESSIONAL ARTHRITIS AWARENESS.
- 4 (D) THE NEEDS OF PEOPLE IN THIS STATE WITH ARTHRITIS, THEIR
- 5 FAMILIES, AND CAREGIVERS.
- 6 (E) EDUCATIONAL AND SUPPORT SERVICE NEEDS OF HEALTH CARE
- 7 PROVIDERS, INCLUDING, BUT NOT LIMITED TO, PHYSICIANS, NURSES, AND
- 8 MANAGED CARE ORGANIZATIONS.
- 9 (F) THE SERVICES AVAILABLE TO A PERSON WITH ARTHRITIS.
- 10 (G) THE EXISTENCE OF ARTHRITIS TREATMENT, SELF-MANAGEMENT,
- 11 PHYSICAL ACTIVITY, AND OTHER EDUCATION PROGRAMS.
- 12 (H) THE EXISTENCE OF REHABILITATION SERVICES.
- 13 (3) UPON APPROPRIATION OF NECESSARY FUNDING, THE DEPARTMENT
- 14 SHALL ESTABLISH AND COORDINATE AN ADVISORY PANEL ON ARTHRITIS THAT
- 15 WILL PROVIDE NONGOVERNMENTAL INPUT REGARDING THE ARTHRITIS
- 16 PREVENTION AND CONTROL PROGRAM. MEMBERSHIP SHALL INCLUDE, BUT IS
- 17 NOT LIMITED TO, PERSONS WITH ARTHRITIS, PUBLIC HEALTH EDUCATORS,
- 18 MEDICAL EXPERTS ON ARTHRITIS, PROVIDERS OF ARTHRITIS HEALTH CARE,
- 19 PERSONS KNOWLEDGEABLE IN HEALTH PROMOTION AND EDUCATION, AND
- 20 REPRESENTATIVES OF NATIONAL ARTHRITIS ORGANIZATIONS AND THEIR LOCAL
- 21 CHAPTERS.
- 22 (4) UPON APPROPRIATION OF NECESSARY FUNDING, THE DEPARTMENT
- 23 SHALL USE, BUT IS NOT LIMITED TO, STRATEGIES CONSISTENT WITH THE
- 24 NATIONAL ARTHRITIS ACTION PLAN, THE MICHIGAN ARTHRITIS ACTION PLAN,
- 25 AND OTHER EXISTING STATE PLANNING EFFORTS TO RAISE PUBLIC AWARENESS
- 26 AND KNOWLEDGE ON THE CAUSES AND NATURE OF ARTHRITIS, PERSONAL RISK
- 27 FACTORS, VALUE OF PREVENTION AND EARLY DETECTION, WAYS TO MINIMIZE
