

HOUSE BILL No. 6059

May 6, 2008, Introduced by Rep. McDowell and referred to the Committee on Appropriations.

A bill to amend 1997 PA 70, entitled
"Compulsive gaming prevention act,"
by amending section 3 (MCL 432.253).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. (1) The compulsive gaming prevention fund is created
2 within the department of treasury.

3 (2) All of the following shall be deposited in the compulsive
4 gaming prevention fund:

5 (a) The money appropriated from the state services fee fund
6 created ~~under~~ **IN SECTION 12A OF** the Michigan gaming control and
7 revenue act, ~~the Initiated Law of 1996 IL 1, MCL 432.201 to 432.216~~
8 **432.212A**, for the compulsive gaming prevention fund.

9 (b) A percentage of the net revenue in the state lottery fund

1 created in section 41 of the McCauley-Traxler-Law-Bowman-McNeely
2 lottery act, 1972 PA 239, MCL 432.41, that is equal to not less
3 than 10% of each year's state lottery advertising budget but not to
4 exceed \$1,000,000.00.

5 (c) A percentage of the Michigan agriculture equine industry
6 development fund created in section 20 of the horse racing law of
7 1995, 1995 PA 279, MCL 431.320, that is equal to 1/10 of 1% of the
8 gross wagers made each year in each of the racetracks licensed
9 under the horse racing law of 1995, 1995 PA 279, MCL 431.301 to
10 431.336.

11 (3) Of the ~~funds-MONEY~~ available in the compulsive gaming
12 prevention fund, ~~\$40,000.00~~ **[UP TO \$1,040,000.00 MAY shall]** be
13 distributed **[ANNUALLY]** to
14 the domestic abuse council **VIOLENCE AND TREATMENT BOARD CREATED IN**
15 **SECTION 2 OF 1978 PA 389, MCL 400.1502.** The remaining ~~funds-MONEY~~
16 in the compulsive gaming prevention fund shall be distributed as
17 determined by the director of community health to be used
18 exclusively for the treatment, prevention, education, training,
19 research, and evaluation of pathological gamblers and their
20 families and to fund the toll-free compulsive gaming helpline
21 number.

22 (4) The state treasurer shall direct the investment of the
23 fund. The state treasurer shall credit to the fund interest and
24 earnings from fund investments.

25 (5) ~~Funds-MONEY~~ remaining in the compulsive gaming prevention
26 fund at the close of the fiscal year shall remain in the compulsive
27 gaming prevention fund and shall not lapse to the general fund.

(6) The department of community health may establish fees for

1 the treatment of pathological gambling addictions.
