SUBSTITUTE FOR HOUSE BILL NO. 6130

A bill to amend 1941 PA 207, entitled "Fire prevention code,"

(MCL 29.1 to 29.33) by adding section 3f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3F. (1) A PERSON SHALL NOT SELL AT RETAIL, OFFER FOR
- 2 RETAIL SALE, OR DISTRIBUTE FOR RETAIL SALE OR PROMOTION IN THIS
- 3 STATE A NOVELTY LIGHTER. A PERSON WHO VIOLATES THIS SUBSECTION
- 4 COMMITS A CIVIL VIOLATION FOR WHICH A FINE OF NOT MORE THAN \$500.00
- 5 MAY BE IMPOSED. THIS SUBSECTION MAY BE ENFORCED BY THE STATE FIRE
- 6 MARSHAL OR A STATE, COUNTY, OR MUNICIPAL LAW ENFORCEMENT OFFICER.
- 7 THE PROHIBITION SPECIFIED IN THIS SUBSECTION DOES NOT APPLY TO THE
- 8 TRANSPORTATION OF NOVELTY LIGHTERS THROUGH THIS STATE OR THE
- 9 STORAGE OF NOVELTY LIGHTERS IN A WAREHOUSE OR DISTRIBUTION CENTER
- 10 IN THIS STATE THAT IS CLOSED TO THE PUBLIC FOR PURPOSES OF RETAIL
- 11 SALES.
- 12 (2) AS USED IN THIS SECTION, "NOVELTY LIGHTER" MEANS A

- MECHANICAL OR ELECTRICAL DEVICE TYPICALLY USED FOR IGNITING 1
- 2 CIGARETTES, PIPES, OR CIGARS THAT IS DESIGNED TO APPEAR TO BE A
- TOY, FEATURES A FLASHING LIGHT, OR MAKES MUSICAL SOUNDS. NOVELTY 3
- 4 LIGHTER DOES NOT INCLUDE ANY OF THE FOLLOWING:
- 5 (A) A LIGHTER MANUFACTURED BEFORE JANUARY 1, 1980.
- (B) A LIGHTER INCAPABLE OF BEING FUELED OR LACKING A DEVICE 6
- NECESSARY TO PRODUCE COMBUSTION OR FLAME. 7
- (C) ANY MECHANICAL DEVICE PRIMARILY USED TO IGNITE FUEL FOR 8
- FIREPLACES OR FOR CHARCOAL OR GAS GRILLS.
