# SENATE SUBSTITUTE FOR HOUSE BILL NO. 5811

A bill to make appropriations for the department of state police and certain other state purposes for the fiscal year ending September 30, 2009; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

- 3 constitution of 1963, total state spending from state resources

- 6 government for fiscal year 2008-2009 is \$20,741,400.00. The

- Sec. 202. The appropriations authorized under this act are
- 23 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- 24 to 18.1594.
- Sec. 203. As used in this act:
- (a) "AFIS" means the automated fingerprint identification
- 27 system.

- 1 (b) "Department" means the department of state police.
- 2 (c) "DHS" means the United States department of homeland
- 3 security.
- 4 (d) "DNA" means deoxyribonucleic acid.
- 5 (e) "DOJ" means the United States department of justice.
- 6 (f) "DOT" means the United States department of
- 7 transportation.
- 8 (g) "FEMA" means the federal emergency management agency.
- 9 (h) "FTE" means full-time equated.
- 10 (i) "IDG" means interdepartmental grant.
- 11 (j) "IDT" means intradepartmental transfer.
- 12 (k) "LEIN" means law enforcement information network.
- 13 (l) "MCOLES" means the Michigan commission on law enforcement
- 14 standards.
- 15 (m) "MDCH" means the Michigan department of community health.
- 16 (n) "MDMB" means the Michigan department of management and
- 17 budget.
- (o) "MDOC" means the Michigan department of corrections.
- 19 (p) "MDOS" means the Michigan department of state.

- 22 (s) "MPSCS" means the Michigan public safety communications
- 23 system.
- 24 Sec. 204. The department of civil service shall bill
- 25 departments and agencies at the end of the first fiscal quarter for
- 26 the 1% charge authorized by section 5 of article XI of the state
- 27 constitution of 1963. Payments shall be made for the total amount

- 1 of the billing by the end of the second fiscal quarter.
- 2 Sec. 205. (1) A hiring freeze is imposed on the state
- 3 classified civil service. State departments and agencies are
- 4 prohibited from hiring any new full-time state classified civil
- 5 service employees and prohibited from filling any vacant state
- 6 classified civil service positions. This hiring freeze does not
- 7 apply to internal transfers of classified employees from 1 position
- 8 to another within a department.
- 9 (2) The state budget director may grant exceptions to this
- 10 hiring freeze when the state budget director believes that the
- 11 hiring freeze will result in rendering a state department or agency
- 12 unable to deliver basic services, causes loss of revenue to the
- 13 state, would result in the inability of the state to receive
- 14 federal funds, or would necessitate additional expenditures that
- 15 exceed any savings from maintaining a vacancy. The state budget
- 16 director shall report quarterly to the chairpersons of the senate
- 17 and house of representatives standing committees on appropriations
- 18 the number of exceptions to the hiring freeze approved during the
- 19 previous quarter and the reasons to justify the exception.
- Sec. 207. At least 60 days before beginning any effort to
- 21 privatize, the department shall submit a complete project plan to
- 22 the appropriate senate and house of representatives appropriations
- 23 subcommittees and the senate and house fiscal agencies. The plan
- 24 shall include the criteria under which the privatization initiative
- 25 will be evaluated. The evaluation shall be completed and submitted
- 26 to the appropriate senate and house of representatives
- 27 appropriations subcommittees and the senate and house fiscal

- 1 agencies within 30 months.
- 2 Sec. 208. Unless otherwise specified, the department shall use
- 3 the Internet to fulfill the reporting requirements of this act.
- 4 This requirement may include transmission of reports via electronic
- 5 mail to the recipients identified for each reporting requirement or
- 6 it may include placement of reports on an Internet or Intranet
- 7 site.
- 8 Sec. 209. Funds appropriated in part 1 shall not be used for
- 9 the purchase of foreign goods or services, or both, if
- 10 competitively priced and of comparable quality American goods or
- 11 services, or both, are available. Preference should be given to
- 12 goods or services, or both, manufactured or provided by Michigan
- 13 businesses, if they are competitively priced and of comparable
- 14 quality. In addition, preference should be given to goods or
- 15 services, or both, that are manufactured or provided by Michigan
- 16 businesses owned and operated by veterans, if they are
- 17 competitively priced and of comparable quality.
- 18 Sec. 210. The director of each department receiving
- 19 appropriations in part 1 shall take all reasonable steps to ensure
- 20 businesses in deprived and depressed communities compete for and
- 21 perform contracts to provide services or supplies, or both, for the
- 22 department. The director shall strongly encourage firms with which
- 23 the department contracts to subcontract with certified businesses
- 24 in depressed and deprived communities for services or supplies, or
- 25 both.
- 26 Sec. 211. It is the intent of the legislature that personnel
- 27 of the department who request and are eligible for reimbursement of

- 1 expenses related to the operation of the department be reimbursed
- 2 from the appropriations provided in this act within 30 days after
- 3 submitting a request, or the eligible personnel shall be paid an
- 4 additional amount equal to 0.75% of the payment due. The department
- 5 shall pay an additional amount equal to 0.75% of the payment due
- 6 for the first month and each succeeding month or portion of a month
- 7 the payment remains past due.
- 8 Sec. 213. (1) It is the intent of the legislature that the
- 9 department shall not provide any subsidy for contractual services
- 10 it provides.
- 11 (2) When the department provides contractual services to a
- 12 local unit of government, the department shall be reimbursed for
- 13 all costs incurred in providing the services, including, but not
- 14 limited to, retirement and overtime costs.
- 15 (3) Contractual services provided to an entity other than a
- 16 local unit of government may be provided by department personnel,
- 17 but only on an overtime basis outside the normal work schedule of
- 18 the personnel.
- 19 (4) This section does not apply to state agencies.
- Sec. 214. The departments and agencies receiving
- 21 appropriations in part 1 shall receive and retain copies of all
- 22 reports funded from appropriations in part 1. The department shall
- 23 follow all federal guidelines and state laws regarding short-term
- 24 and long-term retention of records.
- Sec. 215. Not later than January 1, 2009, the department shall
- 26 report to the state police appropriations subcommittees of the
- 27 house and senate and the house and senate fiscal agencies. The

- 1 report shall contain the following information regarding the
- 2 department's activities related to casino gaming oversight during
- 3 fiscal year 2007-2008:
- 4 (a) The amount of money received and expended.
- 5 (b) The nature and structure of the casino gaming oversight
- 6 unit.
- 7 (c) The positions and classifications of employees assigned.
- 8 (d) The number of full-time and part-time employees and the
- 9 aggregate number of FTEs.
- (e) The number of enlisted and civilian positions.
- 11 (f) The duties and responsibilities of the assigned employees.
- 12 (g) The immediate past position of the enlisted employees
- 13 assigned.
- 14 Sec. 216. The department shall collect and computerize the
- 15 vehicle identification number (VIN) of all vehicles that are
- 16 entered into the state accident data collection system and make
- 17 this and other vehicle information available to the public at cost.
- 18 For bulk access to the accident records in which the VIN has been
- 19 collected and computerized, the department shall make those records
- 20 available to the public at cost, provided that the name and address
- 21 have been excluded.
- Sec. 217. From the funds appropriated in part 1, the
- 23 department shall maintain a toll-free hotline in collaboration with
- 24 the department of education. The toll-free hotline shall be
- 25 operated 24 hours per day, 7 days per week, and shall provide
- 26 students, school officials, and other individuals an opportunity to
- 27 report specific threats of imminent school violence or other

- 1 suspicious or criminal conduct by juveniles to the appropriate
- 2 local law enforcement entities for investigation. The department
- 3 may expend funds for the promotion of the hotline.
- 4 Sec. 218. (1) Funds appropriated in part 1 for at-post
- 5 troopers shall only be expended for trooper salaries, wages,
- 6 benefits, retirement, equipment, supplies, and other expenses
- 7 directly related to state troopers assigned to general law
- 8 enforcement duties at a department post, detachment, satellite
- 9 office, or a resident trooper function.
- 10 (2) It is the intent of the legislature that every effort be
- 11 made to identify funding sufficient to conduct a trooper school for
- 12 the purpose of working toward the goal of establishing a minimum
- 13 at-post trooper strength of 1,075 in this state.
- 14 (3) The department shall submit quarterly written reports to
- 15 the senate and house appropriations subcommittees on state police
- 16 and military and veterans affairs no later than December 1, 2008,
- 17 March 1, 2009, June 1, 2009, and September 1, 2009 which shall
- 18 include a trooper strength report and the status of the
- 19 department's plan for accomplishing the goal of subsection (2). If
- 20 the department determines that insufficient appropriations exist

- 22 department shall submit a proposal outlining a plan to accomplish
- 23 the goal, including an accounting of any additional funding
- 24 necessary to that end.
- Sec. 219. The department of state police shall notify the
- 26 house and senate appropriations subcommittees on state police and
- 27 military and veterans affairs and the house and senate fiscal

- 1 agencies not less than 180 days before recommending to close or
- 2 consolidate any state police posts. The notification shall include
- 3 a local and state impact study of the proposed post closure or
- 4 consolidation.
- 5 Sec. 220. (1) The department of state police, in keeping with
- 6 its role as the general law enforcement agency of the state and as
- 7 the law enforcement agency of last resort for communities that are
- 8 either without local law enforcement resources or are seriously
- 9 underserved by local law enforcement resources, shall provide
- 10 general law enforcement assistance to those communities until
- 11 adequate law enforcement services can be provided to those
- 12 communities by other means.
- 13 (2) Not later than May 1, 2009, the department shall deliver
- 14 to the house and senate appropriations subcommittees on state
- 15 police and military and veterans affairs and the house and senate
- 16 fiscal agencies a report on the additional costs incurred by the
- 17 department in each locality for providing the services described in
- 18 subsection (1) during the first 6 months of the fiscal year 2008-
- **19** 2009.
- 20 Sec. 221. The department of state police may pursue entering
- 21 into an agreement with Calhoun County to build a new facility in
- 22 Marshall which would serve as a new state police post to replace
- 23 the current state police post in Battle Creek.
- 24 Sec. 223. (1) Due to the current budgetary problems in this
- 25 state, out-of-state travel for the fiscal year ending September 30,
- 26 2009 shall be limited to situations in which 1 or more of the
- 27 following conditions apply:

- 1 (a) The travel is required by legal mandate or court order or
- 2 for law enforcement purposes.
- 3 (b) The travel is necessary to protect the health or safety of
- 4 Michigan citizens or visitors or to assist other states in similar
- 5 circumstances.
- 6 (c) The travel is necessary to produce budgetary savings or to
- 7 increase state revenues, including protecting existing federal
- 8 funds or securing additional federal funds.
- 9 (d) The travel is necessary to comply with federal
- 10 requirements.
- 11 (e) The travel is necessary to secure specialized training for
- 12 staff that is not available within this state.
- 13 (f) The travel is financed entirely by federal or nonstate
- 14 funds.
- 15 (2) If out-of-state travel is necessary but does not meet 1 or
- 16 more of the conditions in subsection (1), the state budget director
- 17 may grant an exception to allow the travel. Any exceptions granted
- 18 by the state budget director shall be reported on a monthly basis
- 19 to the senate and house of representatives standing committees on
- 20 appropriations.
- 21 (3) Not later than January 1, 2009, each department shall
- 22 prepare a travel report listing all travel by classified and
- 23 unclassified employees outside this state in the immediately
- 24 preceding fiscal year that was funded in whole or in part with
- 25 funds appropriated in the department's budget. The report shall be
- 26 submitted to the chairs and members of the senate and house of
- 27 representatives standing committees on appropriations, the fiscal

- 1 agencies, and the state budget director. The report shall include
- 2 the following information:
- 3 (a) The name of each person receiving reimbursement for travel
- 4 outside this state or whose travel costs were paid by this state.
- 5 (b) The destination of each travel occurrence.
- 6 (c) The dates of each travel occurrence.
- 7 (d) A brief statement of the reason for each travel
- 8 occurrence.
- **9** (e) The transportation and related costs of each travel
- 10 occurrence, including the proportion funded with state general
- 11 fund/general purpose revenues, the proportion funded with state
- 12 restricted revenues, the proportion funded with federal revenues,
- 13 and the proportion funded with other revenues.
- 14 (f) A total of all out-of-state travel funded for the
- 15 immediately preceding fiscal year.
- 16 Sec. 224. The department shall not take disciplinary action
- 17 against an employee for communicating with a member of the
- 18 legislature or his or her staff.
- 19 Sec. 225. It is the intent of the legislature that the
- 20 administration, working with the MCOLES, continue the long-held
- 21 practice that all revenue made available to the department from the
- 22 Michigan justice training fund be used solely for costs directly
- 23 related to the delivery of Michigan justice training fund grants,
- 24 so that in the future, eligible entities as provided under 1982 PA
- 25 302, MCL 18.421 to 18.429, will have a stable and accurate source
- 26 of training funds.
- Sec. 226. The department of state police, in cooperation with

1 the department of information technology and others, shall take

- 2 steps to encourage the development of state, local, and regional
- 3 tactical interoperable communication plans with the ultimate goal
- 4 being to ensure that effective and efficient communication
- 5 interoperability between radio communication systems of local,
- 6 regional, state, and federal agencies is established in every area
- 7 of the state. The department shall provide a written report to the
- 8 senate and house appropriations subcommittees on state police and
- 9 military and veterans affairs no later than April 1, 2009 on the
- 10 current status of reaching this objective. The report shall include
- 11 an accounting of exactly where within the state desired
- 12 interoperability has been achieved and what cooperative measures
- 13 and use of technology were used to achieve this interoperability,
- 14 and which areas of the state have not yet achieved such status. The
- 15 report shall also include a description of what strategies need to
- 16 be employed to ensure that the remaining areas of the state, and
- 17 the state as a whole, will have a communication system with
- 18 efficient and effective interoperability, particularly on occasions
- 19 when a multijurisdictional response to an emergency is warranted.
- Sec. 227. (1) From the funds appropriated in part 1, the
- 21 department of state police is prohibited from transporting
- 22 employees of institutions of higher education on state-owned
- 23 aircraft.
- 24 (2) From the funds appropriated in part 1, the department is
- 25 prohibited from transporting legislators or legislative staff on
- 26 state-owned aircraft without prior approval from the senate
- 27 majority leader or the speaker of the house of representatives, or

- 1 both.
- 2 (3) From the funds appropriated in part 1, the department is
- 3 prohibited from transporting local government employees on state-
- 4 owned aircraft.
- 5 (4) It is the intent of the legislature that state elected
- 6 officials use commercial or other private air service, unless air
- 7 travel on state-owned aircraft is part of official state business.
- **8** (5) This section shall not apply to transportation that is
- 9 related to law enforcement or homeland security activities.
- 10 Sec. 228. The department shall not approve the travel of more
- 11 than 1 departmental employee to a specific professional development
- 12 conference or training seminar that is located outside of this
- 13 state. The only exception to this travel restriction involves a
- 14 professional development conference or training seminar that is
- 15 funded by a federal or private funding source and requires more
- 16 than 1 person from a department to attend.
- 17 Sec. 230. The unexpended and unencumbered balance of the
- 18 appropriation for the department contained in 2007 PA 130 shall be
- 19 used toward the payment of \$400,000.00 to the Michigan state police
- 20 troopers association. The funds shall be available for
- 21 appropriation in the fiscal year ending September 30, 2009.
- Sec. 232. The department shall place emphasis on recruiting
- 23 MCOLES certified police officers for the trooper recruit school.
- 24 Emphasis shall be given in the hiring process to those officers who
- 25 are on layoff and possess valid MCOLES certification. Any emphasis
- 26 given in the recruiting and selection process shall be consistent
- 27 with the department's hiring standards and in accordance with civil

- 1 service rules. The department shall report to the chairpersons of
- 2 the senate and house of representatives standing committees on
- 3 appropriations the results of its recruitment and selection
- 4 process, including the actual number of certified officers selected
- 5 for any recruit school that is held by September 30, 2009.
- 6 Sec. 233. From the funds appropriated in part 1 for at-post
- 7 troopers, up to \$200,000.00 shall be used for the timely completion
- 8 of a law enforcement resource study produced by contract with an
- 9 accredited in-state university. The study shall examine the law
- 10 enforcement needs of each state police district of this state. The
- 11 study shall provide recommendations concerning state police patrol
- 12 and response needs within each state police district and post area
- of this state, baseline coverage recommendations, and information
- 14 concerning what is required in terms of personnel and resources to
- 15 meet the recommendations and how those resources could most
- 16 efficiently be allocated to achieve the recommendations, along with
- 17 the amount of any additional resources that may be needed. The
- 18 study shall examine, at a minimum, crime statistics, population,
- 19 geographic area, and inventory of all levels of existing police
- 20 resources for a given area, and any other pertinent information.
- 21 The department shall keep the house and senate appropriations
- 22 subcommittee chairs informed as to the progress toward the
- 23 completion of this report and make every effort to have this report
- 24 completed no later than November 1, 2009. The department shall
- 25 provide a copy of the report to both of the subcommittees.
- 26 Sec. 234. Funds appropriated in part 1 shall not be used by a
- 27 principal executive department, state agency, or authority to hire

- 1 a person to provide legal services that are the responsibility of
- 2 the attorney general. This prohibition does not apply to legal
- 3 services for bonding activities and for those activities that the
- 4 attorney general authorizes.
- 5 Sec. 235. (1) If a spending plan for the funds appropriated in
- 6 part 1 for special operations and events, or sources of financing
- 7 related to the spending plan, do not provide the level of program
- 8 service provided for in the current fiscal year, the funds
- 9 appropriated in part 1 for post uniform services or forensic
- 10 sciences shall not be used to fund the shortfall.
- 11 (2) If a spending plan for the funds appropriated in part 1
- 12 for special operations and events, or sources of financing related
- 13 to the spending plan, are in excess of that necessary to provide
- 14 the level of program service provided for in the current fiscal
- 15 year, the department shall take steps to transfer whatever excess
- 16 funding may exist to the funds appropriated in part 1 for post
- 17 uniform services and forensic sciences.
- 18 Sec. 236. (1) The department shall report no later than April
- 19 1, 2009 on each specific policy change made by the department to
- 20 implement a public act affecting that department that took effect
- 21 during the preceding calendar year. The department shall report to
- 22 the house and senate appropriations subcommittees on the budget for
- 23 the department, the joint committee on administrative rules, and
- 24 the senate and house fiscal agencies.
- 25 (2) Funds appropriated in part 1 shall not be used by the
- 26 department to adopt a rule that will apply to a small business and
- 27 that will have a disproportionate economic impact on small

- 1 businesses because of the size of those businesses if the
- 2 department fails to reduce the disproportionate economic impact of
- 3 the rule on small businesses as provided under section 40 of the
- 4 administrative procedures act of 1969, 1969 PA 306, MCL 24.240.
- 5 (3) As used in this section:
- 6 (a) "Rule" means that term as defined under section 7 of the
- 7 administrative procedures act of 1969, 1969 PA 306, MCL 24.207.
- 8 (b) "Small business" means that term as defined under section
- 9 7a of the administrative procedures act of 1969, 1969 PA 306, MCL
- **10** 24.207a.
- 11 Sec. 237. From the funds appropriated in part 1, the
- 12 department shall maintain, for the full 2008-2009 fiscal year,
- 13 either the operation of each Michigan state police post which was
- 14 in operation as of April 2, 2007, or an alternative work station in
- 15 the vicinity of a current Michigan state police post.
- Sec. 238. The department of management and budget shall work
- 17 with the department of state police to reduce building operations
- 18 and leasing costs for all Michigan state police facilities and to
- 19 identify efficiencies and savings.
- 20 Sec. 240. (1) In addition to the funds appropriated in part 1,
- 21 there is appropriated an amount not to exceed \$10,000,000.00 for
- 22 federal contingency funds. These funds are not available for
- 23 expenditure until they have been transferred to another line item
- 24 in this act under section 393(2) of the management and budget act,
- 25 1984 PA 431, MCL 18.1393.
- 26 (2) In addition to the funds appropriated in part 1, there is
- 27 appropriated an amount not to exceed \$3,500,000.00 for state

- 1 restricted contingency funds. These funds are not available for
- 2 expenditure until they have been transferred to another line item
- 3 in this act under section 393(2) of the management and budget act,
- 4 1984 PA 431, MCL 18.1393.
- 5 (3) In addition to the funds appropriated in part 1, there is
- 6 appropriated an amount not to exceed \$1,000,000.00 for local
- 7 contingency funds. These funds are not available for expenditure
- 8 until they have been transferred to another line item in this act
- 9 under section 393(2) of the management and budget act, 1984 PA 431,
- **10** MCL 18.1393.
- 11 (4) In addition to the funds appropriated in part 1, there is
- 12 appropriated an amount not to exceed \$200,000.00 for private
- 13 contingency funds. These funds are not available for expenditure
- 14 until they have been transferred to another line item in this act
- 15 under section 393(2) of the management and budget act, 1984 PA 431,
- **16** MCL 18.1393.
- 17 Sec. 241. From the funds appropriated in part 1, the
- 18 department shall continue the creation of a plan to operate a
- 19 trooper recruit school composed of 50 or fewer recruits on an
- 20 annual or biannual basis. These trooper recruit schools shall be
- 21 operated on a shorter time frame than typical trooper recruit
- 22 schools and shall consist of recruits who possess current
- 23 certification as a law enforcement officer. This plan will result
- 24 in a trooper recruit school that assists in restoring overall
- 25 trooper strength to an optimum level while being more efficient in
- 26 terms of time and financial expenditure.
- Sec. 242. From the funds appropriated in part 1, the

- 1 department shall develop, post, and maintain, on a publicly
- 2 accessible Internet site, all expenditures made by the department
- 3 within the fiscal year. This posting shall include the purpose for
- 4 which each expenditure is made.

#### INFORMATION TECHNOLOGY

- 6 Sec. 301. (1) The money appropriated in part 1 for computer
- 7 services shall be funded by LEIN user fees sufficient to pay 1/4 of
- 8 the state's service and contract maintenance costs of the LEIN.
- 9 (2) The department shall provide a detailed report to the
- 10 senate and house appropriations subcommittees on state police and
- 11 military and veterans affairs and the criminal justice information
- 12 systems policy council no later than October 15, 2008, on the
- 13 actual state service and contract maintenance costs necessary to
- 14 provide the LEIN services to local agencies for fiscal year 2008-
- **15** 2009.

- 16 Sec. 302. From the funds appropriated in part 1 for
- 17 information technology, departments and agencies shall pay user
- 18 fees to the department of information technology for technology-
- 19 related services and projects. These user fees shall be subject to
- 20 provisions of an interagency agreement between the department and
- 21 the department of information technology.
- 22 Sec. 303. Amounts appropriated in part 1 for information
- 23 technology may be designated as work projects and carried forward
- 24 to support technology projects under the direction of the
- 25 department of information technology. Funds designated in this
- 26 manner are not available for expenditure until approved as work

- 1 projects under section 451a of the management and budget act, 1984
- 2 PA 431, MCL 18.1451a.
- 3 Sec. 304. A portion of the funds appropriated in part 1 shall
- 4 be used by the department to produce a written report detailing
- 5 departmental policies regarding access to and use of information
- 6 from the LEIN system. The report shall include a description of
- 7 departmental measures to protect the security of information in the
- 8 LEIN system including safeguards that would prevent unauthorized
- 9 persons from obtaining information from the LEIN system. The
- 10 department shall submit a copy of this report to the senate and
- 11 house appropriations committees not later than April 1, 2009.
- Sec. 305. The criminal justice information systems policy
- 13 council shall encourage members of the law enforcement agencies in
- 14 the state to be sensitive to, and note when necessary, activities
- 15 or circumstances that may suggest the unauthorized access or misuse
- 16 of information from the LEIN system. The criminal justice
- 17 information systems policy council shall advise LEIN auditors, as a
- 18 part of their audit of law enforcement agencies, to investigate in
- 19 depth all suspected incidents of improper access or improper use of
- 20 information from the LEIN system and determine whether or not those
- 21 incidents were illegal. In those incidents that may be determined
- 22 to be illegal, the executive secretary for the council shall
- 23 determine whether those incidents were of a negligent or criminal
- 24 nature. If an incident is determined to be an illegal act, the
- 25 council shall inform the chairs of both the senate and house
- 26 appropriations committees.
- 27 Sec. 306. (1) The department of state police, working with the

- 1 criminal justice information systems policy council, shall
- 2 implement procedures by which all probation information is placed
- 3 on the LEIN system. The LEIN system shall include information on
- 4 each probationer, including any probation conditions placed on a
- 5 probationer and the name of the probation officer assigned to a
- 6 probationer. The LEIN system shall also include any nonstandard
- 7 probation terms.
- 8 (2) If the department determines that amendments to the code
- 9 of criminal procedure, 1927 PA 175, MCL 760.1 to 777.69, are
- 10 required to include all probation information on the LEIN system,
- 11 the department shall deliver to members of the senate and house
- 12 appropriations subcommittees on state police and military affairs
- 13 amendments to the code of criminal procedure, 1927 PA 175, MCL
- 14 760.1 to 777.69, that, in the department's view, are necessary to
- 15 accomplish this goal. These proposed amendments shall be delivered
- 16 to subcommittee members not later than December 1, 2008.
- 17 Sec. 307. The department of state police shall serve as an
- 18 active liaison between the department of information technology and
- 19 local public safety agencies to facilitate the use of the Michigan
- 20 public safety communications system towers by those local public
- 21 safety agencies that have an interest in using the towers as a part
- 22 of their own communications system. The department of state police
- 23 shall deliver a written report to the senate and house
- 24 appropriations subcommittees on state police and military and
- 25 veterans affairs by April 1, 2009, which shall include an
- 26 assessment of the progress toward establishing local public safety
- 27 agency use of the Michigan public safety communications system

- 1 towers, an accounting of problems that may be preventing local use
- 2 of the towers, and any recommendations the department has that may
- 3 foster this utilization.
- 4 Sec. 308. The department of state police shall report any LEIN
- 5 fee increase to the senate and house appropriations subcommittees
- 6 on state police and military and veterans affairs 60 days prior to
- 7 the effective date of that increase. The report shall contain the
- 8 following information: the current fee structure and the total
- 9 revenue earned each year; the new fee structure and the total
- 10 revenue it is expected to earn annually; the total annual cost of
- 11 the LEIN system; and the total amount of LEIN fees paid by the
- 12 department under both the old and the new structure.
- Sec. 309. From the funds appropriated in part 1 for
- 14 information technology, the department may develop and issue a
- 15 request for proposal for the development, implementation, and
- 16 maintenance of an electronic system for real-time enforcement of
- 17 section 3101 of the insurance code of 1956, 1956 PA 218, MCL
- **18** 500.3101.

#### HIGHWAY SAFETY PLANNING

- 20 Sec. 401. On a quarterly basis, the department shall report to
- 21 the senate and house appropriations subcommittees on state police
- 22 and military affairs on the status of assessments collected and
- 23 authorized under section 629e of the Michigan vehicle code, 1949 PA
- 24 300, MCL 257.629e, for the purposes of supporting the secondary
- 25 road patrol grant program. Each quarterly report shall contain
- 26 updated information on collection levels, revised projected grant

- 1 allotments to counties for the year, a comparison of projected
- 2 collections and grant distribution levels with the funds
- 3 appropriated in part 1 for the secondary road patrol program, and
- 4 the extent collection levels have exceeded or failed to meet
- 5 appropriated levels for the current fiscal year or expenditure
- 6 levels from the previous fiscal year.

# FORENSIC SCIENCES

- 8 Sec. 501. (1) The department shall distribute a copy of the
- 9 department's protocol for retaining and purging DNA analysis
- 10 samples and records to each police agency in this state.
- 11 (2) The department shall report to the house and senate
- 12 appropriations subcommittees on state police and military and
- 13 veterans affairs and the house and senate fiscal agencies when any
- 14 changes to the department's DNA protocol are made.
- 15 Sec. 502. The department shall work with the department of
- 16 community health, the Michigan health and hospital association, the
- 17 Michigan state medical society, and the Michigan nurses association
- 18 to ensure that the recommendations included in the "Standard
- 19 Recommended Procedures for the Emergency Treatment of Sexual
- 20 Assault Victims" are followed in the collection of evidence.
- Sec. 503. From the funds appropriated in part 1 for the city
- 22 of Detroit laboratory, funds shall be used to hire a quality
- 23 assurance manager and a biologist. The quality assurance manager
- 24 shall be responsible for the laboratory's quality assurance
- 25 program, the safety program, and the grant program with an emphasis
- 26 on quality assurance and shall provide a report to the house and

- 1 senate appropriations subcommittees on state police and military
- 2 and veterans affairs concerning the benchmarks implemented to
- 3 improve the laboratory's performance, the progress on those
- 4 benchmarks, and the problems related to these goals the laboratory
- 5 may be facing. The report is due by June 1, 2009. The biologist
- 6 hired with these funds shall be responsible for operating the DNA
- 7 extraction machine (Biomek 2000).

## 8 MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS

- 9 Sec. 601. The money appropriated to the MCOLES for maintenance
- 10 and delivery of training to locals is provided in accordance with a
- 11 state reimbursement policy in which 100% of the determined state
- 12 reimbursement rate shall be distributed upon certification by the
- 13 MCOLES.
- 14 Sec. 603. The appropriation in part 1 for mental health
- 15 awareness training shall be made available as grants to local law
- 16 enforcement agencies for training law enforcement officers in
- 17 effective and safe ways of assisting people with mental illness and
- 18 directing people with mental illness to treatment programs.
- 19 Sec. 604. From the funds appropriated in part 1 to the
- 20 Michigan commission on law enforcement standards funds may be used
- 21 to provide training for motor carrier officers and capitol security
- 22 officers for the purpose of qualifying them for MCOLES
- 23 certification.

#### 24 EMERGENCY MANAGEMENT

25 Sec. 801. (1) The state director of emergency management may

- 1 expend money appropriated under this act to call upon any agency or
- 2 department of the state or any resource of the state to protect
- 3 life or property or to provide for the health or safety of the
- 4 population in any area of the state in which the governor proclaims
- 5 a state of emergency or state of disaster under 1945 PA 302, MCL
- 6 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
- 7 MCL 30.401 to 30.421. The state director of emergency management
- 8 may expend the amounts the director considers necessary to
- 9 accomplish these purposes. The director shall submit to the state
- 10 budget director as soon as possible a complete report of all
- 11 actions taken under the authority of this section. The report shall
- 12 contain, as a separate item, a statement of all money expended that
- is not reimbursable from federal money. The state budget director
- 14 shall review the expenditures and submit recommendations to the
- 15 legislature in regard to any possible need for a supplemental
- **16** appropriation.
- 17 (2) In addition to the money appropriated in this act, the
- 18 department may receive and expend money from local, private,
- 19 federal, or state sources for the purpose of providing emergency
- 20 management training to local or private interests and for the
- 21 purpose of supporting emergency preparedness, response, recovery,
- 22 and mitigation activity. If additional expenditure authorization in
- 23 the Michigan administrative information network is approved by the
- 24 state budget office under this section, the department and the
- 25 state budget office shall notify the house and senate
- 26 appropriations subcommittees on state police and military and
- 27 veterans affairs and the house and senate fiscal agencies within 10

- 1 days after the approval. The notification shall include the amount
- 2 and source of the additional authorization, the date of its
- 3 approval, and the projected use of funds to be expended under the
- 4 authorization.
- 5 Sec. 803. The department's emergency management division shall
- 6 make every effort to ensure both of the following:
- 7 (a) That homeland security grants offered by the federal
- 8 government and channeled through the department are allocated to
- 9 first responder entities in the highest percentage possible.
- 10 (b) That homeland security grants awarded to the city of
- 11 Detroit shall not be used to supplant city general funds designated
- 12 to support first responder operations.

#### 13 POST UNIFORM SERVICES

- 14 Sec. 901. State police enlisted personnel who are employed to
- 15 enforce traffic laws as provided in section 629e of the Michigan
- vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited
- 17 from responding to crimes in progress or other emergency
- 18 situations, and are responsible for protecting every citizen of
- 19 this state from harm.

# 20 STATEWIDE FIELD OPERATIONS

- 21 Sec. 1002. Money privately donated to the department is
- 22 appropriated under part 1 to be used for the purposes designated by
- 23 the donor of the money. Money privately donated to the department's
- 24 canine unit shall be used to purchase equipment and other items to
- 25 enhance the operation of the canine unit. It is the intent of the

- 1 legislature that money from private donations not supplant general
- 2 fund appropriations.

# 3 SPECIAL INVESTIGATIONS

- 4 Sec. 1101. (1) There is sufficient money appropriated in part
- 5 1 to special investigations to ensure that the citizens in a
- 6 service area of any state police post in the vicinity of a state
- 7 prison do not experience a downgrading of state police services in
- 8 their area. Special investigations shall be available by temporary
- 9 or permanent assignment of a detective when either a temporary or
- 10 permanent prison facility is opened.
- 11 (2) If the department is unable to comply with subsection (1)

- 13 provide troopers to serve as investigators on an interim basis.
- 14 Sec. 1102. From the funds appropriated in part 1 for special
- 15 investigations, the department shall provide a report to the
- 16 chairpersons of the senate and house of representatives standing
- 17 committees on appropriations no later than April 1, 2009 concerning
- 18 methamphetamine-related criminal activities.

### 19 MOTOR CARRIER ENFORCEMENT

- Sec. 1201. (1) The department shall report to the house and
- 21 senate appropriations subcommittees on state police and the house
- 22 and senate fiscal agencies by March 1, 2009 regarding the
- 23 inspection of school buses and other motor vehicles under section
- 24 715a of the Michigan vehicle code, 1949 PA 300, MCL 257.715a, and
- 25 section 39 of the pupil transportation act, 1990 PA 187, MCL

- 1 257.1839. The report shall include the following information
- 2 regarding inspections conducted in calendar year 2008:
- 3 (a) The number of buses and vehicles inspected by the
- 4 department.
- 5 (b) The number of buses and vehicles passing and failing

- 7 (c) The estimated number of buses and vehicles not inspected.
- 8 (2) If each school bus within a school system receives a 100%
- 9 successful state inspection on its first inspection in a given
- 10 year, the department shall award a certificate to that school
- 11 system.
