

HOUSE SUBSTITUTE FOR  
SENATE BILL NO. 115

A bill to amend 2003 PA 226, entitled  
"Joint municipal planning act,"  
by amending the title and sections 3, 5, and 7 (MCL 125.133,  
125.135, and 125.137).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

2 An act to provide for joint land use planning and ~~the joint~~  
3 ~~exercise of certain zoning powers and duties~~ ZONING by local units  
4 of government; and to provide for the establishment, powers, and  
5 duties of joint planning commissions and zoning boards of appeals.

6 Sec. 3. As used in this act:

7 (a) "Municipality" means a city, village, or township.

8 (b) "Participating" means, with respect to a municipality,  
9 that the municipality is a member of a joint planning commission.

10 ~~—— (c) "Planning act" means either of the following acts:~~

~~1 (i) 1931 PA 285, MCL 125.31 to 125.45, if a city or village is~~  
~~2 a participating municipality or a township whose planning~~

18 Sec. 5. (1) Subject to section 9, the legislative bodies of 2  
 19 or more municipalities may each adopt an ordinance approving an  
 20 agreement establishing a joint planning commission. The agreement  
 21 shall specify at least all of the following:

22 (a) The composition of the joint planning commission,  
 23 including any alternate members.

24 (b) The qualifications, the selection by election or  
 25 appointment, and the terms of office of members of the joint  
 26 planning commission.

27 (c) Conditions and procedures for removal from office of

1 members of the joint planning commission and for filling vacancies  
2 in the joint planning commission.

3 (d) How the operating budget of the joint planning commission  
4 will be shared by the participating municipalities.

5 (e) The jurisdictional area of the joint planning commission,  
6 which may consist of all or part of the combined territory of the  
7 participating municipalities.

8 (f) Procedures by which a municipality may join or withdraw  
9 from the joint planning commission.

10 ~~(g) The planning act whose procedure will be followed by the~~  
11 ~~joint planning commission in adopting a plan or exercising any~~  
12 ~~other power or performing any other duty of a planning commission.~~  
13 ~~The planning act shall be a planning act that would otherwise be~~  
14 ~~applicable to at least 1 participating municipality.~~ **FOR SITUATIONS**  
15 **IN WHICH THE POWERS, DUTIES, OR PROCEDURES OF A PLANNING COMMISSION**  
16 **UNDER THE MICHIGAN PLANNING ENABLING ACT, 2008 PA 33, MCL 125.3801**  
17 **TO 125.3885, DEPEND ON WHETHER THE MUNICIPALITY IS (i) A TOWNSHIP**  
18 **THAT ON SEPTEMBER 1, 2008 HAD A PLANNING COMMISSION CREATED UNDER**  
19 **FORMER 1931 PA 285, (ii) A TOWNSHIP THAT DID NOT ON SEPTEMBER 1,**  
20 **2008, HAVE A PLANNING COMMISSION CREATED UNDER FORMER 1931 PA 285,**  
21 **OR (iii) A CITY OR VILLAGE -- A DESIGNATION OF WHICH OF THESE 3**  
22 **CATEGORIES OF MUNICIPALITIES' POWERS, DUTIES, AND PROCEDURES WILL**  
23 **BE APPLICABLE TO THE JOINT PLANNING COMMISSION. A CATEGORY OF**  
24 **MUNICIPALITY SHALL NOT BE DESIGNATED UNDER THIS SUBDIVISION UNLESS**  
25 **AT LEAST 1 OF THE PARTICIPATING MUNICIPALITIES FALLS WITHIN THAT**  
26 **CATEGORY.**

27 (h) ~~The zoning act whose procedure will be followed by the~~

~~joint planning commission in exercising the powers and performing the duties of a zoning board or zoning commission. The zoning act shall be a zoning act that would otherwise be applicable to at least 1 participating municipality.~~ FOR SITUATIONS IN WHICH THE POWERS, DUTIES, OR PROCEDURES UNDER THE MICHIGAN ZONING ENABLING ACT, 2006 PA 110, MCL 125.3101 TO 125.3702, APPLICABLE TO A PLANNING COMMISSION DEPEND ON WHETHER THE MUNICIPALITY IS A TOWNSHIP OR IS A CITY OR VILLAGE, A DESIGNATION EITHER THAT THE POWERS, DUTIES, AND PROCEDURES APPLICABLE TO A TOWNSHIP WILL BE FOLLOWED BY THE JOINT PLANNING COMMISSION OR THAT THE POWERS, DUTIES, AND PROCEDURES APPLICABLE TO A CITY OR VILLAGE WILL BE FOLLOWED BY THE JOINT PLANNING COMMISSION. POWERS, DUTIES, AND PROCEDURES APPLICABLE TO A TOWNSHIP SHALL NOT BE DESIGNATED UNLESS AT LEAST 1 OF THE PARTICIPATING MUNICIPALITIES IS A TOWNSHIP. POWERS, DUTIES, AND PROCEDURES APPLICABLE TO A CITY OR VILLAGE SHALL NOT BE DESIGNATED UNLESS AT LEAST 1 OF THE PARTICIPATING MUNICIPALITIES IS A CITY OR VILLAGE.

(i) Any additional provision concerning the powers or duties of a zoning board or zoning commission that the ~~zoning act specified pursuant to subdivision (h)~~ MICHIGAN ZONING ENABLING ACT, 2006 PA 110, MCL 125.3101 TO 125.3702, authorizes to be set forth in a zoning ordinance and that is agreed to by the participating municipalities.

(J) THE EFFECTIVE DATE OF THE AGREEMENT.

(2) THE AGREEMENT MAY PROVIDE FOR THE PHASED TRANSFER TO THE JOINT PLANNING COMMISSION OF THE POWERS AND DUTIES OF EXISTING PLANNING COMMISSIONS OR ZONING BOARDS OR ZONING COMMISSIONS UNDER

11 a zoning board or zoning commission under ~~each zoning act~~**THE**  
12 **MICHIGAN ZONING ENABLING ACT, 2006 PA 110, MCL 125.3101 TO**  
13 **125.3702, are, with respect to the jurisdictional area of the joint**  
14 **planning commission, transferred to the joint planning commission.**  
15 In exercising such powers or performing such duties, the joint  
16 planning commission shall follow the procedure ~~provided under the~~  
17 ~~zoning act~~ specified pursuant to section 5(h), **WHEN RELEVANT.**

18           (3) If only part of the territory of a participating  
19 municipality is in the jurisdictional area of a joint planning  
20 commission, the participating municipality, with the joint planning  
21 commission acting as the zoning board or zoning commission, may  
22 adopt a zoning ordinance that affects only that portion of its  
23 territory in the jurisdictional area of the joint planning  
24 commission.

25           (4) **THE PARTICIPATING MUNICIPALITIES, WITH THE JOINT PLANNING**  
26 **COMMISSION ACTING AS THE ZONING COMMISSION, MAY EACH ADOPT A JOINT**  
27 **ZONING ORDINANCE THAT AFFECTS THE JURISDICTIONAL AREA OF THE JOINT**

1 PLANNING COMMISSION AND PROVIDES FOR THE JOINT ADMINISTRATION OF  
2 THE JOINT ZONING ORDINANCE, INCLUDING, BUT NOT LIMITED TO, A JOINT  
3 ZONING BOARD OF APPEALS.
