

HOUSE BILL No. 4353

EXECUTIVE BUDGET BILL

February 28, 2007, Introduced by Rep. LeBlanc and referred to the Committee on Appropriations.

A bill to make appropriations for the department of state police and certain other state purposes for the fiscal year ending September 30, 2008; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

GENERAL SECTIONS

Sec. 201. (1) Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state resources under part 1 for fiscal year 2007-2008 is \$382,549,400.00 and state spending from state resources to be paid to local units of government for fiscal year 2007-2008 is \$20,594,700.00. The itemized statement below identifies appropriations from which spending to units of local government will occur:

7 Sec. 202. The appropriations authorized under this bill are
8 subject to the management and budget act, 1984 PA 431, MCL 18.1101
9 to 18.1594.

10 Sec. 203. As used in this bill:

11 (a) "AFIS" means the automated fingerprint identification
12 system.

13 (b) "Department" means the department of state police.

14 (c) "DHS" means the United States department of homeland
15 security.

16 (d) "DNA" means deoxyribonucleic acid.

17 (e) "DOJ" means the United States department of justice.

18 (f) "DOT" means the United States department of
19 transportation.

20 (g) "FEMA" means the federal emergency management agency.

21 (h) "FTE" means full-time equated.

22 (i) "IDG" means interdepartmental grant.

23 (j) "IDT" means intradepartmental transfer.

24 (k) "LEIN" means law enforcement information network.

25 (l) "MCOLES" means the Michigan commission on law enforcement
26 standards.

27 (m) "MDCH" means the Michigan department of community health.

1 (n) "MDMB" means the Michigan department of management and
2 budget.

3 (o) "MDOC" means the Michigan department of corrections.

4 (p) "MDOS" means the Michigan department of state.

5 (q) "MDOT" means the Michigan department of transportation.

6 (r) "MDTR" means the Michigan department of treasury.

7 (s) "MPSCS" means the Michigan public safety communications
8 system.

9 Sec. 204. The department of civil service shall bill
10 departments and agencies at the end of the first fiscal quarter for
11 the 1% charge authorized by section 5 of article XI of the state
12 constitution of 1963. Payments shall be made for the total amount
13 of the billing by the end of the second fiscal quarter.

14 Sec. 205. (1) A hiring freeze is imposed on the state
15 classified civil service. State departments and agencies are
16 prohibited from hiring any new full-time state classified civil
17 service employees and prohibited from filling any vacant state
18 classified civil service positions. This hiring freeze does not
19 apply to internal transfers of classified employees from 1 position
20 to another within a department.

21 (2) The state budget director may grant exceptions to this
22 hiring freeze when the state budget director believes that the
23 hiring freeze will result in rendering a state department or agency
24 unable to deliver basic services, cause loss of revenue to the
25 state, result in the inability of the state to receive federal
26 funds, or necessitate additional expenditures that exceed any
27 savings from maintaining a vacancy. The state budget director shall

1 report quarterly to the chairpersons of the senate and house of
2 representatives standing committees on appropriations the number of
3 exceptions to the hiring freeze approved during the previous
4 quarter and the reasons to justify the exception.

5 Sec. 206. (1) In addition to the funds appropriated in part 1,
6 there is appropriated an amount not to exceed \$10,000,000.00 for
7 federal contingency funds. These funds are not available for
8 expenditure until they have been transferred to another line item
9 in this bill under section 393(2) of the department of management
10 and budget act, 1984 PA 431, MCL 18.1393.

11 (2) In addition to the funds appropriated in part 1, there is
12 appropriated an amount not to exceed \$3,500,000.00 for state
13 restricted contingency funds. These funds are not available for
14 expenditure until they have been transferred to another line item
15 in this bill under section 393(2) of the department of management
16 and budget act, 1984 PA 431, MCL 18.1393.

17 (3) In addition to the funds appropriated in part 1, there is
18 appropriated an amount not to exceed \$1,000,000.00 for local
19 contingency funds. These funds are not available for expenditure
20 until they have been transferred to another line item in this bill
21 under section 393(2) of the department of management and budget
22 act, 1984 PA 431, MCL 18.1393.

23 (4) In addition to the funds appropriated in part 1, there is
24 appropriated an amount not to exceed \$200,000.00 for private
25 contingency funds. These funds are not available for expenditure
26 until they have been transferred to another line item in this bill
27 under section 393(2) of the department of management and budget

1 act, 1984 PA 431, MCL 18.1393.

2 Sec. 208. The department shall use the Internet to fulfill the
3 reporting requirements of this bill. This requirement may include
4 transmission of reports via electronic mail to the recipients
5 identified for each reporting requirement, or it may include
6 placement of reports on an Internet or Intranet site.

7 Sec. 209. Funds appropriated in part 1 shall not be used for
8 the purchase of foreign goods or services, or both, if
9 competitively priced and of comparable quality American goods or
10 services, or both, are available. Preference should be given to
11 goods or services, or both, manufactured or provided by Michigan
12 businesses if they are competitively priced and of comparable
13 quality.

14 Sec. 210. The director shall take all reasonable steps to
15 ensure businesses in deprived and depressed communities compete for
16 and perform contracts to provide services or supplies, or both. The
17 director shall strongly encourage firms with which the department
18 contracts to subcontract with certified businesses in depressed and
19 deprived communities for services, supplies, or both.

20 Sec. 218. Funds appropriated in part 1 for at-post troopers
21 shall only be expended for trooper salaries, wages, benefits,
22 retirement, equipment, supplies, and other expenses directly
23 related to state troopers assigned to general law enforcement
24 duties at a department post, detachment, satellite office, or a
25 resident trooper function.

26 Sec. 223. (1) Due to the current budgetary problems in this
27 state, out-of-state travel shall be limited to situations in which

1 1 or more of the following conditions apply:

2 (a) The travel is required by legal mandate or court order or
3 for law enforcement purposes.

4 (b) The travel is necessary to protect the health or safety of
5 Michigan citizens or visitors or to assist other states in similar
6 circumstances.

7 (c) The travel is necessary to produce budgetary savings or to
8 increase state revenues, including protecting existing federal
9 funds or securing additional federal funds.

10 (d) The travel is necessary to comply with federal
11 requirements.

12 (e) The travel is necessary to secure specialized training for
13 staff that is not available within this state.

14 (f) The travel is financed entirely by federal or nonstate
15 funds.

16 (2) If out-of-state travel is necessary but does not meet 1 or
17 more of the conditions in subsection (1), the state budget director
18 may grant an exception to allow the travel. Any exceptions granted
19 by the state budget director shall be reported on a monthly basis
20 to the senate and house of representatives standing committees on
21 appropriations.

22 (3) Not later than January 1 of each year, each department
23 shall prepare a travel report listing all travel by classified and
24 unclassified employees outside this state in the immediately
25 preceding fiscal year that was funded in whole or in part with
26 funds appropriated in the department's budget. The report shall be
27 submitted to the chairs and members of the senate and house of

1 representatives standing committees on appropriations, the fiscal
2 agencies, and the state budget director. The report shall include
3 the following information:

4 (a) The name of each person receiving reimbursement for travel
5 outside this state or whose travel costs were paid by this state.

6 (b) The destination of each travel occurrence.

7 (c) The dates of each travel occurrence.

8 (d) A brief statement of the reason for each travel
9 occurrence.

10 (e) The transportation and related costs of each travel
11 occurrence, including the proportion funded with state general
12 fund/general purpose revenues, the proportion funded with state
13 restricted revenues, the proportion funded with federal revenues,
14 and the proportion funded with other revenues.

15 (f) A total of all out-of-state travel funded for the
16 immediately preceding fiscal year.

17 INFORMATION TECHNOLOGY

18 Sec. 301. The money appropriated in part 1 for computer
19 services shall be funded by LEIN user fees sufficient to pay 1/3 of
20 the service and contract maintenance costs of the LEIN system.

21 Sec. 302. From the funds appropriated in part 1 for
22 information technology, the department shall pay user fees to the
23 department of information technology for technology-related
24 services and projects. Such user fees shall be subject to
25 provisions of an interagency agreement between the department and
26 the department of information technology.

1 Sec. 303. Amounts appropriated in part 1 for information
2 technology may be designated as work projects and carried forward
3 to support technology projects under the direction of the
4 department of information technology. Funds designated in this
5 manner are not available for expenditure until approved as work
6 projects under section 451a of the management and budget act, 1984
7 PA 431, MCL 18.1451a.

8 HIGHWAY SAFETY PLANNING

9 Sec. 401. Before January 1, 2008, the department shall report
10 to the senate and house appropriations subcommittees on state
11 police and military affairs on the status of assessments collected
12 and authorized under section 629e of the Michigan vehicle code,
13 1949 PA 300, MCL 257.629e, for the purposes of supporting the
14 secondary road patrol grant program. Each annual report shall
15 contain updated information on collection levels, revised projected
16 grant allotments to counties for the year, a comparison of
17 projected collections and grant distribution levels with the funds
18 appropriated in part 1 for the secondary road patrol program, and
19 the extent collection levels have exceeded or failed to meet
20 appropriated levels for the preceding fiscal year or expenditure
21 levels from the previous fiscal year.

22 FORENSIC SCIENCES

23 Sec. 501. When changes are made to the department's protocol
24 for retaining and purging DNA analysis samples and records, the
25 department shall provide an updated copy to every police agency in

1 the state.

2 **MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS**

3 Sec. 601. The money appropriated to the MCOLES for maintenance
4 and delivery of training to locals is provided in accordance with a
5 state reimbursement policy in which 100% of the determined state
6 reimbursement rate shall be distributed upon certification by the
7 MCOLES.

8 **EMERGENCY MANAGEMENT**

9 Sec. 801. (1) The state director of emergency management may
10 expend money appropriated under this bill to call upon any agency
11 or department of the state or any resource of the state to protect
12 life or property or to provide for the health or safety of the
13 population in any area of the state in which the governor proclaims
14 a state of emergency or state of disaster under 1945 PA 302, MCL
15 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
16 MCL 30.401 to 30.421. The state director of emergency management
17 may expend the amounts the director considers necessary to
18 accomplish these purposes. The director shall submit to the state
19 budget director as soon as possible a complete report of all
20 actions taken under the authority of this section. The report shall
21 contain, as a separate item, a statement of all money expended that
22 is not reimbursable from federal money. The state budget director
23 shall review the expenditures and submit recommendations to the
24 legislature in regard to any possible need for a supplemental
25 appropriation.

(2) In addition to the money appropriated in this bill, the department may receive and expend money from local, private, federal, or state sources for the purpose of providing emergency management training to local or private interests and for the purpose of supporting emergency preparedness, response, recovery, and mitigation activity. If additional expenditure authorization in the Michigan administrative information network is approved by the state budget office under this section, the department and the state budget office shall notify the house and senate appropriations subcommittees on state police and military and veterans affairs and the house and senate fiscal agencies within 10 days after the approval. The notification shall include the amount and source of the additional authorization, the date of its approval, and the projected use of funds to be expended under the authorization.

POST UNIFORM SERVICES

Sec. 901. State police enlisted personnel who are employed to enforce traffic laws as provided in section 629e of the Michigan vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited from responding to crimes in progress or other emergency situations, and are responsible for protecting every citizen of this state from harm.

STATEWIDE FIELD OPERATIONS

Sec. 1002. Money privately donated to the department is appropriated under part 1 to be used for the purposes designated by

1 the donor of the money. Money privately donated to the department's
2 canine unit shall be used to purchase equipment and other items to
3 enhance the operation of the canine unit.
