

HOUSE BILL No. 4661

April 25, 2007, Introduced by Rep. Lemmons and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled
"The revised school code,"
by amending section 416 (MCL 380.416), as amended by 2004 PA 303.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 416. (1) This section applies to a first class school
2 district only if the question under section 410 is not approved in
3 the first class school district.

4 (2) The officers of the first class school district board
5 shall be a president, vice-president, secretary, and treasurer. The
6 **SUBJECT TO SUBSECTION (7), THE** board, a majority of which ~~shall~~
7 ~~constitute~~**CONSTITUTES** a quorum, shall elect its president and
8 vice-president biennially from among the members of the board. In
9 case of a vacancy in the office of president, the vice-president
10 shall succeed to the office of president for the balance of the

1 unexpired term. The secretary and treasurer shall be appointed by
2 the board but shall not be members of the board and shall receive a
3 salary fixed by the board.

4 (3) The president, vice-president, and secretary shall perform
5 the duties prescribed by the bylaws and regulations of the board.
6 The duties of the treasurer shall be determined by the school
7 district general superintendent, as approved by the board.

8 (4) The officers of the board who in the discharge of the
9 duties of their respective positions handle funds belonging to the
10 first class school district shall be required to give bonds for the
11 faithful performance of their duties in accordance with the bylaws
12 and regulations of the board. The premium of the bonds shall be
13 paid from the funds of the board.

14 (5) The school district treasurer shall have the custody of
15 all money belonging to the school district and shall pay out money
16 pursuant to section 433. The funds shall be deposited with
17 depositories selected by the board, and the interest derived shall
18 be paid into the general fund of the board.

19 (6) The board shall require from the school district treasurer
20 a separate bond of not less than \$200,000.00 to protect the funds
21 of the board.

22 (7) ALL OF THE FOLLOWING APPLY TO THE BOARD MEMBERS ELECTED BY
23 THE BOARD IN 2006 AS PRESIDENT AND VICE PRESIDENT OF THE BOARD:

24 (A) THE INITIAL TERM AS PRESIDENT AND VICE PRESIDENT FOR EACH
25 OF THOSE BOARD MEMBERS IS CONTINUED UNTIL A SUCCESSOR IS ELECTED BY
26 THE BOARD FOR EACH IN JANUARY OF 2008.

27 (B) SUCCESSORS FOR EACH OF THOSE OFFICERS AS DESCRIBED IN

1 SUBDIVISION (A) SHALL BE ELECTED BIENNIALY BY THE BOARD AS
2 PROVIDED UNDER SUBSECTION (2).
