

HOUSE BILL No. 5077

August 1, 2007, Introduced by Reps. Espinoza, Polidori, Scott, Brown, Miller, Kathleen Law and Dean and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled
"Public health code,"
(MCL 333.1101 to 333.25211) by adding section 17769.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 17769. A PHARMACIST SHALL NOT INTERCHANGE AN
2 ANTIEPILEPTIC DRUG OR FORMULATION OF AN ANTIEPILEPTIC DRUG THAT IS
3 PRESCRIBED FOR THE TREATMENT OF EPILEPSY OR THE TREATMENT OR
4 PREVENTION OF SEIZURES WITHOUT PRIOR NOTIFICATION OF AND THE SIGNED
5 INFORMED CONSENT TO THE INTERCHANGE BY THE PRESCRIBING PHYSICIAN
6 AND PATIENT OR THE PATIENT'S PARENT, LEGAL GUARDIAN, SPOUSE, OR
7 OTHER LEGAL REPRESENTATIVE. AS USED IN THIS SECTION:

8 (A) "ANTIEPILEPTIC DRUG" MEANS A DRUG OR THERAPEUTIC
9 FORMULATION, GENERIC OR BRAND, PRESCRIBED FOR THE TREATMENT OF

1 EPILEPSY OR THE TREATMENT OR PREVENTION OF SEIZURES.

2 (B) "EPILEPSY" MEANS A NEUROLOGICAL CONDITION CHARACTERIZED BY
3 RECURRENT SEIZURES.

4 (C) "INTERCHANGE" MEANS THE SUBSTITUTION OF 1 VERSION OF AN
5 ANTIEPILEPTIC DRUG FOR THE ANTIEPILEPTIC DRUG ORIGINALLY
6 PRESCRIBED, INCLUDING, BUT NOT LIMITED TO, A GENERIC VERSION FOR
7 THE PRESCRIBED BRAND, A BRAND VERSION FOR THE PRESCRIBED GENERIC, A
8 GENERIC VERSION BY 1 MANUFACTURER FOR THE PRESCRIBED GENERIC BY A
9 DIFFERENT MANUFACTURER, A DIFFERENT FORMULATION OF AN ANTIEPILEPTIC
10 DRUG FOR THE PRESCRIBED ANTIEPILEPTIC DRUG, OR A DIFFERENT
11 ANTIEPILEPTIC THERAPEUTIC DRUG PRODUCT FOR THE PRESCRIBED
12 ANTIEPILEPTIC DRUG.

13 (D) "SEIZURE" MEANS AN ACUTE CLINICAL CHANGE SECONDARY TO A
14 BRIEF DISTURBANCE IN THE ELECTRICAL ACTIVITY OF THE BRAIN.
