- 1 SEC. 2978. (1) THE JUDGES OF EACH CIRCUIT SHALL DETERMINE AND
- 2 PUBLISH A FAIR AND EQUITABLE PROCESS FOR THE CREATION AND
- 3 MAINTENANCE OF THE LIST OF ELIGIBLE REFEREES IN THE COUNTY FOR
- 4 PURPOSES OF SECTION 2977.
- 5 (2) TO BE ELIGIBLE TO SERVE AS A REFEREE FOR PURPOSES OF
- 6 SECTION 2977, UNLESS THE PARTIES STIPULATE TO A PERSON TO SERVE AS
- 7 REFEREE IN A CASE, AN INDIVIDUAL MUST MEET THE FOLLOWING MINIMUM
- 8 QUALIFICATIONS:
- 9 (A) HE OR SHE SHALL HAVE COMPLETED A TRAINING PROGRAM APPROVED
