- 3 ISSUES A FINAL ORDER OF FORECLOSURE, THE CREDITOR SHALL TAKE ANY
- 4 STEPS NECESSARY TO TERMINATE THE FORECLOSURE PROCEEDING OR OTHER
- 5 ACTION.
- 6 (2) THE CURE OF A DEFAULT OF A HOME LOAN REINSTATES THE
- 7 BORROWER TO THE SAME POSITION AS IF THE DEFAULT HAD NOT OCCURRED
- 8 AND NULLIFIES ANY ACCELERATION OF ANY OBLIGATION UNDER THE SECURITY
 - INSTRUMENT OR NOTE ARISING FROM THE DEFAULT AS OF THE DATE OF THE
