A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 20126b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 20126B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 PART, A LOCAL UNIT OF GOVERNMENT MAY RECOVER FROM EITHER OF THE
- 3 FOLLOWING THE COSTS IT INCURRED IN PROVIDING POLICE, FIRE, AND
- 4 OTHER EMERGENCY SERVICES IN RESPONDING TO A RELEASE OR THREAT OF
- 5 RELEASE:
- 6 (A) A PERSON WHO IS LIABLE UNDER SECTION 20126 FOR AN ACTIVITY
 7 RESULTING IN THE NEED FOR THE EMERGENCY SERVICES.
 - (B) THE OWNER OR OPERATOR OF THE LAND OR BUILDINGS WHERE THE EMERGENCY SERVICES WERE PROVIDED.
 - (2) ALL PERSONS LIABLE TO A LOCAL UNIT OF GOVERNMENT UNDER
