by amending section 80152 (MCL 324.80152), as amended by 1999 PA
19.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 80152. (1) Except as otherwise provided in this section,
- 2 a person shall not operate a vessel on the waters of this state if
- 3 he or she is towing or otherwise assisting a person on water skis
- 4 or on a water sled, aquaplane, surfboard, or other similar
- 5 contrivance unless a person capable of communicating to the vessel
- 6 operator the condition and needs of the person being towed or
- 7 assisted is on board the vessel and positioned to observe the
 - person being towed or assisted.
 - (2) Subsection (1) does not apply to vessels used by duly

- 1 constituted ski schools in the giving of instructions or to vessels
- 2 used in sanctioned ski tournaments, competitions, expositions, or
- 3 trials. Vessels described in this subsection shall be ANY OF THE
- 4 FOLLOWING VESSELS IF equipped with a 170-degree wide-angle rearview
- 5 mirror affixed in a manner that will permit the operator to observe
- 6 the progress of the person being towed: -
- 7 (A) A VESSEL USED BY A SKI SCHOOL FOR GIVING INSTRUCTION.
- 8 (B) A VESSEL USED IN A SANCTIONED SKI TOURNAMENT, COMPETITION,
- 9 EXPOSITION, OR TRIAL.
- 10 (C) A PERSONAL WATERCRAFT.
- 11 (3) This section does not apply to motorboats less than 16
- 12 feet in length actually operated by the person being towed and so
- 13 constructed as to be incapable of carrying the operator in or on
- 14 the motorboat.
- 15 (4) Subsection (1) does not apply to a vessel operator who is
- 16 towing a person preparing for a specific water ski tournament if
- 17 all of the following conditions are met:
- 18 (a) The vessel operator is certified as provided in subsection
- **19** (5).
- 20 (b) The person being towed is certified as provided in
- 21 subsection (6).
- (c) Towing is conducted so that, on average, not more than 1
- 23 vessel approaches within 300 feet of the towing vessel during any
- 24 5-minute period.
- 25 (d) The vessel is equipped with all of the following:
- 26 (i) A center-mounted tow pylon.
- 27 (ii) A large clear rearview mirror capable of allowing the

- 3 (iii) Markings that identify the vessel as a vessel that is

- **5** (5) The department shall adopt standards for water ski
- 6 tournament boat operation established by U.S.A. water ski in
- 7 "Trained Boat Driver Program", April 1997, and by the American
- 8 water ski association in "Drivers' Policy Manual". However, the
- 9 department may promulgate rules providing for alternative standards
- 10 under the administrative procedures act of 1969, 1969 PA 306, MCL
- 11 24.201 to 24.328. The department shall certify each individual who
- 12 satisfies the standards described in this subsection as a
- 13 tournament water ski vessel operator and issue proof of that
- 14 certification to the individual.
- 15 (6) The department shall adopt standards for tournament water
- 16 skiers established by the Michigan water ski association in
- 17 "Guidelines for Training Permit Eligibility", proposed revision 125
- 18 of 1996. However, the department may promulgate rules providing for
- 19 alternative standards under the administrative procedures act of
- 20 1969, 1969 PA 306, MCL 24.201 to 24.328. The department shall
- 21 certify each individual who satisfies the standards described in
- 22 this subsection as a tournament water skier and issue proof of that
- 23 certification to the individual.
- 24 (7) The Michigan water ski association shall provide annually
- 25 to the department and the Michigan sheriffs association both of the
- 26 following:
- 27 (a) A list of the individuals whom the organization considers

- 1 qualified for tournament water skiing.
- 2 (b) The names of not more than 3 bodies of water on which each
- 3 of those individuals may be authorized to practice for tournament
- 4 water skiing.
- 5 (8) The department shall specify the body or bodies of water
- 6 upon which a water skier may practice upon each certificate issued
- 7 under subsection (6).
