

HOUSE BILL No. 5441

November 8, 2007, Introduced by Reps. Emmons, Nitz, Calley, Palsrok, Shaffer, Scott, Amos, Walker, Caul, Sheen, Pastor, Brandenburg, Steil, Rick Jones, Nofs, Caswell, Stakoe, Lemmons, Donigan, Meadows, Pavlov, Acciavatti, Hoogendyk, Meekhof, Opsommer, Alma Smith, Dean, Espinoza, Pearce, Huizenga and Garfield and referred to the Committee on Military and Veterans Affairs and Homeland Security.

A bill to amend 2002 PA 591, entitled
"Michigan nursing scholarship act,"
by amending section 2 (MCL 390.1182), as amended by 2006 PA 444.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2. As used in this act:

2 (a) "Authority" means the Michigan higher education assistance
3 authority created by 1960 PA 77, MCL 390.951 to 390.961.

4 (b) "Eligible costs" means tuition and fees charged by an
5 eligible institution; related costs for room, board, books,
6 supplies, transportation, or day care; and other costs determined
7 by the authority.

8 (c) "Eligible employment" means either of the following:

9 (i) Teaching in a nursing program.

1 (ii) A registered nurse or licensed practical nurse providing
2 full-time nursing care, or part-time nursing care if section 7
3 applies, in a ward, emergency department, emergency room, operating
4 room, or trauma center of a hospital licensed under article 17 of
5 the public health code, 1978 PA 368, MCL 333.20101 to 333.22260, in
6 a nursing home or hospice licensed under article 17 of the public
7 health code, 1978 PA 368, MCL 333.20101 to 333.22260, in a health
8 facility or agency licensed under article 17 of the public health
9 code, 1978 PA 368, MCL 333.20101 to 333.22260, that provides
10 nonemergency health care to patients without receiving compensation
11 for providing that nonemergency health care, or in a clinic or
12 other health care program operated by a local health department
13 that provides 1 or more required services under part 24 of the
14 public health code, 1978 PA 368, MCL 333.2401 to 333.2498, or as an
15 employee of a home health care agency providing home patient care.

16 (d) "Eligible institution" means a degree or certificate
17 granting public or independent nonprofit college or university,
18 junior college, or community college in this state **THAT CONSIDERS A**
19 **STUDENT ENROLLED IN THAT INSTITUTION A RESIDENT OF THIS STATE FOR**
20 **DETERMINING HIS OR HER TUITION RATES IF THE STUDENT IS ANY OF THE**
21 **FOLLOWING:**

22 (i) **AN ACTIVE DUTY MEMBER, OR THE SPOUSE OR DEPENDENT CHILD OF**
23 **AN ACTIVE DUTY MEMBER, OF THE ARMED FORCES OF THE UNITED STATES,**
24 **WHILE THAT ACTIVE DUTY MEMBER IS STATIONED IN THIS STATE AND DURING**
25 **THE STUDENT'S CONTINUOUS ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM**
26 **IN WHICH HE OR SHE IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS**
27 **TRANSFERRED TO ACTIVE DUTY OUTSIDE OF THIS STATE.**

1 (ii) A CHILD OF AN ACTIVE DUTY MEMBER OF THE ARMED FORCES OF
2 THE UNITED STATES WHO WAS STATIONED IN THIS STATE BUT IS
3 TRANSFERRED TO A DUTY LOCATION OUTSIDE OF THIS STATE WITHIN THE 1-
4 YEAR PERIOD PRECEDING THE STUDENT'S INITIAL ENROLLMENT IN THAT
5 INSTITUTION AND THE STUDENT CONTINUES TO LIVE IN THIS STATE.

6 (e) "Licensed practical nurse" means an individual licensed to
7 engage in the practice of nursing as a licensed practical nurse as
8 defined in section 17201 of the public health code, 1978 PA 368,
9 MCL 333.17201.

10 (f) "Nursing program" means either of the following:

11 (i) A program for the training of individuals to become
12 registered nurses or licensed practical nurses operated in this
13 state by an eligible institution and approved by the Michigan board
14 of nursing.

15 (ii) A master's degree in nursing program operated in this
16 state by an eligible institution and approved by the Michigan board
17 of nursing.

18 (g) "Registered professional nurse" means that term as defined
19 in section 17201 of the public health code, 1978 PA 368, MCL
20 333.17201.
