"Michigan nursing scholarship act,"

by amending section 2 (MCL 390.1182), as amended by 2006 PA 444.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- (a) "Authority" means the Michigan higher education assistanceauthority created by 1960 PA 77, MCL 390.951 to 390.961.
  - (b) "Eligible costs" means tuition and fees charged by an eligible institution; related costs for room, board, books, supplies, transportation, or day care; and other costs determined by the authority.
    - (c) "Eligible employment" means either of the following:
    - (i) Teaching in a nursing program.

- 21 FOLLOWING:
- 22 (i) AN ACTIVE DUTY MEMBER, OR THE SPOUSE OR DEPENDENT CHILD OF
- 23 AN ACTIVE DUTY MEMBER, OF THE ARMED FORCES OF THE UNITED STATES,
- 24 WHILE THAT ACTIVE DUTY MEMBER IS STATIONED IN THIS STATE AND DURING
- 25 THE STUDENT'S CONTINUOUS ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM
- 26 IN WHICH HE OR SHE IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS
- 27 TRANSFERRED TO ACTIVE DUTY OUTSIDE OF THIS STATE.
