- 1 SEC. 512. (1) THE DIRECTOR MAY AUTHORIZE A PERSON ENGAGED IN
- 2 THE PRODUCTION OF A FILM IN THIS STATE TO USE WITHOUT CHARGE
- 3 PROPERTY OWNED OR UNDER THE CONTROL OF THE DEPARTMENT FOR THE
- 4 PURPOSE OF PRODUCING A FILM UNDER TERMS AND CONDITIONS ESTABLISHED
- 5 BY THE DIRECTOR. THE ECONOMIC AND OTHER BENEFITS TO THIS STATE OF
- 6 FILM PRODUCTION LOCATED IN THIS STATE SHALL BE DEEMED TO BE THE
- 7 VALUE RECEIVED BY THE DEPARTMENT IN EXCHANGE FOR THE USE OF
- 8 PROPERTY UNDER THIS SECTION.
