- 18 OFFENSE AND IS GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE OF NOT
- 19 MORE THAN \$1,000.00 OR IMPRISONMENT FOR NOT MORE THAN 1 YEAR, OR
- 20 BOTH, FOR A SECOND OR SUBSEQUENT OFFENSE.
- 21 (3) A PERSON WHO VIOLATES SUBSECTION (1) (B) OR (C) IS GUILTY

- 25 (A) "EXOTIC ANIMAL" MEANS AN ANIMAL THAT IS NOT NATIVE TO THIS

- 27 IN A FARM OPERATION AS THAT TERM IS DEFINED UNDER THE MICHIGAN

- 1 RIGHT TO FARM ACT, 1981 PA 93, MCL 286.471 TO 286.474. EXOTIC
- 2 ANIMAL ALSO DOES NOT INCLUDE A PROHIBITED FISH SPECIES AS THAT TERM
- 3 IS DEFINED UNDER SECTION 41301 OF THE NATURAL RESOURCES AND

- 5 (B) "OWNER" MEANS A PERSON WHO OWNS OR IS RESPONSIBLE FOR AN
- 6 EXOTIC ANIMAL.
- 7 (C) "RELEASE" MEANS TO CAUSE OR ALLOW AN EXOTIC ANIMAL TO
- 8 BECOME LOCATED OUTSIDE THE PROPERTY OF THE OWNER AND NOT UNDER THE
- 9 DIRECT CONTROL OF THE OWNER.
