## **HOUSE BILL No. 6152**

May 22, 2008, Introduced by Rep. Lemmons and referred to the Committee on Education.

A bill to amend 1954 PA 116, entitled

"Michigan election law,"

(MCL 168.1 to 168.992) by adding section 315b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 315B. (1) THIS STATE SHALL REIMBURSE A FIRST CLASS SCHOOL
- 2 DISTRICT FOR THE COSTS INCURRED BY THE FIRST CLASS SCHOOL DISTRICT
- 3 FOR HOLDING A REGULAR OR SPECIAL SCHOOL ELECTION FROM JANUARY 1,
- 4 1999 THROUGH DECEMBER 31, 2007. THE REIMBURSEMENT SHALL NOT EXCEED
- 5 THE VERIFIED ACCOUNT OF ACTUAL COSTS INCURRED BY THE FIRST CLASS
- 6 SCHOOL DISTRICT FOR HOLDING ITS REGULAR OR SPECIAL SCHOOL ELECTION.
- 7 (2) PAYMENT SHALL BE MADE UPON PRESENTATION AND APPROVAL OF A
- B VERIFIED ACCOUNT OF ACTUAL COSTS INCURRED TO THE DEPARTMENT OF
  - TREASURY, LOCAL GOVERNMENT AUDIT DIVISION, AFTER THE DEPARTMENT OF
  - TREASURY AND THE SECRETARY OF STATE AGREE AS TO WHAT CONSTITUTES

- 1 VALID COSTS OF HOLDING A REGULAR OR SPECIAL SCHOOL ELECTION.
- 2 REIMBURSABLE COSTS DO NOT INCLUDE SALARIES OF PERMANENT LOCAL
- 3 OFFICIALS, THE COST OF REUSABLE SUPPLIES AND EQUIPMENT, OR COSTS
- 4 ATTRIBUTABLE TO LOCAL OR SPECIAL ELECTIONS HELD IN CONJUNCTION WITH
- 5 THE REGULAR OR SPECIAL SCHOOL ELECTION.
- 6 (3) THE LEGISLATURE SHALL APPROPRIATE FROM THE GENERAL FUND OF
- 7 THIS STATE AN AMOUNT NECESSARY TO IMPLEMENT THIS SECTION.
- 8 (4) TO QUALIFY FOR REIMBURSEMENT, A FIRST CLASS SCHOOL
- 9 DISTRICT SHALL SUBMIT ITS VERIFIED ACCOUNT OF ACTUAL COSTS INCURRED
- 10 TO THE DEPARTMENT OF TREASURY NO LATER THAN 120 DAYS AFTER THE
- 11 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
- 12 (5) NOT LATER THAN 90 DAYS AFTER THE DEPARTMENT OF TREASURY
- 13 RECEIVES THE VERIFIED ACCOUNT OF THE ACTUAL COSTS INCURRED, THE
- 14 DEPARTMENT OF TREASURY, AFTER CONSULTATION WITH THE DEPARTMENT OF
- 15 STATE, SHALL PAY OR DISAPPROVE THE VERIFIED ACCOUNT.
- 16 (6) IF THIS STATE DISAPPROVES ALL OR A PORTION OF A VERIFIED
- 17 ACCOUNT OF ACTUAL COSTS INCURRED UNDER THIS SECTION, THIS STATE
- 18 SHALL SEND A NOTICE OF DISAPPROVAL ALONG WITH THE REASONS FOR THE
- 19 DISAPPROVAL TO THE FIRST CLASS SCHOOL DISTRICT. UPON REQUEST OF A
- 20 FIRST CLASS SCHOOL DISTRICT WHOSE VERIFIED ACCOUNT WAS DISAPPROVED
- 21 UNDER THIS SECTION, THIS STATE SHALL REVIEW THE DISAPPROVED COSTS
- 22 WITH THE FIRST CLASS SCHOOL DISTRICT.
- 23 (7) AS USED IN THIS SECTION, "FIRST CLASS SCHOOL DISTRICT"
- 24 MEANS A SCHOOL DISTRICT ORGANIZED AS A SCHOOL DISTRICT OF THE FIRST
- 25 CLASS UNDER THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1 TO
- 26 380.1852.
