## **SENATE BILL No. 732**

September 6, 2007, Introduced by Senators RICHARDVILLE, ALLEN, GARCIA, BIRKHOLZ, HARDIMAN, KAHN, JELINEK, VAN WOERKOM, PATTERSON, CROPSEY, GILBERT, CASSIS, McMANUS, OLSHOVE, KUIPERS, JANSEN, SWITALSKI, STAMAS, BROWN, JACOBS, CHERRY, BARCIA, GLEASON, SANBORN, CLARKE, BASHAM, WHITMER, BISHOP, ANDERSON, SCHAUER, HUNTER, SCOTT, CLARK-COLEMAN and PAPPAGEORGE and referred to the Committee on Senior Citizens and Veterans Affairs.

A bill to designate enterprises owned or controlled by qualified veterans as Michigan patriot businesses; and to provide for the powers and duties of certain state governmental officers and entities.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the "Michigan patriot business act".
  - Sec. 3. As used in this act:
- (a) "Board" means the board of directors of the Michigan strategic fund created in section 5 of the Michigan strategic fund act, 1984 PA 270, MCL 125.2005.
- (b) "Qualified business enterprise" means a business enterprise that is more than 50% owned by 1 or more qualified

- 2 (c) "Qualified veteran" means an individual who meets all of
- 3 the following:
- 4 (i) His or her legal residence before, during, and after
- 5 military service is in this state.
- (ii) He or she served as a member of any branch of the armed
- 7 forces of the United States and received an honorable discharge or
- 8 a discharge for physical reasons with an honorable record.
- 9 (iii) His or her military service included service in the
- 10 Persian Gulf combat zone as part of Operation Iraqi Freedom or in
- 11 southern or central Asia as part of Operation Enduring Freedom.
- 12 Sec. 5. The board shall:
- 13 (a) Designate qualified business enterprises as Michigan
- 14 patriot businesses.
- 15 (b) Maintain a current list of Michigan patriot businesses and
- 16 make that list available to the public on the board's internet
- 17 website, and available to the department of management and budget
- 18 for purposes of section 141(f) of the management and budget act,
- 19 1984 PA 431, MCL 18.1141.
- (c) Provide technical, managerial, and counseling services and
- 21 assistance to qualified business enterprises.
- 22 (d) With the participation of other state departments and
- 23 agencies as appropriate, develop comprehensive plans and specific
- 24 program goals for a qualified business enterprise program;
- 25 establish regular performance monitoring and reporting systems to
- 26 assure that the goals are being achieved; and evaluate the impact
- 27 of federal and state support in achieving the objectives

- 2 (e) Implement state policy in support of qualified business
- 3 enterprise development and coordinate the plans, programs, and
- 4 operations of state government that affect or may contribute to the
- 5 establishment, preservation, and strengthening of qualified

- 7 (f) Coordinate, make application for, and administer federal
- 8 funding grants from federal agencies where applicable.
- 9 (g) Promote the mobilization of activities and resources of
- 10 state agencies and local governments, business and trade
- 11 associations, universities, foundations, professional
- 12 organizations, and volunteer and other groups toward the growth of
- 13 qualified business enterprises, and facilitate the coordination of
- 14 the efforts of these groups with those of other state departments
- 15 and agencies.
- 16 (h) Establish a center for the development, collection, and
- 17 dissemination of information that will be helpful to persons and
- 18 organizations throughout the state in undertaking or promoting the
- 19 establishment and successful operation of qualified business
- 20 enterprises.
- 21 (i) Assist in experimental and demonstration projects, and
- 22 defray all or part of the cost of such projects, designed to
- 23 overcome the special problems of qualified business enterprises.
- 24 (j) Conduct coordinated reviews of all proposed state training
- 25 and technical assistance activities in direct support of the
- 26 qualified business enterprises program to ensure consistency with
- 27 program goals and to preclude duplication of effort of other state

- 1 agencies with overlapping jurisdictions.
- 2 (k) Recommend appropriate legislative or executive actions to
- 3 enhance the opportunities of qualified business enterprises in this
- 4 state.
- 5 (1) Assist qualified business enterprises in obtaining
- 6 governmental or commercial financing for business expansion,
- 7 establishment of new businesses, or industrial development
- 8 projects.
- 9 (m) Assist qualified business enterprises in business contract
- 10 procurement from governmental and private commercial sources.
- 11 (n) Provide a program effort to ensure participation of
- 12 qualified veterans in qualified business enterprise activities.
- 13 Enacting section 1. This act does not take effect unless all
- 14 of the following bills of the 94th Legislature are enacted into
