THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5A. (1) THE ALTERNATIVE FUELS FUND IS CREATED WITHIN THE
- 2 STATE TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER
- 3 ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE ALTERNATIVE FUELS FUND.
- 4 THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE ALTERNATIVE
- 5 FUELS FUND. THE STATE TREASURER SHALL CREDIT TO THE FUND INTEREST
- 6 AND EARNINGS FROM FUND INVESTMENTS. MONEY IN THE FUND AT THE CLOSE
- 7 OF THE FISCAL YEAR SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO
- 8 THE GENERAL FUND.
