SENATE BILL No. 1616

November 6, 2008, Introduced by Senators JANSEN, BIRKHOLZ, RICHARDVILLE, CHERRY, JACOBS and WHITMER and referred to the Committee on Judiciary.

A bill to amend 1939 PA 288, entitled

"Probate code of 1939,"

by amending section 18m of chapter XIIA (MCL 712A.18m), as amended by 2004 PA 102.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER XIIA

Sec. 18m. (1) If a juvenile is within the court's jurisdiction under section 2(a)(1) of this chapter, and is ordered to pay any combination of fines, costs, restitution, assessments, or payments arising out of the same juvenile proceeding, the court shall order the juvenile to pay costs of not less than the following amount, as applicable:

- 3 (b) \$45.00 \$50.00, if the juvenile is found to be within the
- 4 court's jurisdiction for a serious misdemeanor or a specified

- 6 (c) \$40.00 \$45.00, if the juvenile is found to be within the
- 7 court's jurisdiction for a misdemeanor not described in subdivision
- 8 (b) or of an ordinance violation.
- 9 (2) Of the costs ordered to be paid, the clerk of the court
- 10 shall pay to the justice system fund created in section 181 of the
- 11 revised judicature act of 1961, 1961 PA 236, MCL 600.181, the
- 12 applicable amount specified as a minimum cost in subsection (1).
- 13 (3) If a juvenile who is ordered to pay a minimum state cost
- 14 under this section is subject to any combination of fines, costs,
- 15 restitution, assessments, or payments arising out of the same
- 16 juvenile proceeding, money collected from that person for the
- 17 payment of fines, costs, restitution, assessments, or other
- 18 payments shall be allocated as provided in section 29 of this
- 19 chapter. A fine imposed for a felony, misdemeanor, or ordinance
- 20 violation shall not be waived unless costs, other than the minimum
- 21 state cost, are waived.
- 22 (4) On the last day of each month, the clerk of the court
- 23 shall transmit the minimum state cost or portions of minimum state
- 24 cost collected under this section to the department of treasury for
- 25 deposit in the justice system fund created in section 181 of the
- 26 revised judicature act of 1961, 1961 PA 236, MCL 600.181.
