A bill to amend 1976 PA 388, entitled "Michigan campaign finance act," (MCL 169.201 to 169.282) by adding section 57a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 57A. (1) A CANDIDATE OR PERSON <<
2 >> SHALL NOT SOLICIT OR ACCEPT A CONTRIBUTION IN A FACILITY
3 OWNED OR LEASED BY, OR ON BEHALF OF, THIS STATE OR A PUBLIC BODY <<OR
OTHERWISE UTILIZE THE RESOURCES OF A PUBLIC BODY TO SOLICIT OR ACCEPT A
CONTRIBUTION>>.

4 (2) SUBSECTION (1) DOES NOT APPLY TO A CONTRIBUTION SOLICITED
5 OR ACCEPTED IN ANY OF THE FOLLOWING:

6 (A) A FACILITY OWNED OR LEASED BY, OR ON BEHALF OF, THE STATE
7 OR A PUBLIC BODY IF THAT FACILITY IS PRIMARILY USED AS A FAMILY
8 DWELLING AND IS NOT USED TO CONDUCT A FUND-RAISING EVENT.

9 (B) A FACILITY OWNED OR LEASED BY, OR ON BEHALF OF, THE STATE
10 OR A PUBLIC BODY IF ANY CANDIDATE HAS AN EQUAL OPPORTUNITY TO USE

1 THE FACILITY.

2 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
3 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR
4 A FINE OF NOT MORE THAN \$1,000.00, OR BOTH<<, OR IF THE PERSON IS
NOT AN INDIVIDUAL, BY A FINE OF NOT MORE THAN \$20,000.00 OR THE AMOUNT
OF THE CONTRIBUTION OR EXPENDITURE, WHICHEVER IS MORE>>.
