- 2 HUNTING OR FISHING LICENSES AS PROVIDED IN THIS SECTION, FOR THE
 - FOLLOWING FEES:
- 4 (A) THE FEE FOR A VETERAN LIFETIME SMALL GAME LICENSE,
- 5 EQUIVALENT TO THE LICENSE AVAILABLE ANNUALLY PURSUANT TO SECTION
- 6 43523, IS \$15.00.
- 7 (B) THE FEE FOR A VETERAN LIFETIME FIREARM DEER LICENSE,
- 8 EQUIVALENT TO THE LICENSE AVAILABLE ANNUALLY TO TAKE 1 DEER IN A
- SEASON PURSUANT TO SECTION 43526, IS \$15.00.

- 24 CONTINUES TO BE VALID EVEN IF THE HOLDER OF THAT LICENSE BECOMES A
- 25 NONRESIDENT.
- 26 (4) A VETERAN MAY PURCHASE A VETERAN LIFETIME LICENSE BY
- 27 SUBMITTING A COMPLETED APPLICATION ACCOMPANIED BY THE FEE REQUIRED

- 6 (C) THE HEIGHT, WEIGHT, AND EYE COLOR OF THE APPLICANT.
- 7 (D) THE ADDRESS OF THE APPLICANT.
- 8 (E) IF THE APPLICANT HAS A DRIVER LICENSE, THE DRIVER LICENSE
- 9 NUMBER OF THE APPLICANT.
- 10 (F) THE SOCIAL SECURITY NUMBER OF THE APPLICANT.
- 11 (G) PROOF THAT THE APPLICANT IS A VETERAN.
- 12 (5) THE HOLDER OF A VETERAN LIFETIME LICENSE SHALL NOTIFY THE
- 13 DEPARTMENT IF HE OR SHE HAS A NAME OR ADDRESS CHANGE.
- 14 (6) AS USED IN THIS SECTION, "VETERAN" MEANS A RESIDENT OF
- 15 THIS STATE WHO SERVED IN THE ARMY, AIR FORCE, NAVY, MARINE CORPS,
- 16 OR COAST GUARD AND WHO WAS DISCHARGED OR RELEASED FROM HIS OR HER
- 17 SERVICE WITH AN HONORABLE DISCHARGE OR GENERAL DISCHARGE.
