

# HOUSE BILL No. 5765

January 21, 2010, Introduced by Reps. Lisa Brown and Corriveau and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 16521, 17025, 17903, and 18705 (MCL 333.16521, 333.17025, 333.17903, and 333.18705), section 16521 as amended by 2006 PA 397, section 17025 as amended by 2006 PA 161, section 17903 as amended by 2006 PA 387, and section 18705 as amended by 2006 PA 407.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 16521. (1) The Michigan board of acupuncture is created  
2 in the department and shall consist of the following ~~9~~-voting  
3 members who meet the requirements of part 161:

4           (a) ~~Four~~ **UNTIL JUNE 30, 2010, 4** acupuncturists. **BEGINNING JULY**

1 **1, 2010, 7 ACUPUNCTURISTS.** The members ~~initially~~ appointed under  
2 this subdivision shall meet the requirements of section 16135.

3 (b) Three physicians licensed under part 170 or 175.

4 (c) ~~Two~~ **UNTIL JUNE 30, 2010, 2 public members. BEGINNING JULY**  
5 **1, 2010, 3 PUBLIC MEMBERS.**

6 (2) The terms of office of individual members of the board  
7 created under this part, except those appointed to fill vacancies,  
8 expire 4 years after appointment on June 30 of the year in which  
9 the term expires.

10 Sec. 17025. ~~(1)~~ A joint task force is created for the health  
11 profession subfields licensed under this part. The task force shall  
12 consist of the following ~~11~~ members, who shall meet the  
13 requirements of part 161: ~~±~~

14 (A) **ONE** member each from the board of medicine, the board of  
15 osteopathic medicine and surgery, and the board of podiatric  
16 medicine and surgery holding a license other than a health  
17 profession subfield license. ~~7~~

18 (B) **UNTIL JUNE 30, 2010, 5 physician's assistants. ~~7~~ and ~~3~~**  
19 **BEGINNING JULY 1, 2010, 7 PHYSICIAN'S ASSISTANTS.**

20 (C) **THREE** public members.

21 ~~(2) The requirement of section 16135(d) that a task force~~  
22 ~~member shall have practiced that profession for 2 years immediately~~  
23 ~~before appointment is waived until October 1, 1980 for members of~~  
24 ~~the board licensed in a health profession subfield created by this~~  
25 ~~part.~~

26 Sec. 17903. (1) The Michigan athletic trainer board is created  
27 in the department and shall consist of the following ~~7~~ members

1 meeting the requirements of part 161:

2 (a) ~~Four~~ UNTIL JUNE 30, 2010, 4 athletic trainers. BEGINNING  
3 JULY 1, 2010, 6 ATHLETIC TRAINERS.

4 (b) ~~One~~ UNTIL JUNE 30, 2010, 1 public member. BEGINNING JULY  
5 1, 2010, 3 PUBLIC MEMBERS.

6 (c) Two physicians licensed under part 170 or 175.

7 (2) The terms of office of individual members of the board  
8 created under this part, except those appointed to fill vacancies,  
9 expire 4 years after appointment on June 30 of the year in which  
10 the term expires.

11 Sec. 18705. (1) The Michigan board of respiratory care is  
12 created in the department and consists of the following ~~7~~ members  
13 who meet the requirements of part 161:

14 (a) ~~Four~~ UNTIL JUNE 30, 2010, 4 individuals who meet the  
15 requirements of section 16135(2). BEGINNING JULY 1, 2010, 7  
16 INDIVIDUALS WHO ARE ENGAGED IN THE PRACTICE OF RESPIRATORY CARE.

17 (b) One medical director.

18 (c) ~~Two~~ UNTIL JUNE 30, 2010, 2 public members. BEGINNING JULY  
19 1, 2010, 3 PUBLIC MEMBERS.

20 (2) The terms of office of individual members of the board  
21 created under this section, except those appointed to fill  
22 vacancies, expire 4 years after appointment on December 31 of the  
23 year in which the term expires.
