HOUSE BILL No. 5828

February 17, 2010, Introduced by Rep. Byrnes and referred to the Committee on Judiciary.

A bill to amend 1963 PA 247, entitled

"An act to define the term "newspaper" as used in the statutes of this state regarding publication of notices,"

by amending section 1 (MCL 691.1051).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) The term "newspaper" as AS used in any statute of
- 2 this state , except the revised judicature act of 1961 relative IN
- 3 RELATION to the publication of a notice, of any kind, shall be
- 4 construed to refer only to a newspaper UNLESS THE STATUTE EXPRESSLY
- 5 PROVIDES OTHERWISE, "NEWSPAPER" MEANS A PRINT PUBLICATION published
- 6 in the English language for the dissemination of local or
- 7 transmitted news and intelligence of a general character or for the
- 8 dissemination of legal news —TO which ALL OF THE FOLLOWING APPLY:

- 1 (a) THE NEWSPAPER has a bona fide list of paying subscribers
- 2 or has been published at not less than weekly intervals in the same
- 3 community without interruption for at least 2 years. , and
- 4 (b) THE NEWSPAPER has been published and of general
- 5 circulation at not less than weekly intervals without interruption
- 6 for at least 1 year in the county, township, city, village or
- 7 district where the notice is required to be published REQUIRED
- 8 AREA. A newspaper shall not lose eligibility for interruption of
- 9 continuous publication because of acts of God, labor disputes or
- 10 because of military service of the publisher for a period of not to
- 11 exceed 2 years and provided publication is resumed within 6 months
- 12 following the termination of such military service,
- 13 (c) THE NEWSPAPER annually averages at least 25% news and
- 14 editorial content per issue. The term "news and editorial content"
- 15 for the purpose of this section means any printed matter other than
- 16 advertising.
- 17 (2) IF THERE IS NO NEWSPAPER THAT MEETS THE DEFINITION IN
- 18 SUBSECTION (1) PUBLISHED AND OF GENERAL CIRCULATION IN THE REQUIRED
- 19 AREA, "NEWSPAPER" MEANS A WEBSITE ON THE INTERNET THAT MEETS ALL OF
- 20 THE FOLLOWING REQUIREMENTS:
- 21 (A) THE WEBSITE IS IDENTIFIED AS A CONTINUING ONLINE VERSION
- 22 OF A NEWSPAPER THAT PREVIOUSLY MET THE DEFINITION IN SUBSECTION (1)
- 23 AND WAS PUBLISHED AND OF GENERAL CIRCULATION IN THE REQUIRED AREA.
- 24 (B) THE WEBSITE IS PUBLISHED IN THE ENGLISH LANGUAGE FOR THE
- 25 DISSEMINATION OF LOCAL NEWS OF A GENERAL CHARACTER OR FOR THE
- 26 DISSEMINATION OF LEGAL NEWS FOR THE REQUIRED AREA.
- 27 (C) THE WEBSITE HAS BEEN ESTABLISHED AND OPERATING WITHOUT

- 1 INTERRUPTION FOR AT LEAST 2 YEARS.
- 2 (D) THE WEBSITE CONTAINS SUBSTANTIAL NEWS AND EDITORIAL
- 3 CONTENT.
- 4 (E) NEWS CONTENT ON THE WEBSITE IS PUBLISHED AND POSTED
- 5 REGULARLY AND WAS UPDATED AT LEAST EVERY 7 DAYS FOR THE PRECEDING 2
- 6 YEARS.
- 7 (F) THE WEBSITE LISTS ALL OF THE FOLLOWING:
- 8 (i) CONTACT INFORMATION, INCLUDING A LIST OF STAFF LOCATED IN
- 9 THE REQUIRED AREA.
- 10 (ii) AN ADDRESS AND TELEPHONE NUMBER IN THE REQUIRED AREA.
- 11 (iii) AN ADDRESS IN THE REQUIRED AREA WHERE PUBLIC NOTICES MAY
- 12 BE SENT FOR POSTING.
- 13 (iv) AN ADDRESS IN THE REQUIRED AREA WHERE COMPLAINTS CAN BE
- 14 MADE.
- 15 (v) AN ADDRESS IN THE REQUIRED AREA WHERE PRINTED COPIES OF
- 16 NOTICES MAY BE VIEWED BY THE PUBLIC.
- 17 (G) THE WEBSITE INCLUDES A CLEARLY DESIGNATED AREA FOR PUBLIC
- 18 NOTICES THAT IS ACCESSIBLE VIA A CONSPICUOUSLY DISPLAYED AND
- 19 CLEARLY LABELED LINK FROM THE HOMEPAGE OF THE WEBSITE AND THE
- 20 POSTED NOTICES ARE MAINTAINED PERMANENTLY IN A SEARCHABLE DATABASE
- 21 ACCESSIBLE ON THE WEBSITE.
- 22 (H) A SUBSTANTIAL NUMBER OF VISITORS TO THE WEBSITE ARE
- 23 RESIDENTS OF THE REQUIRED AREA.
- 24 (3) If THERE IS no newspaper so qualifies THAT MEETS THE
- 25 DEFINITION IN SUBSECTION (1) OR (2) in the county where the court
- 26 is situated, the term REQUIRED AREA, "newspaper" shall include any
- 27 MEANS A newspaper in an adjoining county which by this act is

- 1 qualified to publish notice of actions commenced therein COUNTY,
- 2 TOWNSHIP, CITY, VILLAGE, DISTRICT, OR OTHER GEOGRAPHIC TERRITORY,
- 3 AS APPLICABLE, THAT MEETS THE DEFINITION IN SUBSECTION (1) OR (2).
- 4 (4) A NEWSPAPER SHALL MAINTAIN A PERMANENT AND COMPLETE
- 5 PRINTED COPY OF EACH PUBLISHED NEWSPAPER EDITION FOR ARCHIVAL AND
- 6 VERIFICATION PURPOSES IN THE REQUIRED AREA. A WEBSITE THAT
- 7 QUALIFIES AS A NEWSPAPER UNDER THIS SECTION SHALL CREATE A PRINTED
- 8 COPY OF ANY NOTICE, IN A FORMAT THAT INCLUDES THE DATE OF
- 9 PUBLICATION, ON THE FIRST DAY THAT THE NOTICE IS PUBLISHED ON THE
- 10 WEBSITE AND SHALL MAINTAIN THE PRINTED COPY IN THE REQUIRED AREA
- 11 FOR ARCHIVAL AND VERIFICATION PURPOSES.
- 12 (5) A NEWSPAPER THAT MEETS THE DEFINITION UNDER SUBSECTION (1)
- 13 OR (2) BUT THAT IS CONTROLLED BY THE PERSON ON WHOSE BEHALF THE
- 14 NOTICE IS PUBLISHED OR BY AN OFFICER, EMPLOYEE, AGENT, OR AFFILIATE
- 15 OF THE PERSON IS NOT QUALIFIED TO ACT AS A NEWSPAPER FOR
- 16 PUBLICATION OF THE NOTICE.
- 17 (6) AS USED IN THIS SECTION:
- 18 (A) "CONTROLLED" MEANS THAT THE PERSON HAS 1 OR MORE OF THE
- 19 FOLLOWING:
- 20 (i) OWNERSHIP OF OR THE POWER TO VOTE, DIRECTLY OR INDIRECTLY,
- 21 MORE THAN 50% OF A CLASS OF VOTING SECURITIES OR VOTING INTERESTS
- 22 OF THE NEWSPAPER.
- 23 (ii) POWER BY THE PERSON'S OWN ACTION TO ELECT OR APPOINT A
- 24 MAJORITY OF EXECUTIVE OFFICERS, MANAGERS, DIRECTORS, TRUSTEES, OR
- 25 OTHER PERSONS EXERCISING MANAGERIAL AUTHORITY OF THE NEWSPAPER.
- 26 (iii) THE LEGAL RIGHT BY THE PERSON'S OWN ACTION TO DIRECT,
- 27 RESTRICT, REGULATE, GOVERN, OR ADMINISTER THE MANAGEMENT OR

- 1 POLICIES OF THE NEWSPAPER.
- 2 (B) "INTERNET" MEANS THAT TERM AS DEFINED IN 47 USC 230.
- 3 (C) "NEWS AND EDITORIAL CONTENT" MEANS ANY CONTENT OTHER THAN
- 4 ADVERTISING.
- 5 (D) "NOTICE" INCLUDES AN ORDER, ORDINANCE, ADVERTISEMENT,
- 6 REPORT, AND ANY OTHER STATEMENT OR INFORMATION REQUIRED BY STATUTE
- 7 TO BE PUBLISHED.
- 8 (E) "REQUIRED AREA" MEANS THE COUNTY, TOWNSHIP, CITY, VILLAGE,
- 9 DISTRICT, OR OTHER GEOGRAPHIC TERRITORY WHERE THE STATUTE REQUIRES
- 10 THE NOTICE TO BE PUBLISHED OR THE NEWSPAPER TO BE PUBLISHED,
- 11 CIRCULATED, OR PRINTED.
- 12 (F) "WEBSITE" MEANS A COLLECTION OF PAGES OF THE INTERNET,
- 13 USUALLY IN HTML FORMAT, WITH CLICKABLE OR HYPERTEXT LINKS TO ENABLE
- 14 NAVIGATION FROM 1 PAGE OR SECTION TO ANOTHER, THAT OFTEN USES
- 15 ASSOCIATED GRAPHICS FILES TO PROVIDE ILLUSTRATION AND MAY CONTAIN
- 16 OTHER CLICKABLE OR HYPERTEXT LINKS.
- 17 Enacting section 1. This amendatory act does not take effect
- 18 unless Senate Bill No. or House Bill No. 5826 (request no.
- 19 03209'09) of the 95th Legislature is enacted into law.
