

# SENATE BILL No. 148

January 29, 2009, Introduced by Senators PAPPAGEORGE, BROWN, SANBORN, BIRKHOLZ, JANSEN, GARCIA, RICHARDVILLE, KAHN, VAN WOERKOM, KUIPERS, CROUSEY, PATTERSON, GEORGE, HARDIMAN, GILBERT, ALLEN, BASHAM, BISHOP, OLSHOVE, GLEASON, STAMAS, JELINEK, BARCIA and McMANUS and referred to the Committee on Health Policy.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16d of chapter XVII (MCL 777.16d), as amended by 2005 PA 336.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

**CHAPTER XVII**

Sec. 16d. This chapter applies to the following felonies enumerated in chapter 750 of the Michigan Compiled Laws:
