It's a commitment that is concisely expressed in its mission statement: "The Michigan Credit Union League will strengthen the credit union community and its image by providing advocacy on important issues, coordinating cooperative initiatives and by providing high-quality solutions that help credit unions succeed and enrich the lives of their members"; now, therefore, be it

- 1. Amend page 2, line 14, after "of" by striking out "live and simulcast" and inserting "HORSE".
- 2. Amend page 2, line 17, after "penalties;" by inserting "TO DECLARE THE EFFECT OF THIS ACT;".
- 3. Amend page 6, line 4, after "TAXES." by inserting "PARI-MUTUEL, PARI-MUTUEL GAMING ACTIVITIES, AND PARI-MUTUEL WAGERING ALLOWED UNDER THIS ACT ARE LIMITED TO WAGERING ON THE RESULTS OF HORSE RACES, BUT INCLUDE ALL TECHNOLOGY AND INNOVATIONS RELATED TO HORSE RACES AND WAGERING ON THE RESULTS OF HORSE RACES THAT MAY EXIST NOW OR IN THE FUTURE.".
 - 4. Amend page 6, line 12, after "432.47" by inserting a comma and "OR ANY OTHER LAW OF THIS STATE".
 - 5. Amend page 74, following line 12, by inserting:

"Enacting section 2. Subdivision (p) of section 2 of the horse racing law of 1995, 1995 PA 279, MCL 431.302, as added by this amendatory act, is curative, shall be applied retroactively, and is intended to correct any misinterpretation concerning the original intent of the legislature to allow all pari-mutuel wagering on the results of horse races to occur under this act subject to the regulatory authority of the racing commissioner without respect to whether the pari-mutuel wagering on the results of horse races or technology for pari-mutuel wagering on the results of horse races occurred or existed on a specific date."

- 5. Amend page 41, line 27, after "IS" by inserting "DETERMINED BY THE RACING COMMISSIONER NOT TO BE EXCESSIVE IN COMPARISON TO THE AMOUNT OF MONEY EXPECTED TO BE WAGERED ON THE RACE AND IS".
 - 6. Amend page 46, line 20, after "THIS" by striking out "SECTION" and inserting "SUBSECTION".

 - (a) The term of the assistance.
 - (b) The maximum principal amount of the assistance.
 - (c) The maximum rate of interest or method of calculation of the rate of interest that will be used, or the premium charged.
- (2) The order of approval under subsection (1) shall incorporate all requirements, provisions, or information included in the application and other documents submitted to the department during the application process.
- (3) THE DEPARTMENT SHALL NOT PROHIBIT A WATER SUPPLIER FROM USING ASSISTANCE FOR A PROJECT TO MEET MATCH REQUIREMENTS FOR FEDERAL LOANS OR GRANTS FOR THAT PROJECT.
- (4) (3) After issuance of the order of approval under subsection (1), the department shall certify to the authority that the water supplier is eligible to receive assistance."
