Comments and Recommendations

Rep. Stamas moved that the following remarks be printed in the Journal. The motion prevailed.

Rep. Knollenberg:

"Thank you Mr. Speaker and members of the House of Representatives for the opportunity to share my farewell speech. While it seems like just yesterday that I was first elected, it also seems like I've been doing this forever as well.

As I leave the legislature, it is with a great deal of gratitude that I share my perspective of what this opportunity to serve means to me.

The best way to do this is to share some of my experiences during my time here.

Most interesting experience certainly was the 2007 budget showdown tops the list. Let me explain. Number one: who would have thought a legislator that was in Russia for ten days of the shutdown would easily win reelection and go on to earn the respect of conservatives and tea partiers and become national committeeman? For the record the Speaker of the House told him that the budget would be done by then. (I doubt that anyone has or will plan a trip in that fashion after that unpredictable event). Number two- Sleeping bags: Yes, Sleeping bags were rolled into the Capitol and members were catnapping in the House chambers. Most of us were spared newspaper footage but some members were not so fortunate and I felt for them. It could have been anyone of us. You third termers know what I mean. Number three- Session interfering with a Sunday morning fundraiser? Yes it is true. I agreed to host a fundraiser at my home for three local council candidates. This fundraiser was a Sunday morning brunch and we were given permission to leave the Capitol after being sequestered for several days and were told that we had to be back in about six hours. This gave me enough time to go home, work out for 30 minutes, shower, grab several days of clothes, say hello to the guests for about 5 minutes and drive back to Lansing in time for another sequestering episode. God bless Lori for being a trooper since she put the house together and had to host the event in my absence and we weren't yet married.

How to Lobby- Two things: First thing- Lobbyist's giving Sergeants pieces of paper asking us to go out to the hallway to be lobbied. First time this happened to me it reminded me of grade school when the principal wanted me out of the classroom and this wasn't usually good thing. Second thing- Lobbyist approaches me in my third term and wants to get to know me (seems a little late for that) and oh by the way he wants me to back off on my bill that just passed out of committee which is on the fast track. This is not the best way to lobby.

Most interesting quote- First termer Coleman Young Jr. during 2007 debate on graduated income tax expressing to the house chamber that and I'm paraphrasing 'What's the big deal, none of my people are going to pay it and we should just pass it.' The room burst out laughing. He was definitely voting his district.

Minority vs. Majority- I started my 1st term in the minority and became a part of the majority party finally in my 3rd term. I have to say that being in the minority really isn't all that fun. Those of you that have been there know what I mean. I didn't know how bad it was when instead of being called 'Representative' for my first four years I was now being called 'Mr. Chairman'. This was definitely an eye opener.

On a serious note, I share these experiences because these are memories that we all relate to. Having said that though, none of it really matters. These are our experiences and our memories which are limited to inside the Lansing beltway.

The only thing that matters are the people that elected us. I am grateful to the Troy and Clawson citizens of the 41st district. I have tried to represent them and their interests. I truly believe that with almost 10 million people in our state we also have 10 million different opinions and I've tried to balance all of that and represent the 41st district the best that I know how. It has truly been an honor to represent and serve them. And I thank them.

There are a number of people that I need to thank:

- I start with my wife, Lori. We met over seven years ago and she wasn't aware that I had filed to run for State Representative. I had filed about a month before meeting her. It wasn't until about four months of dating that I told her that I was running and that campaigns are brutal and that this relationship may not last. She didn't like the sound of that and was determined to stick it out and prove me wrong. You all know what I mean. It is a hard process for loved ones and family. We got married three years later and she has been very supportive of my service. I thank her and I love her.
- I also need to thank my parents Joe and Sandie Knollenberg who have been there for me and provided the mentoring, the integrity, the diplomacy, and the inspiration to serve. They are great role models. In addition I want to also thank my brother Steve for his support.
- I also need to thank all the policy, communications, legislative staff for the expertise on the issues and making sure that I was prepared with special thanks to Tim Lee, Mike Webber, Dominick Pallone and Joelle Demand.
- I also want to thank Mark Meadows and Ed Clemente for their fairness when they were Chairman of committees that I served on and for their respect to the minority members.
- I also want to acknowledge my good friend, Chet Zarko, who passed away while serving as my legislative aide. I have missed him and know that he is above looking down on all of us.

We've come a long way since 2007. I believe Michigan is in a better place. Budget is solid, unemployment is lower, incomes are higher, we have more capital investments and there is more hope for a brighter future. We still have a long way to go and I hope that the next legislature continues in that fashion.

Again, I thank you all for the opportunity to give my farewell and to thank my constituents. God Bless."

EXECUTIVE ORDER No. 2012 - 17

MICHIGAN DOMESTIC AND SEXUAL VIOLENCE PREVENTION AND TREATMENT BOARD

MICHIGAN DOMESTIC VIOLENCE PREVENTION AND TREATMENT BOARD

WHEREAS, Section 1 of Article V of the Michigan Constitution of 1963 vests the executive power of the state of Michigan in the Governor; and

WHEREAS, the Violence Against Women ("Violence Against Women Act") and the Department of Justice Reauthorization Act of 2005, PL 109-162, January 5, 2006, 119 Stat 2960, provide federal dollars to address domestic and sexual violence: and

WHEREAS, the Violence Against Women Act addresses both domestic violence and sexual violence; and

WHEREAS, Congress enacted 42 USC 14043g, the Violence Against Women Act Sexual Assault Services Program grant to assist in providing intervention, advocacy, accompaniment, support services, and assistance to victims of sexual assault: and

WHEREAS, Act 389 of 1978, MCL 400.1501 to MCL 400.1511, established the Domestic Violence Prevention and Treatment Board; and

WHEREAS, the Michigan Domestic Violence Prevention and Treatment Board is the designated agency to administer and monitor grants under the Violence against Women Act Sexual Assault Services Program which supports nonprofit, nongovernmental sexual assault service provider organizations; and

WHEREAS, the goals and functions of the Domestic Violence Prevention and Treatment Board affect both domestic violence and sexual violence prevention and treatment; and

WHEREAS, the Michigan Domestic Violence Prevention and Treatment Board provides sexual assault funding to Sexual Assault Centers in Michigan; and

WHEREAS, MCL 400.1531 to 400.1535 delegated responsibility to the Michigan Domestic Violence Prevention and Treatment Board to expend money from the Sexual Assault Victims' Medical Forensic Intervention and Treatment Fund; and WHEREAS, MCL 722.1041 to 722.1044 delegated responsibility to the Michigan Domestic Violence Prevention and Treatment Board to expend money from the Children's Advocacy Center Fund; and

WHEREAS, incorporating sexual abuse prevention and treatment into the Domestic Violence Prevention and Treatment Board will lead to more effective outcomes and greater administrative efficiency for domestic violence and sexual abuse victims:

NOW, THEREFORE, I, Richard D. Snyder, Governor of the state of Michigan, by virtue of the power and authority vested in the Governor by the Michigan Constitution of 1963, and the laws of the state of Michigan, order the following:

I. CREATION OF THE MICHIGAN DOMESTIC AND SEXUAL VIOLENCE PREVENTION AND TREAT-MENT BOARD

A. The Michigan Domestic and Sexual Violence Prevention and Treatment Board ("Board") is created within the Department of Human Services ("Department"). The Director of the Department shall provide appropriate staff support for the Board, subject to available funding.

B. All of the authority, powers, duties, functions, and responsibilities of the Michigan Domestic Violence Prevention and Treatment Board established by Act 389 of 1978, MCL 400.1501 to MCL 400.1511 shall be transferred to the Michigan Domestic and Sexual Violence and Prevention Treatment Board created under Section I. A. of this Order. All records, personnel, property and unexpended balances of appropriations of the Michigan Domestic Violence Prevention and Treatment Board are transferred to the Michigan Domestic and Sexual Violence Prevention and Treatment Board.

C. The Michigan Domestic Violence Prevention and Treatment Board is abolished.

II. BOARD MEMBERSHIP

A. The Governor shall appoint a Michigan Domestic and Sexual Violence Prevention and Treatment Board consisting of seven (7) members, all of whom shall have experience in an area related to the problems of domestic violence and/or sexual violence. The members shall be appointed by the Governor with the advice and consent of the senate. The term of office of a member shall be three (3) years, except that of the members first appointed, two (2) shall serve for a term of one (1) year, two (2) shall serve for a term of two (2) years and three (3) shall serve for a term of three (3) years.

- B. The Governor shall designate one member of the board to serve as chairperson. A majority of the members shall constitute a quorum.
- C. A vacancy on the Board shall be filled in the same manner as the original appointment. A member appointed to fill a vacancy occurring other than by expiration of a term shall be appointed for the remainder of the unexpired term.
 - D. The legislature shall establish per diem compensation and the schedule for reimbursement of expenses.

III. CHARGE TO THE BOARD

The Board shall do all of the following:

- 1. Coordinate and monitor programs and services funded under Act 389 of 1978, MCL 400.1501 to MCL 400.1511 or otherwise supported by funds expended by the board for the prevention of domestic and sexual violence and the treatment of victims of domestic and sexual violence.
- 2. Develop standards for the implementation and administration of services and procedures to prevent domestic and sexual violence, and to provide services and programs for victims of domestic and sexual violence.
- 3. Provide planning and technical assistance to prime sponsors for the development, implementation, and administration of programs and services for the prevention of domestic and sexual violence, and the treatment of victims of domestic and sexual violence.
- 4. Conduct research to develop and implement effective means for preventing domestic and sexual violence and treating victims of domestic and sexual violence.
- 5. Provide assistance to the Department of State Police in developing a system for monitoring and maintaining a uniform reporting system to provide accurate statistical data on domestic and sexual violence.

- 6. Coordinate educational and public informational programs for the purpose of developing appropriate public awareness regarding the problems of domestic and sexual violence; encourage professional persons and groups to recognize and deal with problems of domestic and sexual violence; to make information about the problems of domestic and sexual violence available to the public, organizations, and agencies that deal with problems of domestic and sexual violence; encourage the development of community programs to prevent domestic and sexual violence; and provide services to victims of domestic and sexual violence.
- 7. Study and recommend changes in civil and criminal laws and procedures that will enable victims of domestic and sexual violence to receive equitable and fair treatment under the law.
- 8. Advise the legislature and Governor on the nature, magnitude, and priorities of the problem of domestic and sexual violence, the needs of victims of domestic and sexual violence, and recommend appropriate changes in state laws and programs related to domestic and sexual violence.
- 9. Develop policies, budgets, and standards that will reduce the problem of domestic and sexual violence and improve the condition of victims.
- 10. Administer grants awarded pursuant to the Violence Against Women Act, the Family Violence Prevention and Services Act, and other governmental or non-governmental grants.

IV. MISCELLANEOUS

- A. This Order shall not abate any suit, action, or other proceeding lawfully commenced by, against, or before any entity affected under this Order. Any suit, action, or proceeding may be maintained by, against, or before the appropriate successor of any entity affected under this Order.
- B. The invalidity of any portion of this Order shall not affect the validity of the remainder of the Order, which may be given effect without any invalid portion. Any portion of this Order found invalid by a court or other entity with proper jurisdiction shall be severable from the remaining portions of this order.

The motion did not prevail and the amendment was not adopted, a majority of the members serving not voting therefor. Rep. Lane moved that the bill be placed on the order of Third Reading of Bills.

A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 963, 968, 969, 972, and 975 (MCL 168.963, 168.968, 168.969, 168.972, and 168.975), section 963 as amended by 2005 PA 71, section 968 as amended

by 1989 PA 26, and section 972 as amended by 2004 PA 298, and by adding sections 971a and 973a; and to repeal acts and parts of acts.

A bill to amend 1990 PA 100, entitled "An act to permit the imposition, revival, and continued collection by certain cities of a utility users tax; to provide the procedure for, and to require the adoption of a prescribed uniform city utility users tax ordinance by cities desiring to impose and collect such a tax; to limit the rate of such tax; to prescribe the powers and duties of the department of treasury; and to provide for appeals," by amending section 2 of chapter 1 (MCL 141.1152), as amended by 2011 PA 57, and by adding sections 8a and 8b to chapter 1.

Senate Bill No. 1020, entitled

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 81101, 81115, 81122, 81129, 81131, and 81133 (MCL 324.81101, 324.81115, 324.81122, 324.81129, 324.81131, and 324.81133), section 81101 as amended by 2012 PA 246, sections 81115 and 81129 as amended by 2008 PA 240, section 81122 as added by 1995 PA 58, section 81131 as amended by 2011 PA 107, and section 81133 as amended by 2012 PA 340; and to repeal acts and parts of acts.

The Senate has passed the bill.

The bill was read a first time by its title and referred to the Committee on Natural Resources, Tourism, and Outdoor Recreation.
