# Protest

Senator Whitmer, under her constitutional right of protest (Art. 4, Sec. 18), protested against the passage of Senate Bill No. 472 and moved that the statement she made during the discussion of the bill be printed as her reasons for voting "no."

As we take up Senate Bill No. 472, I think that it bears your attention to look at what the Senate Fiscal Agency said about this particular bill. It says that farmland and open space preservation sounds like a good idea. With any legislation that comes through this body, we should be asking ourselves two questions. No. 1, how does this help jobs in Michigan? No. 2, what does this do for education?

Now, I don't see anything that says that this is a net job growth public policy, but I do see that it says this bill would reduce School Aid Fund revenues by an unknown amount. I cannot in good conscience vote for legislation that will continue to hurt our kids' schools and the future of Michigan, and that, accordingly, is my "no" vote explanation.

# Senate Concurrent Resolution No. 10.

A concurrent resolution to approve a certain designated open space land application for property in Midland County. The question being on the adoption of the concurrent resolution,

The concurrent resolution was adopted, a majority of the members serving voting therefor.

#### Senate Resolution No. 57.

A resolution to memorialize the President and the United States Congress to support the continued and increased importation of oil derived from Canadian oil sands and to urge the United States Secretary of State to approve the TransCanada Keystone Coast Expansion pipeline project.

The question being on the adoption of the resolution,

The resolution was adopted.

#### **Protest**

Senator Young, under his constitutional right of protest (Art. 4, Sec. 18), protested against the adoption of Senate Resolution No. 57 and moved that the statement he made during the discussion of the resolution be printed as his reasons for voting "no."

The motion prevailed.

Senator Young's statement is as follows:

I would like to begin with a quote from George H.W. Bush: "Use power to help people. For we are given power not to advance our own purpose nor to make a great show in the world, nor a name. There is but one just use of power and it is to serve people." I rise to offer my "no" vote explanation. This resolution which urges Congress and the President to approve construction of the Keystone XL oil pipeline is bad for Michigan and bad for the United States.

I am sure that the sponsor of this legislation will tell us that increasing access to Canadian oil sands will increase gas prices at the pump. After all, that is the corporate line being used to convince American consumers that this pipeline is a good deal. Unfortunately, the company's own report shows that to be untrue. In documents filed by TransCanada Keystone Pipeline with the Canadian government, the company's own market analysis explained that because of limited transportation options, the majority of Canadian-sent oil is currently re-routed to refineries here in the Midwest. This has created an oversupply and helps to drive down gas prices here in Michigan and throughout the Midwest.

TransCanada has indicated that by building the Keystone XL Pipeline expansion, it will be easier to deliver Canadian oil directly to Texas refineries and ultimately onto China, bypassing the Midwest market completely and lowering the supply of oil for those of us here in Michigan. The end result for Michigan drivers, according to the company, is an increase in the price of gas around 15 cents per gallon. I say again, if the Keystone XL Pipeline is built, the company freely admits it will raise the price of gas here in the Midwest by 15 cents per gallon.

I almost paid more than \$50 today for gas. I can't take it. I don't want another price increase on gasoline. We can't have that. It is absurd. It is appalling.

If, however, my colleagues would rather ignore the cost increase to Michigan motorists, let's look at the significant environmental costs this project has. Does it trouble the resolution sponsor that completed portions of the Keystone XL Pipeline have already had 12 major spills in recent years or that the pipeline crosses most of the major rivers in America's breadbasket? Or how about the fact that the pipeline will be built on the Ogallala Aquifer which supplies 30 percent of the nation's groundwater used for irrigation? What happens if this water supply gets contaminated? Are we willing to risk the health and safety of this country in order to satisfy the desires of a corporation?

In short, this resolution won't create a single job in Michigan, will raise gas prices for Michigan drivers, and will create significant environmental risks for the nation's water supply. Let's stand and call it what it is—a raw deal for the people of Michigan. They deserve better than this.

Senator Pappageorge offered the following resolution:

Whereas, The Legislature recognizes that understanding American history and America's First Principles are indispensable to the survival of our republic as a free people. In great reverence to the victims of the September 11, 2001, attacks, the Legislature acknowledges that American citizens must take time to honor the First Principles, founders, documents, and symbols of their history; and

Whereas, The events that led to the signing of *The Constitution of the United States of America* by the delegates of the Constitutional Convention on September 17, 1787, have significance for every American and are honored in public schools across the nation on September 17 of each year as Constitution Day; and

Whereas, Revolution, the rule of law, social compact, equality, unalienable rights, and limited government are the First Principles upon which America was founded and flourishes; and

Whereas, Exceptional, visionary, and indispensable Americans such as Thomas Paine, Patrick Henry, John Adams, John Marshall, George Washington, Abraham Lincoln, Frederick Douglass, Martin Luther King, Jr., Elizabeth Cady Stanton, Susan B. Anthony, Thomas Jefferson, and James Madison founded and advanced the United States; and

Whereas, The Bennington Flag, the original Betsy Ross American flag, the current American Flag, the Suffragist Flag, the Fort Sumter Flag, the Gadsden Flag, and the flag of the state of Michigan are fundamental physical symbols of American history and freedom that should be studied and remembered by each American citizen; now, therefore, be it

Resolved by the Senate, That we hereby designate September 11-17, 2011, as Michigan Patriot Week, which symbolically begins on September 11 and concludes on September 17, Constitution Day. We recognize that each generation needs to renew the spirit of America based on America's First Principles, historical figures, founding documents, and symbols of America. The citizens, schools and other educational institutions, government agencies, municipalities, and nonprofit, religious, labor, community, and business organizations are urged to recognize and participate in Patriot Week by honoring and celebrating so that all may offer the reverence that is due to our free republic; and be it further

Resolved, That copies of this resolution be transmitted to the Michigan Council for Social Studies, Michigan Center for Civic Education, State Board of Education, Michigan public and nonpublic schools, State Bar of Michigan, Oakland County Bar Association, Oakland County Circuit Court, Senate Majority Leader Randy Richardville, Speaker of the House Jase Bolger, and Governor Rick Snyder.
