Each one of us stands here today with names, faces, and stories that have become part of us—stories that speak of human suffering, injustice, and corruption, as well as incredible courage, sacrifice, and generosity; faces that personalize for us the plight of the unemployed and the underemployed, the elderly, the disabled, and those trapped in generational cycles of poverty; names that call us to bring our best thinking, our most rigorous compassion, and our most courageous answers to the searching questions of struggling school districts, blighted cities, and polluted resources to the raw hopes of entrepreneurs and small business owners who dare to dream; and the anxious conversations about how unions and managers work together.

Lord, for these names, faces, and stories, we ask that the governance of this body would indeed be life-giving, nourishing, and fruitful. We give thanks to You also for the life-giving, fruit-bearing work that has begun this week in the schools across this state. We pray for teachers, students, and administrators as they give themselves anew to the work of education. We ask that You would add to that work in such a way that education would mature into wisdom and wisdom would birth responsibility and responsibility would intensify until it is a passionate calling and vision that grips the hearts and minds of the next generation of leaders who are seated behind school desks.

Lord, as the members of this government face all of these challenges, joys, and hopes, I ask that You protect them from becoming overwhelmed on the one hand and from sliding into self-interest on the other. Rather, we all would seek Your face and the flourishing of our shared humanity. Amen.
