9. Amend page 17, line 25, after "is" by striking out "\$96,859,100.00" and inserting "\$96,834,100.00".

- 10. Amend page 19, line 11, after "least" by striking out "15.0%" and inserting "10.0%".
- 11. Amend page 20, line 5, after "treatment" by inserting "program".
- 12. Amend page 20, line 24, by striking out all of section 271 and inserting:

"Sec. 271. (1) From the amount appropriated in part 1 for office of great start operations, there is allocated \$75,000.00 to the department to contract for a report that updates the information and data in the previously completed analysis published by the W.K. Kellogg Foundation entitled "Building a Sustainable Future - Analysis of the Fiscal Resources Supporting Children from Birth Through Age 8 in Michigan."

- (2) The report identified in (1) shall include at least the following:
- (a) Each source and amount of early childhood funding.
- (b) The agency responsible for distributing the funding identified in subdivision (a).
- (c) The recipients of each type of funding identified in subdivision (a).
- (d) For each recipient identified in (c), the dollar amount and percentage of funding spent for administrative purposes.
- (e) A fiscal map of federal, state, and private expenditures on programs and services for children, from birth through age 8 and their families.
- (f) An analysis of the effectiveness of early childhood funding, highlighting the diversification and adequacy of existing funding, the stability and flexibility of available programs and funding sources, and the coordination of funding from multiple public and private sources.
- (3) The updated information and data shall be included in a report to the legislature along with any related recommendations the department may have to ensure children are developmentally ready to succeed in school at the time of school entry.
- (4) The report shall be completed not later than May 15, 2012 and, upon completion, the report shall be transmitted to the state budget director, the chairpersons of the senate and house of representatives committees on appropriations and the appropriations subcommittees responsible for the department of education budget, and the senate and house fiscal agencies."
- 13. Amend page 21, line 25, by striking out all of section 303 and inserting:
- "Sec. 303. (1) If private funds become available, the department shall enter into a contract with a state university or outside research entity to conduct a behavioral health study of juvenile justice facilities operated or contracted for by the state. The study shall utilize diagnostic clinical interviews with and records reviews for a representative random sample of juvenile justice system detainees to develop a report on each of the following:
- (a) The proportion of juvenile justice detainees with a primary diagnosis of emotional disorder, the percentage of those detainees considered to currently require mental health treatment, and the proportion of those detainees currently receiving mental health services, including a description and breakdown, encompassing, at a minimum, the categories of inpatient, residential, and outpatient care, of the type of mental health services provided to those detainees.

- (b) The proportion of juvenile justice detainees with a primary diagnosis of addiction disorder, the percentage of those detainees considered to currently require substance abuse treatment, and the proportion of those detainees currently receiving substance abuse services, including a description and breakdown, encompassing, at a minimum, the categories of residential and outpatient care, of the type of substance abuse services provided to those detainees.
- (c) The proportion of juvenile justice detainees with a dual diagnosis of emotional disorder and addiction disorder, the percentage of those detainees considered to currently require treatment for their condition, and the proportion of those detainees currently receiving that treatment, including a description and breakdown, encompassing, at a minimum, the categories of mental health inpatient, mental health residential, mental health outpatient, substance abuse residential, and substance abuse outpatient, of the type of treatment provided to those detainees.
- (d) Data indicating whether juvenile justice detainees with a primary diagnosis of emotional disorder, a primary diagnosis of addiction disorder, and a dual diagnosis of emotional disorder and addiction disorder were previously hospitalized in a state psychiatric hospital for persons with mental illness. These data shall be broken down according to each of these 3 respective categories.
- (e) Data indicating whether and with what frequency juvenile justice detainees with a primary diagnosis of emotional disorder, a primary diagnosis of addiction disorder, and a dual diagnosis of emotional disorder and addiction disorder have been detained previously. These data shall be broken down according to each of these 3 respective categories.
- (f) Data classifying the types of offenses historically committed by juvenile justice detainees with a primary diagnosis of emotional disorder, a primary diagnosis of addiction disorder, and a dual diagnosis of emotional disorder and addiction disorder. These data shall be broken down according to each of these 3 respective categories.
- (g) Data indicating whether juvenile justice detainees have previously received services managed by a community mental health program or substance abuse coordinating agency. These data shall be broken down according to the respective categories of detainees with a primary diagnosis of emotional disorder, a primary diagnosis of addiction disorder, and a dual diagnosis of emotional disorder and addiction disorder.
- (2) The report referenced under subsection (1) would be provided not later than June 30 of the current fiscal year to the senate and house appropriations subcommittees on human services, the senate and house fiscal agencies and policy offices, and the state budget director."
- 14. Amend page 24, following line 16, by inserting:

#### "DEPARTMENT OF TRANSPORTATION

Sec. 371. The funds appropriated in part 1 for welcome center operations shall be used first to maintain a minimum of 8 hours of operation, seven days per week, at the Mackinaw City, St. Ignace, and Sault Ste. Marie welcome centers. Any remaining funds shall be distributed equally among the remaining welcome centers across the state.".

#### **Statements**

Senator Young asked and was granted unanimous consent to make a statement and moved that the statement be printed in the Journal.

Senator Young's statement is as follows:

I would like to start with a quote: "Every civilization rests on a set of promises; if the promises are broken too often, the civilization dies, no matter how rich it may be, or how mechanically clever. Hope and faith depend on the promises; if hope and faith go, everything goes." —Herbert Agar.

I rise today because of a deal that took place in 1999 with then-Governor Engler and the Detroit delegation involved in revenue sharing. They basically said that all revenue sharing payments would be frozen, and they would not cut them, but they would cut other areas in this great state of Michigan—other cities, townships, and municipalities—but they would hold Detroit harmless. Then the state decided to go back on the promise. As a result, the citizens of Detroit feel that is not only injustice, but they believe it is fiscal terrorism.

Citizens in Detroit seek economic elevation and restoration. They believe the city's coffers have been pillaged, prodded, and as a result, they have inadequate living conditions. We will not thrive and have shared prosperity as a state if we continue to treat the state's economic engine, the epicenter of prosperity—the city of Detroit—in this fashion. It is reflected in a lack of police service. It is reflected when you have little girls who are burned alive in buildings because the fire department shows up and the water pumps don't work in the truck. It is reflected in the fact that buses cannot properly operate, and as a result, you have women and children waiting for two or three hours in the cold and dark to catch a bus. You have people who are having their jobs and their ability to provide for their families taken away from them because they do not have the finances necessary to operate the city.

I think that there are only a couple of times in our lives that we are able to truly blaze a trail; we are able to set a dawn of a new era; we are able to right the wrongs and ills of injustice that our citizens face. This is that time. We must grab that scepter of fairness. We must come together and close the gap between the promise and the reality of the city of Detroit by restoring the finances and honoring the promise that we made to the citizens. As I always say, nobody cares how much you know. It's how much you care. It is time to show the citizens of Detroit that we care by paying back the revenue that is owed to them.
