Senate Concurrent Resolution No. 37.

A concurrent resolution of tribute offered as a memorial for Philip O. Mastin, Jr., former member of the House of Representatives and the Senate.

Whereas, The members of the Michigan Legislature were saddened to learn of the passing of former State Senator and Representative Phil Mastin. A dedicated public servant, he will be remembered for his courage to stand by his convictions and make difficult decisions for the good of our state; and

Whereas, A graduate of Hazel Park High School, Phil Mastin would go on to a long and distinguished career in private and public service. For fifteen years, he worked as an automotive designer for Ford and General Motors. During the 1960s, he began his career in public service, serving as a Hazel Park city councilman, Oakland County supervisor and commis-

sioner, and as a leader in the Oakland County Democratic Party. In 1970, he was elected to represent the 69th District in the Michigan House of Representatives. He returned to local government for a few years as Pontiac city manager and director of the Pontiac Downtown Development Authority, prior to his election to the State Senate in 1982; and

Whereas, Phil Mastin served for seven years in the Michigan Legislature as a State Representative and a State Senator. Building on his past experience in the auto industry and local government, he served on committees dealing with labor, local government, and tax issues. In his final term in the House, he sat on the Appropriations Committee. In the Senate, he was chair of the Labor Committee. His legislative career will always be noted for his resolve and ability to do what he felt was best for the state despite potential personal ramifications; and

Whereas, Phil Mastin enjoyed a successful career and life following his legislative service. The latter part of his career was marked by his efforts to improve the training and conditions for Michigan's workers as a consultant for the National Alliance of Business, a government relations manager for the UAW-GM Human Resources Center, a founding member of the Michigan Job Training Coordinating Council, and a trustee of the Michigan Quality of Work Life Council. He would also continue his work as a member of the boards of directors for the Michigan and National Mental Health Associations. Even in retirement, he remained actively engaged as a board member of the United Way of Michigan, president of his church golf league, and a member of his condominium association's advisory committee; now, therefore, be it

Resolved by the Senate (the House of Representatives concurring), That we offer this expression of our highest tribute to honor the memory of Philip O. Mastin, Jr., a member of the House of Representatives from 1971 to 1976 and a member of the Senate in 1982; and be it further

Resolved, That copies of this resolution be transmitted to the Mastin family as evidence of our lasting esteem for his memory and contributions.

Senate Resolution No. 182.

A resolution declaring Friday, December 7, 2012, as Pearl Harbor Remembrance Day in the state of Michigan.

Whereas, On the morning of December 7, 1941, America was attacked without warning at Pearl Harbor by the air and naval forces of Imperial Japan. More than 2,400 people perished and another 1,100 were wounded, triggering our nation's entry into World War II; and

Whereas, On December 7, 2012, we honor those who lost their lives and all veterans who have fought to preserve our freedom and democracy; and

Whereas, Today, we also recognize the citizens of Michigan who answered their country's call to the battlefield, the factory, and the farm. We remember Pearl Harbor through their deeds, their devotion to duty, and their willingness to fight for freedom; and

Whereas, The attack at Pearl Harbor ignited the American spirit with a determination that freedom would not fall. The tragedy of December 7, 1941, remains upon the memories of the citizens of the state of Michigan, as well as our great nation. May this recollection serve not just as a symbol of American valor, but also as the resolve of all Americans in preserving freedom; now, therefore, be it

Resolved by the Senate, That the members of this legislative body declare Friday, December 7, 2012, as Pearl Harbor Remembrance Day in the state of Michigan. We urge the people of Michigan to acknowledge the importance of this day.

of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of transportation needs within the state; to authorize the state transportation commission, counties, cities, and villages to borrow money, issue bonds, and make pledges of funds for transportation purposes; to authorize counties to advance funds for the payment of deficiencies necessary for the payment of bonds issued under this act; to provide for the limitations, payment, retirement, and security of the bonds and pledges; to provide for appropriations and tax levies by counties and townships for county roads; to authorize contributions by townships for county roads; to provide for the establishment and administration of the state trunk line fund, local bridge fund, comprehensive transportation fund, and certain other funds; to provide for the deposits in the state trunk line fund, critical bridge fund, comprehensive transportation fund, and certain other funds of money raised by specific taxes and fees; to provide for definitions of public transportation functions and criteria; to define the purposes for which Michigan transportation funds may be allocated; to provide for Michigan transportation fund grants; to provide for review and approval of transportation programs; to provide for submission of annual legislative requests and reports; to provide for the establishment and functions of certain advisory entities; to provide for conditions for grants; to provide for the issuance of bonds and notes for transportation purposes; to provide for the powers and duties of certain state and local agencies and officials; to provide for the making of loans for transportation purposes by the state transportation department and for the receipt and repayment by local units and agencies of those loans from certain specified sources; and to repeal acts and parts of acts," by amending sections 10b, 10c, 10d, 10e, 10h, 10l, and 10n (MCL 247.660b, 247.660c, 247.660d, 247.660e, 247.660h, 247.660l, and 247.660n, section 10b as amended by 1982 PA 438, section 10c as amended by 2010 PA 257, section 10e as amended by 2008 PA 487, section 10h as amended by 2002 PA 498, section 10l as amended by 1987 PA 234, and section 10n as amended by 2002 PA 329.
