### OVERVIEW

The Executive recommended supplemental for Michigan Natural Resources Trust Fund (MNRTF) acquisition and development projects totals \$39,665,200. These projects were recommended by the Natural Resources Trust Fund Board and will be funded with state restricted revenue from the Michigan Natural Resources Trust Fund. The supplemental request for the Department of Natural Resources (DNR) has a net impact of \$0 on appropriations and consists of several fund source shifts involving federal funding and the Michigan State Waterways Fund. These adjustments are intended to help ensure that available federal funding is utilized by the state and make additional Michigan State Waterways funding available for capital outlay boating access projects.

### FY 2011-12 Appropriation Items:

#### CAPITAL OUTLAY

##### 1. Michigan Natural Resources Trust Fund

**Executive** and **House** include \$39.7 million for 22 land acquisition projects and 77 land development projects supported with revenues from the Michigan Natural Resources Trust Fund.

**Senate** includes \$35.3 million for 18 land acquisition projects and 77 land development projects. **Senate** eliminates funding for four eco-region land consolidation projects (items 17, 19, 20, and 21 on pages 4 and 5).

**Conference** includes \$37.8 million for 22 land acquisition projects and 77 land development projects. The conference report contains \$100 appropriations for the Upper Peninsula and Northern Lower Peninsula Eco-Regional Land Consolidation projects (items 17 and 21 on pages 4 and 5).

The MNRTF provides financial assistance to local units of government and to the Department of Natural Resources for the purchase of lands for outdoor recreation, for protection of natural resources and open space, and for development of land for public outdoor recreation. The MNRTF is supported with revenues from state-owned oil and gas mineral resources. These projects were approved by the MNRTF Board on December 7, 2011. (1/31/12 SBO letter)

Replaces \$4.0 million of restricted funding with the same amount of federal funding to help fund the operations and maintenance of boating access site activities within the Recreational Boating line item. The DNR received permission from the U.S. Fish and Wildlife Service to use Dingell-Johnson federal funds for operations and maintenance of these sites for FY 2011-12. (1/31/12 SBO letter)

**3. Capital Outlay Boating: South Higgins Lake - Fund Source Shift**

Eliminates \$750,000 of federal funding for this 2012 project and increases state restricted funding by the same amount. This change would eliminate all federal funding for the project and increase funding from the State Waterways Fund from \$250,000 to \$1.0 million. (1/31/12 SBO letter)
