- 19 Sec. 205. Unless otherwise specified, the departments shall

- 12 (d) The number of active department employees by job
- 13 classification.
- 14 (e) Job specifications and wage rates.
- 15 (2) The department may develop and operate its own website to
- 16 provide this information or may reference the state's central
- 17 transparency website as the source for this information.
- 18 Sec. 208. The department shall require all public school
- 19 districts to maintain complete records within the personnel file of
- 20 a teacher or school employee of any disciplinary actions taken by
- 21 the local school board against the teacher or employee for sexual
- 22 misconduct. The records shall not be destroyed or removed from the
- 23 teacher's or employee's personnel file except as required by a
- 24 court order.
- Sec. 209. From the funds appropriated in part 1 for
- 26 information technology, departments and agencies shall pay user
- 27 fees to the department of technology, management, and budget for

- 1 technology-related services and projects. Such user fees shall be
- 2 subject to provisions of an interagency agreement between the

- 7 for law enforcement purposes.

- 12 increase state revenues, including protecting existing federal
- 13 funds or securing additional federal funds.
- 14 (d) The travel is necessary to comply with federal
- 15 requirements.
- 16 (e) The travel is necessary to secure specialized training for
- 17 staff that is not available within this state.
- 18 (f) The travel is financed entirely by federal or nonstate
- 19 funds.
- 20 (2) Not later than January 1 of each year, each department
- 21 shall prepare a travel report listing all travel by classified and
- 22 unclassified employees outside this state in the immediately
- 23 preceding fiscal year that was funded in whole or in part with
- 24 funds appropriated in the department's budget. The report shall be
- 25 submitted to the house and senate standing committees on
- 26 appropriations, the house and senate fiscal agencies, and the state
- 27 budget director. The report shall include the following

- 1 information:
- 2 (a) The name of each person receiving reimbursement for travel
- 3 outside this state or whose travel costs were paid by this state.
- 4 (b) The destination of each travel occurrence.
- 5 (c) The dates of each travel occurrence.
- 6 (d) A brief statement of the reason for each travel
- 7 occurrence.
- 8 (e) The transportation and related costs of each travel
- 9 occurrence, including the proportion funded with state general
- 10 fund/general purpose revenues, the proportion funded with state
- 11 restricted revenues, the proportion funded with federal revenues,
- 12 and the proportion funded with other revenues.
- 13 (f) A total of all out-of-state travel funded for the
- 14 immediately preceding fiscal year.
- 15 Sec. 215. The department shall not approve the travel of more
- 16 than 1 departmental employee to a specific professional development
- 17 conference or training seminar that is located outside of this
- 18 state unless the professional development conference or training
- 19 seminar is funded by a federal or private funding source and
- 20 requires more than 1 person from a department to attend, or the
- 21 conference or training seminar includes multiple issues in which 1
- 22 employee from the department does not have expertise.
- 23 Sec. 216. The department shall not take disciplinary action
- 24 against an employee who communicates truthfully and factually with
- 25 a member of the legislature or his or her staff.
- 26 Sec. 217. The state superintendent of public instruction shall
- 27 take all reasonable steps to ensure businesses in deprived and

- 1 depressed communities compete for and perform contracts to provide
- 2 services or supplies, or both. The director shall strongly
- 3 encourage firms with which the department contracts to subcontract
- 4 with certified businesses in depressed and deprived communities for
- 5 services, supplies, or both.
- 6 Sec. 218. The department and agencies receiving appropriations
- 7 in part 1 shall receive and retain copies of all reports funded
- 8 from appropriations in part 1. Federal and state guidelines for
- 9 short-term and long-term retention of records shall be followed.
- 10 The department may electronically retain copies of reports unless
- 11 otherwise required by federal and state guidelines.
- 12 Sec. 219. (1) In addition to the funds appropriated in part 1,
- 13 there is appropriated an amount not to exceed \$5,000,000.00 for
- 14 federal contingency funds. These funds are not available for
- 15 expenditure until they have been transferred to another line item
- 16 in this act under section 393(2) of the management and budget act,

- 18 (2) In addition to the funds appropriated in part 1, there is

- 7 under section 393(2) of the management and budget act, 1984 PA 431,
- 8 MCL 18.1393.
- 9 Sec. 220. The department shall provide data requested by a
- 10 member of the legislature, his or her staff, or the house and
- 11 senate fiscal agencies in a timely manner.
- Sec. 221. Funds appropriated in part 1 shall not be used by a
- 13 principal executive department, state agency, or authority to hire
- 14 a person to provide legal services that are the responsibility of
- 15 the attorney general. This prohibition does not apply to legal
- 16 services for bonding activities and for those activities that the
- 17 attorney general authorizes.
- 18 Sec. 225. It is the intent of the legislature that not later
- 19 than 60 days after the state receives audited membership counts
- 20 from intermediate school districts, the state superintendent of
- 21 public instruction shall investigate and report to the legislature

12 MICHIGAN SCHOOLS FOR THE DEAF AND BLIND

- 13 Sec. 402. For each student enrolled at the Michigan schools
- 14 for the deaf and blind, the department shall assess the
- 15 intermediate school district of residence 100% of the cost of
- 16 operating the student's instructional program. The amount shall
- 17 exclude room and board related costs and the cost of weekend
- 18 transportation between the school and the student's home.
- 19 Sec. 404. (1) The department may assess rent or lease excess
- 20 property located on the campus of the Michigan schools for the deaf
- 21 and blind in Flint to private or publicly funded organizations.
- 22 (2) From the amount appropriated in part 1 for tenant rent,
- 23 the department may receive and expend funds from lease agreements
- 24 at the Michigan schools for the deaf and blind Flint campus that
- 25 have been negotiated with the approval of the department of
- 26 technology, management, and budget. These funds shall be used for

- 1 the operation, maintenance, and renovation expenses associated with
- 2 the leased space.
- 3 (3) From the unexpended balances of appropriations for the
- 4 Michigan schools for the deaf and blind operations, up to
- 5 \$250,000.00 of any unexpended and unencumbered funds remaining on
- 6 September 30, 2012 may be carried forward as a work project and
- 7 expended for special maintenance and repairs of facilities at the
- 8 campus of the Michigan schools for the deaf and blind in Flint. The
- 9 work shall be carried out by state employees, or by contract as
- 10 necessary, at an estimated cost of \$250,000.00. The estimated
- 11 completion date of the work is September 30, 2013.
- 12 (4) From the tenant rent appropriation for Michigan schools
- 13 for the deaf and blind operations, up to \$100,000.00 of any
- 14 unexpended and unencumbered funds remaining on September 30, 2012
- 15 may be carried forward as a work project or as restricted revenue
- 16 and expended for special maintenance and repairs of facilities at
- 17 Fay hall. The work project may be performed by state employees, or
- 18 by contract when necessary, at an estimated cost of \$100,000.00.
- 19 The estimated completion date of the work project is September 30,
- 20 2013.
- 21 Sec. 405. The department may assist the department of
- 22 community health, other departments, and local school districts to
- 23 secure reimbursement for eligible services provided in Michigan
- 24 schools from the federal Medicaid program. The department may
- 25 submit reports of direct expenses related to this effort to the
- 26 department of community health for reimbursement.
- 27 Sec. 406. (1) The Michigan schools for the deaf and blind may

- 1 promote its residential program as a possible appropriate option
- 2 for children who are deaf or hard of hearing or who are blind or
- 3 visually impaired. The Michigan schools for the deaf and blind
- 4 shall distribute information detailing its services to all
- 5 intermediate school districts in the state.
- 6 (2) Upon knowledge of or recognition by an intermediate school
- 7 district that a child in the district is deaf or hard of hearing or
- 8 blind or visually impaired, the intermediate school district shall
- 9 provide to the parents of the child the literature distributed by
- 10 the Michigan schools for the deaf and blind to intermediate school
- 11 districts under subsection (1).
- 12 (3) Parents will continue to have a choice regarding the
- 13 educational placement of their deaf or hard-of-hearing children.
- 14 Sec. 407. Revenue received by the Michigan schools for the
- 15 deaf and blind from gifts, bequests, and donations that is
- 16 unexpended at the end of the state fiscal year may be carried over
- 17 to the succeeding fiscal year and shall not revert to the general
- **18** fund.

PROFESSIONAL PREPARATION SERVICES

- 20 Sec. 501. From the funds appropriated in part 1 for
- 21 professional preparation services, the department shall maintain
- 22 the professional personnel register and certificate
- 23 revocation/felony conviction files.
- 24 Sec. 502. The department shall authorize teacher preparation
- 25 institutions to provide an alternative program by which up to 1/2
- 26 of the required student internship or student teaching credits may

- 1 be earned through substitute teaching. The department shall require
- 2 that teacher preparation institutions collaborate with school
- 3 districts to ensure that the quality of instruction provided to
- 4 student teachers is comparable to that required in a traditional
- 5 student teaching program.
- 6 Sec. 506. Revenue received from teacher testing fees that is
- 7 unexpended at the end of the state fiscal year may be carried over
- 8 to the succeeding fiscal year and shall not revert to the general
- 9 fund.

10 OFFICE OF EDUCATIONAL IMPROVEMENT AND INNOVATION

- 11 Sec. 601. From the amount appropriated in part 1 for the
- 12 office of educational improvement and innovation, there is
- 13 allocated \$350,000.00 and 3.5 FTE positions to operate a charter
- 14 school office to administer charter school legislation and
- 15 associated regulations, and to coordinate the activities of the
- 16 department relating to charter schools.

17 INFORMATION TECHNOLOGY

- 18 Sec. 701. The department shall work in collaboration with the
- 19 center for educational performance and information to support the
- 20 comprehensive educational information system and all data
- 21 collection and reporting efforts of the department.

22 LIBRARY OF MICHIGAN

- 23 Sec. 801. In addition to the funds appropriated in part 1, the
- 24 funds collected by the department for document reproduction and

- 1 services; conferences, workshops, and training classes; and the use
- 2 of specialized equipment, facilities, and software are appropriated
- 3 for all expenses necessary to provide the required services. These
- 4 funds are available for expenditure when they are received and may
- 5 be carried forward into the next succeeding fiscal year.
- 6 Sec. 803. It is the intent of the legislature that the library
- 7 of Michigan and the component programs currently within the library
- 8 of Michigan shall be kept together in a state department.
- 9 Sec. 804. From the funds appropriated in part 1 and other
- 10 funding available, the department and library of Michigan shall
- 11 maintain custody of the non-Michigan genealogy and all Michigan-
- 12 specific collections. These collections shall continue to be made
- available to the public.

14 GRANTS ADMINISTRATION AND SCHOOL SUPPORT SERVICES

- Sec. 901. Within 10 days of the receipt of a grant
- 16 appropriated in the federal and private grants line item in part 1,
- 17 the department shall notify the house and senate chairpersons of
- 18 the appropriations subcommittees responsible for the department
- 19 budget, the house and senate fiscal agencies, and the state budget
- 20 director of the receipt of the grant, including the funding source,
- 21 purpose, and amount of the grant.
- 22 Sec. 902. The college access challenge grant program is a work
- 23 project as provided in section 451a of the management and budget
- 24 act, 1984 PA 431, MCL 18.1451a, and as follows and as such
- 25 appropriations for the program shall not lapse at the end of the
- 26 fiscal year but shall continue to be available for expenditure

- 1 until the project has been completed:
- 2 (a) The purpose of the project is to provide assistance and
- 3 training to Michigan families, counselors, teachers, and community
- 4 leaders in applying for and securing funds for college to low-
- 5 income students.
- 6 (b) The project will be accomplished by state employees and/or
- 7 by contracts with private vendors.
- 8 (c) The total estimated cost of the project is \$8,571,000.00.
- 9 (d) The tentative completion date is September 30, 2012.
- Sec. 903. By not later than March 1, 2012, the department
- 11 shall work with districts that operate as a school of excellence
- 12 cyber school as defined in section 551 of the revised school code,
- 13 1976 PA 451, MCL 380.551, and districts that operate an alternative
- 14 education program with a seat-time waiver under section 101 of the
- 15 state school aid act of 1979, 1979 PA 94, MCL 388.1701, to provide
- 16 a report to the house and senate chairpersons of the appropriations
- 17 subcommittees responsible for the department budget, the house and
- 18 senate fiscal agencies, and the state budget director on all of the
- 19 following:
- 20 (a) Each district operating a program and the districts that
- 21 enroll students in their program.
- (b) The total number of students and membership pupils
- 23 enrolled in each program.
- 24 (c) The district in which each pupil is enrolled if other than
- 25 the district with the seat-time wavier or the cyber school.
- 26 (d) The district in which the pupil was enrolled prior to
- 27 enrolling in the cyber school or the district with a seat-time

- 2 (e) The number of participating students who had previously

- 7 (h) The cost per pupil charged to school districts that enroll
- 8 their students in the program.
- 9 (i) The name of each online education provider contracted by a
- 10 district with a seat-time waiver or a cyber school and the state in
- 11 which the online education provider is located.

15 GENERAL SECTIONS

- 16 Sec. 1201. It is the intent of the legislature to provide
- 17 appropriations for the fiscal year ending on September 30, 2013 for
- 18 the line items listed in part 1. The fiscal year 2012-2013
- 19 appropriations are anticipated to be the same as those for fiscal
- 20 year 2011-2012, except that the line items will be adjusted for
- 21 changes in caseload and related costs, federal fund match rates,
- 22 economic factors, and available revenue. These adjustments will be
- 23 determined after the January 2012 consensus revenue estimating
- 24 conference.
