- 14 appropriated an amount not to exceed \$100,000.00 for local
- 15 contingency funds. These funds are not available for expenditure
- 16 until they have been transferred to another line item in this act
- 17 under section 393(2) of the management and budget act, 1984 PA 431,
- **18** MCL 18.1393.
- 19 (4) In addition to the funds appropriated in part 1, there is
- 20 appropriated an amount not to exceed \$1,000,000.00 for private
- 21 contingency funds. These funds are not available for expenditure
- 22 until they have been transferred to another line item in this act
- under section 393(2) of the management and budget act, 1984 PA 431,
- **24** MCL 18.1393.
- 25 Sec. 216. Amounts appropriated in part 1 for information
- 26 technology may be designated as work projects and carried forward
- 27 to support technology projects under the direction of the

- 1 department of technology, management, and budget. Funds designated
- 2 in this manner are not available for expenditure until approved as
- 3 work projects under section 451a of the management and budget act,
- 4 1984 PA 431, MCL 18.1451a.
- 5 Sec. 217. The department and agencies receiving appropriations
- 6 in part 1 shall receive and retain copies of all reports funded
- 7 from appropriations in part 1. Federal and state guidelines for
- 8 short-term and long-term retention of records shall be followed.
- 9 The department may electronically retain copies of reports unless
- 10 otherwise required by federal and state guidelines.
- 11 Sec. 220. Not later than November 15, the department shall
- 12 prepare and transmit a report that provides for estimates of the
- 13 total general fund/general purpose appropriation lapses at the
- 14 close of the fiscal year. This report shall summarize the projected
- 15 year-end general fund/general purpose appropriation lapses by major

- 9 Sec. 233. On a quarterly basis, the department shall report on
- 10 the number of FTEs in pay status by civil service classification to
- 11 the senate and house appropriations subcommittees on natural
- 12 resources and environment and the senate and house fiscal agencies.
- Sec. 234. (1) The department shall maintain a searchable
- 14 website accessible by the public at no cost that includes, but is
- 15 not limited to, all of the following:
- 16 (a) Fiscal year-to-date expenditures by category.
- 17 (b) Fiscal year-to-date expenditures by appropriation unit.
- (c) Fiscal year-to-date payments to a selected vendor,
- 19 including the vendor name, payment date, payment amount, and
- 20 payment description.
- (d) The number of active department employees by job
- 22 classification.
- (e) Job specifications and wage rates.
- 24 (2) The department may develop and operate its own website to
- 25 provide this information or may reference the state's central
- 26 transparency website as the source for this information.
- Sec. 235. The department shall not expend more than \$10,000.00

- 1 from the appropriations in part 1 to implement the requirements of
- **2** section 234.

## 3 EXECUTIVE OPERATIONS AND DEPARTMENT SUPPORT

- 4 Sec. 301. The department may charge the appropriations
- 5 contained in part 1, including all special maintenance and capital
- 6 projects appropriated for the fiscal year ending September 30,
- 7 2012, for engineering services provided, a standard percentage fee
- 8 to recover actual costs. The department may use the revenue derived
- 9 to support the engineering services charges provided for in part 1.
- 10 Sec. 302. The department may charge land acquisition projects
- 11 appropriated for the fiscal year ending September 30, 2012, and for
- 12 prior fiscal years, a standard percentage fee to recover actual
- 13 costs, and may use the revenue derived to support the land
- 14 acquisition service charges provided for in part 1.
- 15 Sec. 303. As appropriated in part 1, the department may charge
- 16 both application fees and transaction fees related to the exchange
- 17 or sale of state-owned land or rights in land authorized by part 21
- 18 of the natural resources and environmental protection act, 1994 PA
- 19 451, MCL 324.2101 to 324.2162. The fees shall be set by the
- 20 director of the department at a rate which allows the department to
- 21 recover its costs for providing these services.
- 22 Sec. 304. For the purposes of administering the museum store
- 23 as provided in section 7a of 1913 PA 271, MCL 399.7a, the
- 24 department is exempt from section 261 of the management and budget
- 25 act, 1984 PA 431, MCL 18.1261.
- 26 Sec. 305. As appropriated in part 1, proceeds in excess of

- 1 costs incurred in the conduct of auctions, sales, or transfers of
- 2 artifacts no longer considered suitable for the collections of the
- 3 state historical museum may be expended upon receipt for additional
- 4 material for the collection. The department shall notify the
- 5 chairpersons, vice chairpersons, and minority vice chairpersons of
- 6 the senate and house appropriations subcommittees on natural
- 7 resources 1 week prior to any auctions or sales. Any unexpended
- 8 funds may be carried forward into the next succeeding fiscal year.
- 9 Sec. 306. As appropriated in part 1, funds collected by the

- 3 transaction, and whether the transaction is by purchase, public
- 4 auction, transfer, exchange, or conveyance.
- 5 Sec. 309. By January 1, 2012, the department shall produce a
- 6 report identifying active oil and gas leases entered into before
- 7 July 1995 which are larger than 160 acres in size and where the
- 8 acreage held in a producing unit is less than or equal to 1/4 of
- 9 the total lease acreage.

## WILDLIFE DIVISION

- 11 Sec. 402. It is the intent of the legislature that, from the
- 12 funds appropriated in part 1, the department shall reimburse the
- 13 department of agriculture and rural development for costs incurred
- 14 for indemnification payments for livestock losses caused by wolves,
- 15 coyotes, or cougars under the animal industry act, 1988 PA 466, MCL
- **16** 287.701 to 287.746.

### 17 FISHERIES DIVISION

- 18 Sec. 501. (1) From the appropriation in part 1 for aquatic
- 19 resource mitigation, not more than \$758,000.00 shall be allocated
- 20 for grants to watershed councils, resource development councils,
- 21 soil conservation districts, local governmental units, and other
- 22 nonprofit organizations for stream habitat stabilization and soil
- 23 erosion control.
- 24 (2) The fisheries division in the department shall develop
- 25 priority and cost estimates for all projects recommended for grants

- 1 under subsection (1).
- 2 Sec. 502. As a condition of expenditure of fisheries
- 3 management appropriations under part 1, the department of natural
- 4 resources shall not impede the certification process for water
- 5 control structures on Michigan waterways. The department of natural
- 6 resources shall fund from funds appropriated in part 1 all non-
- 7 water-quality studies or requirements that the department requests
- 8 of either of the following:
- 9 (a) The department of environmental quality as a condition for
- 10 issuance of a certification under the federal water pollution

#### 14 RECREATION DIVISION

- Sec. 601. Pursuant to section 1902(2) of the natural resources
- 16 and environmental protection act, 1994 PA 451, MCL 324.1902, there
- 17 is appropriated from the Michigan natural resources trust fund to
- 18 the Michigan state parks endowment fund an amount not to exceed
- 19 \$10,000,000.00 for the fiscal year ending September 30, 2012.
- 20 Sec. 602. The department shall notify the house and senate
- 21 appropriations subcommittees on natural resources and the house and
- 22 senate fiscal agencies if it intends to reduce operations or reduce
- 23 recreation opportunities in any state park or recreation area.

## 24 FOREST MANAGEMENT DIVISION

25 Sec. 701. In addition to the funds appropriated in part 1,

- 1 \$350,000.00 is appropriated to the department to cover costs
- 2 related to any declared emergency involving the collapse of any
- 3 abandoned mine shaft located on state land. This appropriation
- 4 shall not be expended unless the state budget director recommends
- 5 the expenditure and the department notifies the house and senate
- 6 committees on appropriations.
- 7 Sec. 702. Of the funds appropriated in part 1, the department
- 8 shall, subject to the forest certification process, prescribe

- 4 compact with the federal government. If additional expenditure
- 5 authorization is required, the department shall notify the state
- 6 budget office that expenditure under this section is required. The

- 18 campgrounds proposed for closure by the department will be open and
- 19 accessible to the general public.
- 20 Sec. 707. The department shall complete the development of a
- 21 strategic plan to incorporate selected state forest campgrounds
- 22 into the state park system as mini-state parks in order to qualify
- 23 them for funding under section 2045 of the natural resources and
- 24 environmental protection act, 1994 PA 451, MCL 324.2045, from state

- Sec. 710. The department shall provide a report on the
- 14 wildfire protection use of department aircraft to the house and
- 15 senate appropriations subcommittees on natural resources and the
- 16 house and senate fiscal agencies by December 1, 2011. The report
- 17 shall include the following information for the preceding fiscal
- 18 year: how many airplanes the department owns, how much the
- 19 airplanes cost annually, which DNR divisions used the aircraft
- 20 throughout the year, how many wildfires occurred in which the
- 21 aircraft were used to help provide detection, surveillance, or
- 22 suppression support, and how many flight hours were logged for the
- 23 fleet in that year.

## LAW ENFORCEMENT

24

- 25 Sec. 801. The appropriation in part 1 for snowmobile law
- 26 enforcement grants shall be used by the department to provide

- 1 grants to county law enforcement agencies to enforce part 821 of
- 2 the natural resources and environmental protection act, 1994 PA
- 3 451, MCL 324.82101 to 324.82160, including rules promulgated under
- 4 that part and ordinances enacted pursuant to that part. The
- 5 department shall consider the number of enforcement hours and the
- 6 number of miles of snowmobile trails in each county in allocating
- 7 these grants. Any funds not distributed to counties revert back to
- 8 the snowmobile registration fee subaccount created under section
- 9 82111 of the natural resources and environmental protection act,
- 10 1994 PA 451, MCL 324.82111. Counties shall provide semiannual
- 11 reports to the department on the use of grant money received under
- 12 this section.
- 13 Sec. 802. The department shall provide a report on the marine
- 14 safety grant program to the senate and house appropriations
- 15 subcommittees on natural resources and the senate and house fiscal
- 16 agencies by December 1, 2011. The report shall include the
- 17 following information for the preceding year: the total amount of
- 18 revenue received for watercraft registrations, the amount deposited
- 19 into the marine safety fund, and the expenditures made from the
- 20 marine safety fund, including the amounts expended for department
- 21 administration, other state agencies, the law enforcement division,
- 22 and grants to counties. The report shall also include the
- 23 distribution methodology used by the department to distribute the
- 24 marine safety grants and a list of the grants and the amounts
- 25 awarded by county.

#### 26 GRANTS

- 1 Sec. 901. Federal pass-through funds to local institutions and
- 2 governments that are received in amounts in addition to those
- 3 included in part 1 for grants to communities federal oil, gas,
- 4 and timber payments and that do not require additional state
- 5 matching funds are appropriated for the purposes intended. By
- 6 November 30, 2011, the department shall report to the senate and
- 7 house appropriations subcommittees on natural resources, the senate
- 8 and house fiscal agencies, and the state budget director on all
- 9 amounts appropriated under this section during the fiscal year
- 10 ending September 30, 2011.
- 11 Sec. 902. Subject to part 811 of the natural resources and
- 12 environmental protection act, 1994 PA 451, MCL 324.81101 to
- 13 324.81150, from the funds appropriated in part 1 for off-road
- 14 vehicle trail improvements grants, not less than \$980,000.00 shall
- 15 be spent on the development of new trails in accordance with the
- 16 off-road vehicle trail expansion plan submitted to the legislature
- 17 pursuant to section 807 of article 14 of 2005 PA 154.

### 18 CAPITAL OUTLAY

- 19 Sec. 1001. The appropriation made in this act for the harbors
- 20 and docks program is for the purpose of participating with the
- 21 federal government and assisting local units of government, public
- 22 colleges and universities, or other governmental entities in this
- 23 state with the construction and improvement of recreational boating
- 24 facilities within this state. Subject to the approval of the state
- 25 administrative board, this money shall be allocated by the
- 26 department to the federal government, or to the governmental

- 1 entities involved in the particular projects. An allocation shall
- 2 not exceed the state portion as listed with each project
- 3 description. The department shall take the steps necessary to match
- 4 federal money available for the construction and improvement of
- 5 recreational boating facilities within the state, and to meet
- 6 requirements of the federal government.
- 7 Sec. 1002. (1) The director of the department shall allocate
- 8 lump-sum appropriations to the department made in this act
- 9 consistent with statutory provisions and the purposes for which
- 10 funds were appropriated. Lump-sum allocations shall address
- 11 priority program or facility needs and may include, but are not
- 12 limited to, design, construction, remodeling and addition, special
- 13 maintenance, major special maintenance, energy conservation, and
- 14 demolition.

- 27 have been obtained, the department shall fund a capital outlay

- 1 project to construct a breakwall at the Grand Marais harbor
- 2 according to a plan to be prepared by Burt Township. The project
- 3 has an estimated completion cost of \$7,000,000.00 and an estimated
- 4 completion date of September 30, 2015.

## 5 ONE-TIME BASIS ONLY

- 6 Sec. 1101. For the state fiscal year ending September 30,
- 7 2012, there is appropriated from general fund/general purpose
- 8 revenue, on a 1-time basis only, \$4,000,000.00 for the Grand Marais
- 9 harbor capital outlay project provided for in section 1004.

## 13 GENERAL SECTIONS

- 14 Sec. 1201. It is the intent of the legislature to provide
- 15 appropriations for the fiscal year ending on September 30, 2013 for
- 16 the line items listed in part 1. The fiscal year 2012-2013
- 17 appropriations are anticipated to be the same as those for fiscal
- 18 year 2011-2012, except that the line items will be adjusted for
- 19 changes in caseload and related costs, federal fund match rates,
- 20 economic factors, and available revenue. These adjustments will be
- 21 determined after the January 2012 consensus revenue estimating
- 22 conference.
