SUBSTITUTE FOR

SENATE BILL NO. 176

A bill to make appropriations for the department of environmental quality for the fiscal year ending September 30, 2012; to provide for the expenditure of those appropriations; to provide anticipated appropriations for the fiscal year ending September 30, 2013; to create funds and accounts; to require reports; to prescribe certain powers and duties of certain state agencies and officials; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by the various state agencies.

5	Sec. 201. Pursuant to section 30 of article IX of the state
6	constitution of 1963, total state spending from state resources
7	under part 1 for fiscal year 2011-2012 is \$245,063,500.00 and state
8	spending from state resources to be paid to local units of
9	government for fiscal year 2011-2012 is \$2,175,000.00. The itemized
10	statement below identifies appropriations from which spending to
11	local units of government will occur:

17	Sec. 202. The appropriations authorized under this act are
18	subject to the management and budget act, 1984 PA 431, MCL 18.1101
19	to 18.1594.
20	Sec. 203. As used in this act:
21	(a) "Department" means the department of environmental
22	quality.
23	(b) "Director" means the director of the department.
24	(c) "FTE" means full-time equated.
25	(d) "IDG" means interdepartmental grant.

- 1 (e) "IDT" means intradepartmental transfer.
- 2 (f) "MDOT" means the state transportation department.
- 3 (g) "MDSP" means the department of state police.
- 4 (h) "NPDES" means national pollution discharge elimination
- 5 system.
- 6 Sec. 204. The civil service commission shall bill the
- 7 department and agencies at the end of the first fiscal quarter for
- 8 the 1% charge authorized by section 5 of article XI of the state
- 9 constitution of 1963. Payments shall be made for the total amount
- 10 of the billing by the end of the second fiscal quarter.
- 11 Sec. 205. Unless otherwise specified, the department shall use
- 12 the Internet to fulfill the reporting requirements of this act.
- 13 This requirement may include transmission of reports via electronic
- 14 mail to the recipients identified for each reporting requirement,
- 15 or it may include placement of reports on an Internet or Intranet
- **16** site.
- 17 Sec. 206. Amounts appropriated in part 1 for information
- 18 technology may be designated as work projects and carried forward
- 19 to support technology projects under the direction of the
- 20 department of technology, management, and budget. Funds designated
- 21 in this manner are not available for expenditure until approved as
- 22 work projects under section 451a of the management and budget act,
- 23 1984 PA 431, MCL 18.1451a.
- Sec. 207. The department and agencies receiving appropriations
- 25 in part 1 shall receive and retain copies of all reports funded
- 26 from appropriations in part 1. Federal and state guidelines for
- 27 short-term and long-term retention of records shall be followed.

- 1 The department may electronically retain copies of reports unless
- 2 otherwise required by federal and state guidelines.
- 3 Sec. 208. From the funds appropriated in part 1 for
- 4 information technology, departments and agencies shall pay user
- 5 fees to the department of technology, management, and budget for
- 6 technology-related services and projects. The user fees shall be
- 7 subject to provisions of an interagency agreement between the
- 8 department and agencies and the department of technology,
- 9 management, and budget.
- 10 Sec. 210. Funds appropriated in part 1 shall not be used for
- 11 the purchase of foreign goods or services, or both, if
- 12 competitively priced and of comparable quality American goods or
- 13 services, or both, are available. Preference shall be given to
- 14 goods or services, or both, manufactured or provided by Michigan
- 15 businesses if they are competitively priced and of comparable
- 16 quality. In addition, preference shall be given to goods or
- 17 services, or both, that are manufactured or provided by Michigan
- 18 businesses owned and operated by veterans, if they are
- 19 competitively priced and of comparable quality.
- 20 Sec. 211. The director shall take all reasonable steps to
- 21 ensure businesses in deprived and depressed communities compete for
- 22 and perform contracts to provide services or supplies, or both. The
- 23 director shall strongly encourage firms with which the department
- 24 contracts to subcontract with certified businesses in depressed and
- 25 deprived communities for services, supplies, or both.
- 26 Sec. 212. The department shall not take disciplinary action
- 27 against an employee for communicating with a member of the

- 1 legislature or his or her staff.
- 2 Sec. 213. (1) Funds appropriated in part 1 shall not be used
- 3 by the department to promulgate a rule that will apply to a small
- 4 business and that will have a disproportionate economic impact on
- 5 small businesses because of the size of those businesses if the
- 6 department fails to reduce the disproportionate economic impact of
- 7 the rule on small businesses as provided under section 40 of the
