14 **GENERAL SECTIONS**

15 Sec. 201. Pursuant to section 30 of article IX of the state
 16 constitution of 1963, total state spending from state resources
 17 under part 1 for fiscal year 2012-2013 is \$262,091,600.00 and state
 18 spending from state resources to be paid to local units of
 19 government for fiscal year 2012-2013 is \$5,921,100.00. The itemized

10 subject to the management and budget act, 1984 PA 431, MCL 18.1101
11 to 18.1594.

12 Sec. 203. As used in this act:

- 13 (a) "Commission" means the natural resources commission.
14 (b) "Department" means the department of natural resources.
15 (c) "FTE" means full-time equated.
16 (d) "IDG" means interdepartmental grant.
17 (e) "IDT" means intradepartmental transfer.

18 Sec. 204. The civil service commission shall bill the
19 department and agencies at the end of the first fiscal quarter for
20 the 1% charge authorized by section 5 of article XI of the state
21 constitution of 1963. Payments shall be made for the total amount
22 of the billing by the end of the second fiscal quarter.

23 Sec. 205. Unless otherwise specified, the department shall use
24 the Internet to fulfill the reporting requirements of this act.
25 This requirement may include transmission of reports via electronic
26 mail to the recipients identified for each reporting requirement,
27 or it may include placement of reports on an Internet or Intranet

1 site.

17 information technology, departments and agencies shall pay user
18 fees to the department of technology, management, and budget for
19 technology-related services and projects. The user fees shall be
20 subject to provisions of an interagency agreement between the
21 department and agencies and the department of technology,
22 management, and budget.

23 Sec. 210. Funds appropriated in part 1 shall not be used for
24 the purchase of foreign goods or services, or both, if
25 competitively priced and of comparable quality American goods or
26 services, or both, are available. Preference shall be given to
27 goods or services, or both, manufactured or provided by Michigan

1 businesses if they are competitively priced and of comparable
2 quality. In addition, preference should be given to goods or
3 services, or both, that are manufactured or provided by Michigan
4 businesses owned and operated by veterans, if they are
5 competitively priced and of comparable quality.

6 Sec. 211. The director of the department shall take all
7 reasonable steps to ensure businesses in deprived and depressed
8 communities compete for and perform contracts to provide services
9 or supplies, or both. The director shall strongly encourage firms
10 with which the department contracts to subcontract with certified
11 businesses in depressed and deprived communities for services,
12 supplies, or both.

13 Sec. 212. The department shall not take disciplinary action
14 against an employee for communicating with a member of the
15 legislature or his or her staff.

16 Sec. 214. Funds appropriated in part 1 shall not be used by a
17 principal executive department, state agency, or authority to hire
18 a person to provide legal services that are the responsibility of
19 the attorney general. This prohibition does not apply to legal
20 services for bonding activities and for those outside services that
21 the attorney general authorizes.

22 Sec. 215. (1) In addition to the funds appropriated in part 1,
23 there is appropriated an amount not to exceed \$3,000,000.00 for
24 federal contingency funds. These funds are not available for
25 expenditure until they have been transferred to another line item
26 in this act under section 393(2) of the management and budget act,
27 1984 PA 431, MCL 18.1393.

1 (2) In addition to the funds appropriated in part 1, there is
2 appropriated an amount not to exceed \$10,000,000.00 for state
3 restricted contingency funds. These funds are not available for
4 expenditure until they have been transferred to another line item
5 in this act under section 393(2) of the management and budget act,
6 1984 PA 431, MCL 18.1393.

7 (3) In addition to the funds appropriated in part 1, there is
8 appropriated an amount not to exceed \$100,000.00 for local
9 contingency funds. These funds are not available for expenditure
10 until they have been transferred to another line item in this act
11 under section 393(2) of the management and budget act, 1984 PA 431,
12 MCL 18.1393.

13 (4) In addition to the funds appropriated in part 1, there is
14 appropriated an amount not to exceed \$1,000,000.00 for private
15 contingency funds. These funds are not available for expenditure
16 until they have been transferred to another line item in this act
17 under section 393(2) of the management and budget act, 1984 PA 431,
18 MCL 18.1393.

19 Sec. 216. Amounts appropriated in part 1 for information
20 technology may be designated as work projects and carried forward
21 to support technology projects under the direction of the
22 department of technology, management, and budget. Funds designated
23 in this manner are not available for expenditure until approved as
24 work projects under section 451a of the management and budget act,
25 1984 PA 431, MCL 18.1451a.

26 Sec. 217. The department and agencies receiving appropriations
27 in part 1 shall receive and retain copies of all reports funded

1 from appropriations in part 1. Federal and state guidelines for
2 short-term and long-term retention of records shall be followed.
3 The department may electronically retain copies of reports unless
4 otherwise required by federal and state guidelines.

5 Sec. 218. The departments and agencies receiving
6 appropriations in part 1 shall prepare a report on out-of-state
7 travel expenses not later than January 1 of each year. The travel
8 report shall be a listing of all travel by classified and
9 unclassified employees outside this state in the immediately
10 preceding fiscal year that was funded in whole or in part with
11 funds appropriated in the department's budget. The report shall be
12 submitted to the house and senate standing committees on
13 appropriations, the house and senate fiscal agencies, and the state
14 budget director. The report shall include the following
15 information:

16 (a) The dates of each travel occurrence.

17 (b) The total transportation and related costs of each travel
18 occurrence, including the proportion funded with state general
19 fund/general purpose revenues, the proportion funded with state
20 restricted revenues, the proportion funded with federal revenues,
21 and the proportion funded with other revenues.

22 Sec. 219. It is the intent of the legislature that all
23 principal executive departments and agencies cooperate with the
24 development and implementation of the department of technology,
25 management, and budget statewide office space consolidation plan.

26 Sec. 220. Not later than November 15, the department shall
27 prepare and transmit a report that provides for estimates of the

1 total general fund/general purpose appropriation lapses at the
2 close of the fiscal year. This report shall summarize the projected
3 year-end general fund/general purpose appropriation lapses by major
4 departmental program or program areas. The report shall be
5 transmitted to the office of the state budget, the chairpersons of
6 the senate and house of representatives standing committees on
7 appropriations, and the senate and house fiscal agencies.

8 Sec. 222. Within 14 days after the release of the executive
9 budget recommendation, the department shall provide the state
10 budget director, the senate and house appropriations chairs, the
11 senate and house appropriations subcommittees on natural resources,
12 respectively, and the senate and house fiscal agencies with an
13 annual report on estimated state restricted fund balances, state
14 restricted fund projected revenues, and state restricted fund
15 expenditures for the fiscal years ending September 30, 2012 and
16 September 30, 2013.

17 Sec. 223. Before January 31, 2013, the department, in
18 cooperation with the Michigan state waterways commission, shall
19 provide to the state budget director, the senate and house
20 appropriations subcommittees on natural resources, and the senate
21 and house fiscal agencies a list of projects completed by the
22 commission in fiscal year 2011-2012, including the county and
23 municipality in which each project is located.

24 Sec. 230. By October 31, 2012, the department shall identify
25 10 principal measurable outcomes to be affected by expenditure of
26 the funds appropriated in part 1 of this act and submit a report to
27 the house and senate appropriations committees, the house and

1 senate fiscal agencies, and the state budget director that ranks
2 the outcomes by level of importance and contains current data on
3 those outcomes. Beginning on April 1, 2013, the department shall
4 provide biannual updates to the house and senate appropriations
5 committees on changes in those measurable outcomes and departmental
6 efforts to improve the outcomes.

7 Sec. 233. On a quarterly basis, the department shall report on
8 the number of FTEs in pay status by civil service classification to
9 the senate and house appropriations subcommittees on natural
10 resources and environment and the senate and house fiscal agencies.

11 Sec. 234. The department shall maintain a searchable website
12 accessible by the public at no cost that includes, but is not
13 limited to, all of the following:

14 (a) Fiscal year-to-date expenditures by category.

15 (b) Fiscal year-to-date expenditures by appropriation unit.

16 (c) Fiscal year-to-date payments to a selected vendor,
17 including the vendor name, payment date, payment amount, and
18 payment description.

19 (d) The number of active department employees by job
20 classification.

21 (e) Job specifications and wage rates.

22 **DEPARTMENT SUPPORT SERVICES**

23 Sec. 302. The department may charge land acquisition projects
24 appropriated for the fiscal year ending September 30, 2013, and for
25 prior fiscal years, a standard percentage fee to recover actual
26 costs, and may use the revenue derived to support the land

1 acquisition service charges provided for in part 1.

2 Sec. 303. As appropriated in part 1, the department may charge
3 both application fees and transaction fees related to the exchange
4 or sale of state-owned land or rights in land authorized by part 21
5 of the natural resources and environmental protection act, 1994 PA
6 451, MCL 324.2101 to 324.2162. The fees shall be set by the
7 director of the department at a rate which allows the department to
8 recover its costs for providing these services.

9 **COMMUNICATION AND CUSTOMER SERVICES**

10 Sec. 404. For the purposes of administering the museum store
11 as provided in section 7a of 1913 PA 271, MCL 399.7a, the
12 department is exempt from section 261 of the management and budget
13 act, 1984 PA 431, MCL 18.1261.

14 Sec. 405. As appropriated in part 1, proceeds in excess of
15 costs incurred in the conduct of auctions, sales, or transfers of
16 artifacts no longer considered suitable for the collections of the
17 state historical museum may be expended upon receipt for additional
18 material for the collection. The department shall notify the
19 chairpersons, vice chairpersons, and minority vice chairpersons of
20 the senate and house appropriations subcommittees on natural
21 resources 1 week prior to any auctions or sales. Any unexpended
22 funds may be carried forward into the next succeeding fiscal year.

23 Sec. 406. As appropriated in part 1, funds collected by the
24 department for historical markers; document reproduction and
25 services; conferences, admissions, workshops, and training classes;
26 and the use of specialized equipment, facilities, exhibits,

1 collections, and software shall be used for expenses necessary to
2 provide the required services. The department may charge fees for
3 the aforementioned services, including admission fees. It is the
4 intent of the legislature that if sufficient revenues are
5 available, as a condition of the expenditure of revenue from
6 admission fees to the Michigan historical museum, admission to the
7 museum shall be free for children under 18 years of age. The
8 department may accept voluntary admissions contributions of \$2.00
9 for children under 18 years of age. Any unexpended funds may be
10 carried forward into the next succeeding fiscal year.

11 Sec. 408. By October 21, 2012, the department shall submit to
12 the senate and house appropriations subcommittees on natural
13 resources a report on all land transactions approved by the
14 commission in the fiscal year ending September 30, 2012. For each
15 land transaction, the report shall include the size of the parcel,
16 the county and municipality in which the parcel is located, the
17 dollar amount of the transaction, the fund source affected by the
18 transaction, and whether the transaction is by purchase, public
19 auction, transfer, exchange, or conveyance.

20 Sec. 409. By January 1, 2013, the department shall produce a
21 report identifying active oil and gas leases entered into before
22 July 1995 which are larger than 160 acres in size and where the
23 acreage held in a producing unit is less than or equal to 1/4 of
24 the total lease acreage.

25 **WILDLIFE DIVISION**

26 Sec. 503. From the funds appropriated in part 1, the

1 department shall produce a report detailing any efforts undertaken
2 to enforce the invasive species order on swine raised under the
3 husbandry of residents of this state. The report shall include fund
4 sources used and the amount of expenditures and shall be submitted
5 to the legislature by December 31, 2012.

6 Sec. 504. From the funds appropriated in part 1, the
7 department shall provide a report to the legislature on the use of
8 registration fees collected from privately owned cervid operations.
9 Appropriations in part 1 from cervidae licensing and inspection
10 fees shall not be used for anything other than work directly
11 related to the regulation of privately owned cervids in this state.

12 **FISHERIES DIVISION**

13 Sec. 601. (1) From the appropriation in part 1 for aquatic
14 resource mitigation, not more than \$758,000.00 shall be allocated
15 for grants to watershed councils, resource development councils,
16 soil conservation districts, local governmental units, and other
17 nonprofit organizations for stream habitat stabilization and soil
18 erosion control.

19 (2) The fisheries division in the department shall develop
20 priority and cost estimates for all projects recommended for grants
21 under subsection (1).

22 Sec. 602. As a condition of expenditure of fisheries
23 management appropriations under part 1, the department of natural
24 resources shall not impede the certification process for water
25 control structures on Michigan waterways. The department of natural
26 resources shall fund from funds appropriated in part 1 all non-

1 water-quality studies or requirements that the department requests
2 of either of the following:

3 (a) The department of environmental quality as a condition for
4 issuance of a certification under section 401 of the federal water
5 pollution control act, 33 USC 1341.

6 (b) The federal energy regulatory commission as a condition of
7 licensing under the federal power act, 16 USC 791a to 825r.

8 Sec. 603. The department shall provide a quarterly report to
9 the legislature on use of funding provided for cormorant
10 management. The department shall use general fund/general purpose
11 revenue for this purpose and submit revenue appropriated in this
12 act for cormorant management to the United States department of
13 agriculture animal and plant health inspection service to allow for
14 increased taking of cormorants and their nests.

15 **PARKS AND RECREATION DIVISION**

16 Sec. 702. The department shall notify the house and senate
17 appropriations subcommittees on natural resources and the house and
18 senate fiscal agencies if it intends to reduce operations or reduce
19 recreation opportunities in any state park or recreation area.

20 **FOREST RESOURCES DIVISION**

21 Sec. 801. In addition to the funds appropriated in part 1,
22 \$350,000.00 is appropriated to the department to cover costs
23 related to any declared emergency involving the collapse of any
24 abandoned mine shaft located on state land. This appropriation
25 shall not be expended unless the state budget director recommends

1 the expenditure and the department notifies the house and senate
2 committees on appropriations.

3 Sec. 802. Of the funds appropriated in part 1, the department
4 shall, subject to the forest certification process, prescribe
5 treatment on 79,000 acres, prepare appropriate treatment for not
6 less than 67,500 acres at the current average rate of 12.5 to 15
7 cords per acre, and offer those cords for sale in the 2012-2013
8 fiscal year, provided that the department shall take into
9 consideration the impact of timber harvesting on wildlife habitat
10 and recreation uses. The department shall, subject to the forest
11 certification process, increase marking or treatment of hardwood
12 timber for sale and harvest by 10% over 2011-2012 fiscal year
13 levels. In addition, the department shall take into consideration
14 silvicultural analysis and report annually to the legislature on
15 plans and efforts to address factors limiting management of timber.
16 The department shall increase the number of prepared acres if it
17 appears that regional market demand requires increased volumes of
18 harvested timber. The department shall provide quarterly reports on
19 the number of acres treated, pursuant to this section, to the
20 senate and house appropriations subcommittees on natural resources
21 and the standing committees of the senate and house of
22 representatives with primary responsibility for natural resources
23 issues. The department shall complete and deliver these reports no
24 later than 45 days after the end of the fiscal quarter.

25 Sec. 803. In addition to the money appropriated in this act,
26 the department may receive and expend money from federal sources
27 for the purpose of providing response to wildfires as required by a

compact with the federal government. If additional expenditure authorization is required, the department shall notify the state budget office that expenditure under this section is required. The department shall notify the house and senate appropriations subcommittees on natural resources and the house and senate fiscal agencies of the expenditures under this section by November 1, 2013.

Sec. 804. The department shall continue to work cooperatively with horseback riding interests to maximize riding opportunities in the state.

Sec. 805. The department shall spend amounts appropriated in part 1 for forest-related activities to employ or contract for sufficient foresters to mark timber, pursuant to section 802.

Sec. 806. It is the intent of the legislature that forest campgrounds proposed for closure by the department will be open and accessible to the general public.

LAW ENFORCEMENT

Sec. 901. The appropriation in part 1 for snowmobile law enforcement grants shall be used by the department to provide grants to county law enforcement agencies to enforce part 821 of the natural resources and environmental protection act, 1994 PA 451, MCL 324.82101 to 324.82160, including rules promulgated under that part and ordinances enacted pursuant to that part. The department shall consider the number of enforcement hours and the number of miles of snowmobile trails in each county in allocating these grants. Any funds not distributed to counties revert back to

1 the snowmobile registration fee subaccount created under section
2 82111 of the natural resources and environmental protection act,
3 1994 PA 451, MCL 324.82111. Counties shall provide semiannual
4 reports to the department on the use of grant money received under
5 this section.

6 Sec. 902. The department shall provide a report on the marine
7 safety grant program to the senate and house appropriations
8 subcommittees on natural resources and the senate and house fiscal
9 agencies by December 1, 2012. The report shall include the
10 following information for the preceding year: the total amount of
11 revenue received for watercraft registrations, the amount deposited
12 into the marine safety fund, and the expenditures made from the
13 marine safety fund, including the amounts expended for department
14 administration, other state agencies, the law enforcement division,
15 and grants to counties. The report shall also include the
16 distribution methodology used by the department to distribute the
17 marine safety grants and a list of the grants and the amounts
18 awarded by county.

19 GRANTS

20 Sec. 1001. Federal pass-through funds to local institutions
21 and governments that are received in amounts in addition to those
22 included in part 1 for grants to communities - federal oil, gas,
23 and timber payments and that do not require additional state
24 matching funds are appropriated for the purposes intended. By
25 November 30, 2012, the department shall report to the senate and
26 house appropriations subcommittees on natural resources, the senate

1 and house fiscal agencies, and the state budget director on all
2 amounts appropriated under this section during the fiscal year
3 ending September 30, 2012.

4 Sec. 1002. Subject to part 811 of the natural resources and
5 environmental protection act, 1994 PA 451, MCL 324.81101 to
6 324.81150, from the funds appropriated in part 1 for off-road
7 vehicle trail improvements grants, not less than \$980,000.00 shall
8 be spent on the development of new trails in accordance with the
9 off-road vehicle trail expansion plan submitted to the legislature
10 pursuant to section 807 of article 14 of 2005 PA 154.

11 Sec. 1003. (1) The appropriation in part 1 for the dam
12 management grant program shall be used by the department to provide
13 grants for the maintenance, repair, or removal of failing dams. The
14 department shall require each grant application to include a
15 written long-term plan for each dam that is covered by the
16 application.

17 (2) The unexpended funds appropriated in part 1 for the dam
18 management grant program are considered work project
19 appropriations, and any unencumbered or unallotted funds are
20 carried forward into the succeeding fiscal year. The following is
21 in compliance with section 451a(1) of the management and budget
22 act, 1984 PA 431, MCL 18.1451a:

23 (a) The purpose of the projects to be carried forward is to
24 provide for maintenance, repair, or removal of dams.

25 (b) The projects will be accomplished by contract.

26 (c) The total estimated cost of all projects is \$2,000,000.00.

27 (d) The tentative completion date is September 30, 2017.

1 **CAPITAL OUTLAY**

2 Sec. 1101. The appropriation made in this act for the harbors
3 and docks program is for the purpose of participating with the
4 federal government and assisting local units of government, public
5 colleges and universities, or other governmental entities in this
6 state with the construction and improvement of recreational boating
7 facilities within this state. Subject to the approval of the state
8 administrative board, this money shall be allocated by the
9 department to the federal government, or to the governmental
10 entities involved in the particular projects. An allocation shall
11 not exceed the state portion as listed with each project
12 description. The department shall take the steps necessary to match
13 federal money available for the construction and improvement of
14 recreational boating facilities within the state, and to meet
15 requirements of the federal government.

16 Sec. 1102. (1) The director of the department shall allocate
17 lump-sum appropriations to the department made in this act
18 consistent with statutory provisions and the purposes for which
19 funds were appropriated. Lump-sum allocations shall address
20 priority program or facility needs and may include, but are not
21 limited to, design, construction, remodeling and addition, special
22 maintenance, major special maintenance, energy conservation, and
23 demolition.

24 (2) The state budget director may authorize that funds
25 appropriated for lump-sum appropriations shall be available for no
26 more than 3 fiscal years following the fiscal year in which the

1 original appropriation was made. Any remaining balance from
2 allocations made in this section shall lapse to the fund from which
3 it was appropriated pursuant to the lapsing of funds as provided in
4 the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

5 Sec. 1103. The appropriations in part 1 for capital outlay
6 shall be carried forward at the end of the fiscal year consistent
7 with the provisions of section 248 of the management and budget
8 act, 1984 PA 431, MCL 18.1248.

9 PART 2A

10 PROVISIONS CONCERNING ANTICIPATED APPROPRIATIONS

11 FOR FISCAL YEAR 2013-2014

12 **GENERAL SECTIONS**

13 Sec. 1201. It is the intent of the legislature to provide
14 appropriations for the fiscal year ending on September 30, 2014 for
15 the line items listed in part 1. The fiscal year 2013-2014
16 appropriations are anticipated to be the same as those for fiscal
17 year 2012-2013, except that the line items will be adjusted for
18 changes in caseload and related costs, federal fund match rates,
19 economic factors, and available revenue. These adjustments will be
20 determined after the January 2013 consensus revenue estimating
21 conference.
