HOUSE BILL NO. 4306

(As amended May 10, 2011)

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1245.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 1245. (1) SUBJECT TO [SUBSECTIONS (4) AND (5),] BEGINNING JULY 1,
- 2 2012, THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL
- 3 DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY THAT
- 4 DIRECTLY EMPLOYS PERSONNEL TO PROVIDE CUSTODIAL, PUPIL
- 5 TRANSPORTATION, OR FOOD SERVICES FOR THE SCHOOL DISTRICT,
- 6 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY SHALL OBTAIN
- 7 COMPETITIVE BIDS FOR THE PROVISION OF THESE SERVICES AS PROVIDED
- 8 FOR UNDER SUBSECTION (2). A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 9 DISTRICT, OR PUBLIC SCHOOL ACADEMY MAY CONTRACT WITH ANY PERSON OR

- 1 ENTITY TO PROVIDE THESE SERVICES, OR MAY HAVE THESE SERVICES
- 2 PROVIDED ON AN EMPLOYMENT BASIS BY A GROUP OF ITS EMPLOYEES AFTER
- 3 OBTAINING COMPETITIVE BIDS UNDER SUBSECTION (2).
- 4 (2) SUBJECT TO SUBSECTION (4), BEFORE ENTERING INTO OR
- 5 RENEWING A CONTRACT OR COLLECTIVE BARGAINING AGREEMENT FOR A
- 6 SERVICE DESCRIBED IN SUBSECTION (1), THE BOARD OF A SCHOOL DISTRICT
- 7 OR INTERMEDIATE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC
- 8 SCHOOL ACADEMY DESCRIBED IN SUBSECTION (1) SHALL OBTAIN COMPETITIVE
- 9 BIDS ON THE PROVISION OF THE SERVICES. THE COMPETITIVE BIDDING
- 10 PROCESS ADOPTED BY A SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT,
- 11 OR PUBLIC SCHOOL ACADEMY MAY BE BASED ON THE PROCESS PRESCRIBED FOR
- 12 COMPETITIVE BIDDING OF CONSTRUCTION CONTRACTS UNDER SECTION 1267
- 13 AND SHALL REQUIRE THAT ALL BIDS RECEIVED WILL BE MADE AVAILABLE FOR
- 14 INSPECTION ON THE WEBSITE OF THE SCHOOL DISTRICT, INTERMEDIATE
- 15 SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY WITHIN 10 DAYS AFTER THE
- 16 DEADLINE FOR SUBMISSION OF BIDS.
- 17 (3) WITHIN 30 DAYS AFTER ENTERING INTO OR RENEWING A CONTRACT
- 18 OR COLLECTIVE BARGAINING AGREEMENT DESCRIBED IN SUBSECTION (1), THE
- 19 BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR BOARD
- 20 OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL INCLUDE ON ITS
- 21 WEBSITE A POSTING THAT IDENTIFIES THE BID SELECTED OR OTHER ACTION
- 22 TAKEN AFTER CONSIDERATION OF THE BIDS.
- 23 (4) THIS SECTION DOES NOT APPLY TO ANY OF THE FOLLOWING:
- 24 (A) A CONTRACT OF LESS THAN THE THRESHOLD AMOUNT PROVIDED
- 25 UNDER SECTION 1267 FOR COMPETITIVE BIDDING TO BE REQUIRED UNDER
- 26 THAT SECTION, AS ADJUSTED EACH YEAR UNDER THAT SECTION.
- 27 (B) THE PROVISION OF FOOD SERVICES, IF THE REVENUES THAT THE

- 1 SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 2 ACADEMY RECEIVES FROM ITS FOOD SERVICE PROGRAM EXCEED THE COSTS OF
- 3 OPERATION OF THE PROGRAM, AS DETERMINED FOR THE MOST RECENT SCHOOL
- 4 FISCAL YEAR FOR WHICH THE DATA ARE AVAILABLE.
- 5 (C) AN ADMINISTRATIVE FUNCTION IN SUPPORT OF A SERVICE
- 6 DESCRIBED IN SUBSECTION (1) IF THAT FUNCTION IS NORMALLY CARRIED
- 7 OUT AT A DIFFERENT ADMINISTRATIVE LEVEL THAN THE ACTUAL PROVISION
- 8 OF THE SERVICE, SUCH AS PLANNING, ROUTING, OR TRAINING.
 - [(5) THIS SECTION DOES NOT APPLY TO A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT THAT HAS A POSITIVE FUND BALANCE AS OF THE END OF THE IMMEDIATELY PRECEDING SCHOOL FISCAL YEAR IN AN AMOUNT AT LEAST EQUAL TO 10% OF THE SCHOOL DISTRICT'S OR INTERMEDIATE SCHOOL DISTRICT'S GENERAL OPERATING BUDGET FOR THE CURRENT SCHOOL FISCAL YEAR.
- 9 (6)] A CONTRACTOR WHO PROVIDES FOOD SERVICES FOR A SCHOOL
- 10 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY IS
- 11 ENCOURAGED TO PROVIDE THOSE SERVICES USING FRESH AND LOCAL FOODS IN
- 12 A MANNER CONSISTENT WITH THE PURPOSES OF THE FARM-TO-SCHOOL
