SUBSTITUTE FOR

HOUSE BILL NO. 4564

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 17766c (MCL 333.17766c), as amended by 2011 PA 86.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17766c. (1) A person shall not do any of the following:
- 2 (a) Purchase more than 3.6 grams of ephedrine or
- 3 pseudoephedrine alone or in a mixture within a single calendar day.
- 4 (b) Purchase more than 9 grams of ephedrine or pseudoephedrine
- 5 alone or in a mixture within a 30-day period.
- 6 (c) Possess more than 12 grams of ephedrine or pseudoephedrine
- 7 alone or in a mixture.
- 8 (D) EXCEPT AS PROVIDED IN SUBSECTION (4), USE OR ATTEMPT TO
- 9 USE A FALSE IDENTIFICATION OR THE IDENTIFICATION OF ANOTHER PERSON
- 10 TO PURCHASE A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR

- 1 PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
- 2 PSEUDOEPHEDRINE.
- 3 (2) A person who violates this section is guilty of a crime as
- 4 follows:
- 5 (a) A person who violates subsection (1)(a) or (b) is quilty
- 6 of a misdemeanor punishable by imprisonment for not more than 93
- 7 days or a fine of not more than \$500.00, or both.
- 8 (b) A person who violates subsection (1)(c) is guilty of a
- 9 felony punishable by imprisonment for not more than 2 years or a
- 10 fine of not more than \$2,000.00, or both.
- 11 (C) A PERSON WHO VIOLATES SUBSECTION (1) (D) IS GUILTY OF A
- 12 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 13 A FINE OF NOT MORE THAN \$100.00, OR BOTH.
- 14 (3) This section SUBSECTION (1) (A) TO (C) does not apply to
- 15 any of the following:
- 16 (a) A person who possesses ephedrine or pseudoephedrine
- 17 pursuant to a license issued by this state or the United States to
- 18 manufacture, deliver, dispense, possess with intent to manufacture
- 19 or deliver, or possess a controlled substance, prescription drug,
- 20 or other drug.
- 21 (b) An individual who possesses ephedrine or pseudoephedrine
- 22 pursuant to a prescription.
- (c) A person who possesses ephedrine or pseudoephedrine for
- 24 retail sale pursuant to a license issued under the general sales
- 25 tax act, 1933 PA 167, MCL 205.51 to 205.78.
- 26 (d) A person who possesses ephedrine or pseudoephedrine in the
- 27 course of his or her business of selling or transporting ephedrine

- 1 or pseudoephedrine to a person described in subdivision (a) or (c).
- 2 (e) A person who, in the course of his or her business, stores
- 3 ephedrine or pseudoephedrine for sale or distribution to a person
- 4 described in subdivision (a), (c), or (d).
- (f) Any product that the state board of pharmacy, upon
- 6 application of a manufacturer, exempts from this section because
- 7 the product has been formulated in such a way as to effectively
- 8 prevent the conversion of the active ingredient into
- 9 methamphetamine.
- 10 (g) Possession of any pediatric product primarily intended for
- 11 administration to children under 12 years of age according to label
- 12 instructions.
- 13 (4) SUBSECTION (1) (D) DOES NOT APPLY TO A PERSON WHO
- 14 PARTICIPATES IN EITHER OF THE FOLLOWING:
- 15 (A) AN UNDERCOVER OPERATION IN WHICH THE INDIVIDUAL PURCHASES
- 16 OR RECEIVES A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR
- 17 PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
- 18 PSEUDOEPHEDRINE AS DESCRIBED IN SUBSECTION (1) UNDER THE DIRECTION
- 19 OF THE PERSON'S EMPLOYER AND WITH THE PRIOR APPROVAL OF THE LOCAL
- 20 PROSECUTOR'S OFFICE AS PART OF AN EMPLOYER-SPONSORED INTERNAL
- 21 ENFORCEMENT ACTION.
- 22 (B) AN UNDERCOVER OPERATION IN WHICH THE INDIVIDUAL PURCHASES
- 23 OR RECEIVES A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR
- 24 PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
- 25 PSEUDOEPHEDRINE AS DESCRIBED IN SUBSECTION (1) UNDER THE DIRECTION
- 26 OF THE STATE POLICE OR LOCAL LAW ENFORCEMENT AGENCY AS PART OF AN
- 27 ENFORCEMENT ACTION UNLESS THE INITIAL OR CONTEMPORANEOUS PURCHASE

- 1 OR RECEIPT OF A PRODUCT THAT CONTAINS ANY COMPOUND, MIXTURE, OR
- 2 PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
- PSEUDOEPHEDRINE BY THE PERSON WAS NOT UNDER THE DIRECTION OF THE 3
- 4 STATE POLICE OR LOCAL LAW ENFORCEMENT AGENCY AND WAS NOT PART OF
- 5 THE UNDERCOVER OPERATION.
