SENATE BILL NO. 210

A bill to amend 2000 PA 274, entitled "Large carnivore act,"

by amending section 22 (MCL 287.1122).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 22. (1) Sections 4, 5, and 6 do not apply to any of the
- 2 following:
- 3 (a) An animal control shelter or animal protection shelter.
- 4 (b) A person licensed or approved by the department of natural
- 5 resources of this state or by the United States fish and wildlife
- 6 service of the United States department of the interior. This
- 7 subdivision does not apply to a person in possession of 1 or more
- 8 black bears under the authority of a permit to hold wildlife in
- 9 captivity issued by the department of natural resources.
- 10 (c) A zoological park approved or accredited by the American

- 1 zoo and aquarium association.
- 2 (d) A person approved by the association of sanctuaries or the
- 3 American sanctuary association.
- 4 (e) A law enforcement officer acting under the authority of
- 5 this act.
- 6 (f) A veterinarian temporarily in possession of a large
- 7 carnivore to provide veterinary care for or humanely euthanize the
- 8 large carnivore.
- 9 (G) A PERSON WHO IS LICENSED BY THE UNITED STATES DEPARTMENT
- 10 OF AGRICULTURE AND WHOSE FACILITIES ARE ACCREDITED BY THE
- 11 ZOOLOGICAL ASSOCIATION OF AMERICA.
- 12 (2) Sections 4, 5, 6(1)(d) to (5)(d), 8, and 14(3) do not
- 13 apply to a person who is not a resident of this state and who is in
- 14 this state only for the purpose of travel between locations outside
- 15 of this state.
- 16 (3) Subject to subsection (2), this act does not apply to a
- 17 person who meets all of the following requirements:
- 18 (a) Is conducting a for-profit or nonprofit business that
- 19 meets both of the following requirements:
- 20 (i) The primary purpose of the business is the presentation of
- 21 animals including large carnivores to the public for education or
- 22 exhibition purposes.
- 23 (ii) The business is not conducted in connection with another
- 24 business as a means of attracting customers to that other business.
- 25 (b) Is a class C licensee that possesses and maintains a class
- 26 C license under 9 C.F.R. CFR 1.1.
- (c) Meets or exceeds all standards, including but not limited

- 1 to standards for training, housing, care, and transport of large
- 2 carnivores, required of a class C licensee under 9 C.F.R. CFR 1.1.
- 3 (d) Does not allow a patron to do any of the following:
- 4 (i) Come into direct contact with a large carnivore.
- 5 (ii) Come into close enough contact with a large carnivore over
- 6 20 weeks of age so as to place the patron in jeopardy of being
- 7 harmed by the large carnivore.
- 8 (e) Does not sell large carnivores, except to another person
- 9 that meets the requirements of this subsection.
- 10 (f) Does not breed large carnivores.
- 11 (4) This act does not apply to a circus.
