14	Sec. 201. Pursuant to section 30 of article IX of the state
15	constitution of 1963, total state spending from state resources

- 2 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- 3 to 18.1594.
- 4 Sec. 203. As used in this act:
- 5 (a) "Department" means the department of environmental
- 6 quality.
- 7 (b) "Director" means the director of the department.
- 8 (c) "FTE" means full-time equated.
- 9 Sec. 205. Unless otherwise specified, the department shall use
- 10 the Internet to fulfill the reporting requirements of this act.
- 11 This requirement may include transmission of reports via electronic
- 12 mail to the recipients identified for each reporting requirement,
- 13 or it may include placement of reports on an Internet or Intranet
- **14** site.
- 15 Sec. 207. The department and agencies receiving appropriations
- 16 in part 1 shall receive and retain copies of all reports funded
- 17 from appropriations in part 1. Federal and state guidelines for
- 18 short-term and long-term retention of records shall be followed.

- 2 the attorney general. This prohibition does not apply to legal
- 3 services for bonding activities and for those activities that the
- 4 attorney general authorizes.
- 5 Sec. 215. (1) In addition to the funds appropriated in part 1,
