SUBSTITUTE FOR

SENATE BILL NO. 502

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 513a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 513A. (1) BEGINNING OCTOBER 1, 2011, THE COMMISSION MAY
- 2 ISSUE TO THE GOVERNING BOARD OF A COMMUNITY COLLEGE OR UNIVERSITY
- 3 THAT IS ACCREDITED BY THE HIGHER LEARNING COMMISSION AND THAT
- 4 OPERATES AN ACCREDITED CULINARY OR HOSPITALITY PROGRAM, WITHOUT
- 5 REGARD TO THE QUOTA PROVISIONS OF SECTION 531, A LICENSE TO SELL
- 6 ALCOHOLIC LIQUOR FOR CONSUMPTION AT THE COMMUNITY COLLEGE'S OR
- 7 UNIVERSITY'S CULINARY OR HOSPITALITY PROGRAM'S LOCATION FOR
- 8 ACTIVITIES THAT FURTHER THE COMMUNITY COLLEGE'S OR UNIVERSITY'S
- 9 COMMUNITY OR ACADEMIC MISSION.
- 10 (2) THE SALE OF ALCOHOLIC LIQUOR TO PATRONS AT A LOCATION

- 1 OTHER THAN THE COMMUNITY COLLEGE'S OR UNIVERSITY'S CULINARY OR
- 2 HOSPITALITY PROGRAM'S LOCATION OR AT ACTIVITIES THAT DO NOT FURTHER
- 3 THE COMMUNITY COLLEGE'S OR UNIVERSITY'S COMMUNITY OR ACADEMIC
- 4 MISSION, INCLUDING, BUT NOT LIMITED TO, PUBLIC AND PRIVATE
- 5 GATHERINGS OR MEETINGS THAT DO NOT HAVE A DIRECT CORRELATION TO THE
- 6 COMMUNITY COLLEGE'S OR UNIVERSITY'S COMMUNITY OR ACADEMIC MISSION,
- 7 IS PROHIBITED UNDER THIS SECTION.
- 8 (3) TO OBTAIN A LICENSE UNDER THIS SECTION, A COMMUNITY
- 9 COLLEGE OR UNIVERSITY SHALL SUBMIT BOTH OF THE FOLLOWING TO THE
- 10 COMMISSION:
- 11 (A) DOCUMENTATION VERIFYING THAT THE COMMUNITY COLLEGE OR
- 12 UNIVERSITY IS ACCREDITED BY THE HIGHER LEARNING COMMISSION.
- 13 (B) EITHER OF THE FOLLOWING:
- 14 (i) DOCUMENTATION VERIFYING THAT THE COMMUNITY COLLEGE'S OR
- 15 UNIVERSITY'S CULINARY OR HOSPITALITY PROGRAM IS ACCREDITED BY A
- 16 REGIONALLY RECOGNIZED ACCREDITING BODY.
- 17 (ii) A COPY OF THE COMMUNITY COLLEGE'S OR UNIVERSITY'S
- 18 APPLICATION TO A REGIONALLY RECOGNIZED ACCREDITING BODY FOR
- 19 ACCREDITATION OF ITS CULINARY OR HOSPITALITY PROGRAM.
- 20 (4) THE COMMISSION MAY REVOKE A LICENSE ISSUED UNDER THIS
- 21 SECTION IF, WITHIN 2 YEARS OF APPLYING FOR A LICENSE UNDER THIS
- 22 SECTION, THE COMMUNITY COLLEGE'S OR UNIVERSITY'S CULINARY OR
- 23 HOSPITALITY PROGRAM IS NOT ACCREDITED BY A REGIONALLY RECOGNIZED
- 24 ACCREDITING BODY.
- 25 (5) A LIQUOR LICENSE ISSUED UNDER THIS SECTION SHALL BE
- 26 GRANTED AND REGISTERED TO THE COMMUNITY COLLEGE'S OR UNIVERSITY'S
- 27 CULINARY OR HOSPITALITY PROGRAM'S LOCATION.

- 1 (6) A LIQUOR LICENSE ISSUED UNDER THIS SECTION SHALL BE USED
- 2 BY THE COMMUNITY COLLEGE OR UNIVERSITY AND NOT BY A PRIVATE ENTITY.
- 3 (7) A COMMUNITY COLLEGE OR UNIVERSITY THAT HOLDS A LIQUOR
- 4 LICENSE UNDER THIS SECTION SHALL NOT OBTAIN A CATERING PERMIT UNDER
- 5 SECTION 547.
- 6 (8) AS USED IN THIS SECTION:
- 7 (A) "COMMUNITY COLLEGE" MEANS A COMMUNITY COLLEGE ESTABLISHED
- 8 UNDER THE COMMUNITY COLLEGE ACT OF 1966, 1966 PA 331, MCL 389.1 TO
- 9 389.195.
- 10 (B) "UNIVERSITY" MEANS A PUBLIC UNIVERSITY DESCRIBED IN
- 11 SECTION 4, 5, OR 6 OF ARTICLE VIII OF THE STATE CONSTITUTION OF
- 12 1963.
