SUBSTITUTE FOR

SENATE BILL NO. 642

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81F. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN INDIVIDUAL
- 3 WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS A HEALTH
- 4 CARE PROFESSIONAL OR BECAUSE OF THE INDIVIDUAL'S STATUS AS A HEALTH
- 5 CARE PROFESSIONAL IS GUILTY OF A MISDEMEANOR PUNISHABLE BY
- 6 IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF NOT MORE THAN
- 7 \$1,000.00, OR BOTH.
- 8 (2) EXCEPT AS PROVIDED IN SUBSECTION (3), A PERSON WHO
- 9 ASSAULTS OR ASSAULTS AND BATTERS AN INDIVIDUAL WHILE THE INDIVIDUAL
- 10 IS PERFORMING HIS OR HER DUTIES AS A HEALTH CARE PROFESSIONAL OR

- 1 BECAUSE OF THE INDIVIDUAL'S STATUS AS A HEALTH CARE PROFESSIONAL
- 2 AND CAUSES THE INDIVIDUAL ANY BODILY INJURY REQUIRING MEDICAL
- 3 ATTENTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
- 4 MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 5 (3) A PERSON WHO ASSAULTS OR ASSAULTS AND BATTERS AN
- 6 INDIVIDUAL WHILE THE INDIVIDUAL IS PERFORMING HIS OR HER DUTIES AS
- 7 HEALTH CARE PROFESSIONAL OR BECAUSE OF THE INDIVIDUAL'S STATUS AS A
- 8 HEALTH CARE PROFESSIONAL AND CAUSES THE INDIVIDUAL SERIOUS
- 9 IMPAIRMENT OF BODY FUNCTION IS GUILTY OF A FELONY PUNISHABLE BY
- 10 IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF NOT LESS THAN
- 11 \$1,000.00 OR MORE THAN \$5,000.00, OR BOTH.
- 12 (4) A CONVICTION OR SENTENCE IMPOSED FOR A VIOLATION OF THIS
- 13 SECTION DOES NOT PRECLUDE A CONVICTION OR SENTENCE FOR A VIOLATION
- 14 OF ANY OTHER APPLICABLE LAW.
- 15 (5) AS USED IN THIS SECTION:
- 16 (A) "HEALTH CARE PROFESSIONAL" MEANS ANY OF THE FOLLOWING:
- 17 (i) AN EMERGENCY MEDICAL TECHNICIAN.
- 18 (ii) AN AMBULANCE OPERATOR OR AMBULANCE ATTENDANT.
- 19 (iii) A NURSE.
- 20 (iv) A PHYSICAL THERAPIST.
- 21 (v) AN OCCUPATIONAL THERAPIST.
- 22 (vi) A PHYSICIAN.
- 23 (vii) A PHYSICIAN'S ASSISTANT.
- 24 (B) "SERIOUS IMPAIRMENT OF BODY FUNCTION" MEANS THAT PHRASE AS
- 25 DEFINED IN SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300,
- 26 MCL 257.58C.
