SUBSTITUTE FOR

SENATE BILL NO. 779

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 225.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 225. (1) EXCEPT AS PROVIDED IN SUBSECTION (3), A PERSON
- 2 SHALL NOT POSSESS EITHER OF THE FOLLOWING:
- 3 (A) AN IMITATION FIREARM FROM WHICH THE COLORED MARKINGS
- 4 REQUIRED UNDER THE LAWS OF THIS STATE OR OF THE UNITED STATES ON A
- 5 TOY, LOOK-ALIKE, OR IMITATION FIREARM HAVE BEEN REMOVED, DISGUISED,
- 6 CLOAKED, COVERED, CONCEALED, OR MASKED.
- 7 (B) A FIREARM TO WHICH ANY COLOR OR MARKINGS THAT ARE REQUIRED
- 8 ON AN IMITATION FIREARM UNDER THE LAWS OF THIS STATE OR OF THE
- 9 UNITED STATES HAVE BEEN ADDED OR INSTALLED IN A WAY THAT MAKES THE

- 1 FIREARM LOOK MORE LIKE AN IMITATION FIREARM.
- 2 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A CRIME
- 3 AS FOLLOWS:
- 4 (A) A PERSON WHO VIOLATES SUBSECTION (1) (A) AND WHO USES THE
- 5 ALTERED TOY, LOOK-ALIKE, OR IMITATION FIREARM TO COMMIT A
- 6 MISDEMEANOR IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT
- 7 FOR NOT MORE THAN 93 DAYS OR A FINE OF NOT MORE THAN \$100.00, OR
- 8 BOTH.
- 9 (B) A PERSON WHO VIOLATES SUBSECTION (1) (A) AND WHO USES THE
- 10 ALTERED TOY, LOOK-ALIKE, OR IMITATION FIREARM TO COMMIT A FELONY IS
- 11 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 18
- 12 MONTHS OR A FINE OF NOT MORE THAN \$10,000.00, OR BOTH.
- 13 (C) A PERSON WHO VIOLATES SUBSECTION (1) (B) IS GUILTY OF A
- 14 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 15 A FINE OF NOT MORE THAN \$100.00, OR BOTH.
- 16 (D) A PERSON WHO VIOLATES SUBSECTION (1) (B) WHILE THE PERSON
- 17 COMMITS A FELONY IS GUILTY OF A VIOLATION OF SECTION 227B.
- 18 (3) THIS SECTION DOES NOT APPLY TO A MANUFACTURER, IMPORTER,
- 19 OR DISTRIBUTOR OF IMITATION FIREARMS OR TO THE LAWFUL USE OF AN
- 20 IMITATION FIREARM IN A MOTION PICTURE, TELEVISION, STAGE, OR OTHER
- 21 THEATRICAL PRODUCTION.
- 22 (4) A CONVICTION OR SENTENCE IMPOSED FOR A VIOLATION OF THIS
- 23 SECTION DOES NOT PRECLUDE A CONVICTION OR SENTENCE FOR A VIOLATION
- 24 OF ANY OTHER APPLICABLE LAW.
- 25 (5) AS USED IN THIS SECTION:
- 26 (A) "BB GUN" MEANS A SMOOTH BORE RIFLE OR HANDGUN DESIGNED AND
- 27 MANUFACTURED EXCLUSIVELY TO PROPEL BBS THAT DO NOT EXCEED .177

- CALIBER BY A SPRING OR BY GAS OR AIR. 1
- 2 (B) "FIREARM" MEANS THAT TERM AS DEFINED IN SECTION 222.
- (C) "IMITATION FIREARM" MEANS A BB GUN, TOY GUN, REPLICA OF A 3
- FIREARM, OR OTHER DEVICE THAT IS SO SUBSTANTIALLY SIMILAR IN
- 5 COLORATION AND OVERALL APPEARANCE TO AN EXISTING FIREARM AS TO LEAD
- A REASONABLE PERSON TO PERCEIVE THAT THE DEVICE IS A FIREARM.
- Enacting section 1. This amendatory act takes effect 90 days 7
- after the date it is enacted into law. 8
