

**HOUSE SUBSTITUTE FOR
SENATE BILL NO. 949**

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 201 and 206 (MCL 388.1801 and 388.1806), as
added by 2011 PA 62.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 201. (1) Subject to the conditions set forth in this
2 article, the amounts listed in subsection (2) are appropriated for
3 community colleges for the fiscal year ending September 30, ~~2012,~~
4 **2013**, from the funds indicated in this section. The following is a
5 summary of the appropriations in subsection (2):

6 (a) The gross appropriation is ~~\$283,880,500.00.~~ **\$100.00.** After
7 deducting total interdepartmental grants and intradepartmental
8 transfers in the amount of \$0.00, the adjusted gross appropriation
9 is ~~\$283,880,500.00.~~ **\$100.00.**

(b) The sources of the adjusted gross appropriation described in subdivision (a) are as follows:

(i) Total federal revenues, \$0.00.

(ii) Total local revenues, \$0.00.

20 appropriated for community colleges with fiscal years ending June
21 30, ~~2012–2013~~ and shall be paid out of the state treasury and
22 distributed by the state treasurer to the respective community
23 colleges in 11 monthly installments on the sixteenth of each month,
24 or the next succeeding business day, beginning with October 16,
25 ~~2011–2012~~. Each community college shall accrue its July and August
26 ~~2012–2013~~ payments to its institutional fiscal year ending June 30,
27 ~~2012–2013~~. However, if a community college fails to submit all
