HOUSE SUBSTITUTE FOR SENATE BILL NO. 1112

A bill to amend 1975 PA 238, entitled "Child protection law,"

(MCL 722.621 to 722.638) by adding section 12b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 12B. (1) THE TASK FORCE ON THE PREVENTION OF SEXUAL ABUSE
- OF CHILDREN IS CREATED WITHIN THE DEPARTMENT.
- 3 (2) THE GOVERNOR SHALL APPOINT MEMBERS TO THE TASK FORCE IN
- 4 CONSULTATION WITH THE DEPARTMENT. THE APPOINTMENT OF MEMBERS MUST
- 5 REFLECT THE GEOGRAPHIC DIVERSITY OF THIS STATE. MEMBERS OF THE TASK
- 6 FORCE MUST INCLUDE THE FOLLOWING:
- 7 (A) INDIVIDUALS WHO HAVE EXPERIENCE AND EXPERTISE IN THE
- 8 FIELDS OF INTERVENTION AND PREVENTION OF CHILD ABUSE AND NEGLECT,
- 9 EDUCATION, OR CHILD WELFARE.
- 10 (B) A REPRESENTATIVE FROM THE MICHIGAN COALITION TO END
- 11 DOMESTIC AND SEXUAL VIOLENCE.
- 12 (C) A REPRESENTATIVE FROM THE MICHIGAN DOMESTIC AND SEXUAL

- 1 VIOLENCE PREVENTION AND TREATMENT BOARD.
- 2 (D) A REPRESENTATIVE FROM THE MICHIGAN CHAPTER OF THE NATIONAL
- 3 CHILDREN'S ALLIANCE.
- 4 (E) AN ADMINISTRATOR OR STAFF MEMBER OF A CHILD ASSESSMENT
- 5 CENTER.
- 6 (F) A LICENSED THERAPIST TRAINED TO COUNSEL OR TREAT CHILD
- 7 SEXUAL ABUSE VICTIMS.
- 8 (G) A CIRCUIT COURT JUDGE OR HIS OR HER DESIGNEE.
- 9 (H) A SCHOOL DISTRICT BOARD MEMBER, INTERMEDIATE SCHOOL
- 10 DISTRICT BOARD MEMBER, OR PUBLIC SCHOOL ACADEMY BOARD MEMBER.
- 11 (3) THE DEPARTMENT DIRECTOR OR HIS OR HER DESIGNEE SHALL SERVE
- 12 AS THE TASK FORCE'S PRESIDING OFFICER. THE TASK FORCE SHALL MEET AT
- 13 THE CALL OF THE PRESIDING OFFICER. THE TASK FORCE SHALL MAKE
- 14 RECOMMENDATIONS FOR REDUCING CHILD SEXUAL ABUSE IN THIS STATE. THE
- 15 TASK FORCE SHALL ALSO MAKE RECOMMENDATIONS FOR SCHOOL POLICIES THAT
- 16 ADDRESS THE SEXUAL ABUSE OF CHILDREN. IN MAKING THOSE
- 17 RECOMMENDATIONS, THE TASK FORCE SHALL DO ALL OF THE FOLLOWING:
- 18 (A) GATHER INFORMATION CONCERNING CHILD SEXUAL ABUSE
- 19 THROUGHOUT THIS STATE.
- 20 (B) RECEIVE REPORTS AND TESTIMONY FROM INDIVIDUALS, STATE AND
- 21 LOCAL AGENCIES, COMMUNITY-BASED ORGANIZATIONS, AND OTHER PUBLIC AND
- 22 PRIVATE ORGANIZATIONS.
- 23 (C) REVIEW STEPS TAKEN AND PROGRAMS ESTABLISHED IN OTHER
- 24 STATES TO REDUCE CHILD SEXUAL ABUSE.
- 25 (D) CREATE GOALS FOR STATE POLICY THAT ARE AIMED AT PREVENTING
- 26 CHILD SEXUAL ABUSE.
- 27 (E) CREATE RECOMMENDATIONS AND GUIDELINES FOR SCHOOL POLICIES

- 1 ADDRESSING SEXUAL ABUSE OF CHILDREN ACCORDING TO SECTION 1505 OF
- 2 THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1505. THESE
- 3 RECOMMENDATIONS AND GUIDELINES SHALL BE FLEXIBLE ENOUGH TO ALLOW
- 4 ACCOMMODATION FOR LOCAL AUTONOMY AND VALUES.
- 5 (F) CREATE RECOMMENDATIONS AND GUIDELINES FOR AGE-APPROPRIATE,
- 6 EVIDENCE-BASED CHILD SEXUAL ABUSE AWARENESS.
- 7 (G) CREATE RECOMMENDATIONS AND GUIDELINES FOR SCHOOL PERSONNEL
- 8 TO RESPOND APPROPRIATELY TO PUPILS AFFECTED BY SEXUAL ABUSE.
- 9 (H) CREATE RECOMMENDATIONS AND GUIDELINES FOR PROVIDING
- 10 EDUCATIONAL MATERIAL TO PARENTS AND GUARDIANS ON THE WARNING SIGNS
- 11 OF CHILD SEXUAL ABUSE AND INFORMATION ON ASSISTANCE AND REFERRALS
- 12 OR RESOURCES.
- 13 (I) DEVELOP A CHILD SEXUAL ABUSE PROTOCOL TO BE UTILIZED BY
- 14 ALL COMMUNITY PARTNERS IN ORDER TO HELP TO IDENTIFY, PREVENT, AND
- 15 INVESTIGATE CHILD SEXUAL ABUSE.
- 16 (J) SUBMIT A FINAL REPORT WITH THE TASK FORCE'S
- 17 RECOMMENDATIONS TO THE GOVERNOR AND THE LEGISLATURE NOT LATER THAN
- 18 365 DAYS AFTER THE MEMBERS OF THE TASK FORCE ARE APPOINTED.
- 19 (4) THE RECOMMENDATIONS DESCRIBED UNDER SUBSECTION (3) MAY
- 20 INCLUDE PROPOSALS FOR SPECIFIC STATUTORY CHANGES AND METHODS TO
- 21 FOSTER COOPERATION AMONG STATE AGENCIES AND BETWEEN THE STATE AND
- 22 LOCAL GOVERNMENT.
- 23 (5) THE TASK FORCE SHALL CONSULT WITH THE EMPLOYEES OF THE
- 24 DEPARTMENT WHO WORK ON CHILD PROTECTION MATTERS, THE DEPARTMENT OF
- 25 STATE POLICE, THE STATE BOARD OF EDUCATION, AND ANY OTHER STATE
- 26 AGENCY OR DEPARTMENT NECESSARY TO ACCOMPLISH THE TASK FORCE'S
- 27 RESPONSIBILITIES UNDER THIS SECTION.

- (6) THE MEMBERS OF THE TASK FORCE SHALL SERVE WITHOUT 1
- 2 COMPENSATION AND SHALL NOT BE REIMBURSED FOR THEIR EXPENSES.
- 3 (7) THE TASK FORCE SHALL BE ABOLISHED UPON SUBMISSION OF THE
- FINAL REPORT REQUIRED IN SUBSECTION (3) TO THE GOVERNOR AND THE 4
- 5 LEGISLATURE.
- (8) UPON WRITTEN REQUEST FROM A CHILD OR THE CHILD'S PARENT OR 6
- 7 LEGAL GUARDIAN, THAT CHILD SHALL BE EXCUSED, WITHOUT PENALTY, FROM
- PARTICIPATING IN THE TASK FORCE'S INFORMATION-GATHERING EFFORTS. 8
- (9) AS USED IN THIS SECTION, "TASK FORCE" MEANS THE TASK FORCE 9
- 10 ON THE PREVENTION OF SEXUAL ABUSE OF CHILDREN CREATED IN SUBSECTION
- 11 (1).
- 12 Enacting section 1. This amendatory act does not take effect
- unless Senate Bill No. 1113 of the 96th Legislature is enacted into 13
- 14 law.
