SUBSTITUTE FOR

SENATE BILL NO. 962

A bill to make appropriations for the department of state police and certain other state purposes for the fiscal year ending September 30, 2013; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide for certain emergency powers; to provide for the powers and duties of certain committees, certain state agencies, and certain employees; and to provide for the acquisition and disposition of certain real and personal property.

- 2 (a) "CJIS" means the criminal justice information system.

- 3 (b) "Department" means the department of state police.
- 4 (c) "DNA" means deoxyribonucleic acid.
- 5 (d) "FEMA" means the federal emergency management agency.
- 6 (e) "IDG" means interdepartmental grant.
- 7 (f) "IDT" means intradepartmental transfer.
- 8 (g) "LEIN" means the law enforcement information network.
- 9 (h) "MCOLES" means Michigan commission on law enforcement
- 10 standards.
- 11 (i) "MPSCS" means Michigan public safety communications
- 12 system.
- Sec. 204. The following shall constitute the appropriations
- 14 from part 1 for interdepartmental grant funds received by the
- department from sources outside the department: \$2,601,300.00 from
- 16 training academy charges; \$176,800.00 from the department of

- 4 (4) In addition to the funds appropriated in part 1, there is
- 5 appropriated an amount not to exceed \$200,000.00 for private
- 6 contingency funds. These funds are not available for expenditure
- 7 until they have been transferred to another line item in this act
- 8 under section 393(2) of the management and budget act, 1984 PA 431,
- **9** MCL 18.1393.
- 10 Sec. 209. Funds appropriated in part 1 shall not be used for
- 11 the purchase of foreign goods or services, or both, if
- 12 competitively priced and of comparable quality American goods or
- 13 services, or both, are available. Preference should be given to
- 14 goods or services, or both, manufactured or provided by Michigan
- 15 businesses, if they are competitively priced and of comparable
- 16 quality. In addition, preference should be given to goods or
- 17 services, or both, that are manufactured or provided by Michigan
- 18 businesses owned and operated by veterans, if they are
- 19 competitively priced and of comparable quality.
- 20 Sec. 210. The department shall take all reasonable steps to
- 21 ensure businesses in deprived and depressed communities compete for
- 22 and perform contracts to provide services or supplies, or both, for
- 23 the department. The director of the department shall strongly
- 24 encourage firms with which the department contracts to subcontract
- 25 with certified businesses in depressed and deprived communities for
- 26 services or supplies, or both.
- 27 Sec. 212. The departments and agencies receiving

- 1 appropriations in part 1 shall receive and retain copies of all
- 2 reports funded from appropriations in part 1. Federal and state
- 3 guidelines for short-term and long-term retention of records shall
- 4 be followed. The department may electronically retain copies of
- 5 reports unless otherwise required by federal and state guidelines.
- 6 Sec. 215. The department shall not take disciplinary action

- 12 (2) Notwithstanding any other provisions of this act, the

- 14 from the funding entities listed.
- 15 (3) The secondary road patrol funding is not subject to
- 16 funding flexibility and shall be funded in accordance with section
- 17 629e of the Michigan vehicle code, 1949 PA 300, MCL 257.629e.
- 18 (4) Any funding required by statute is not subject to funding
- 19 flexibility and shall be funded in accordance with that statute.
- Sec. 217. The department shall improve its budgetary
- 21 efficiency pertaining to the delivery of core services delineated
- 22 in section 221 by doing all of the following:
- 23 (a) Prioritizing personnel over buildings in budgetary
- 24 efficiency considerations.
- 25 (b) Pursuing the physical or virtual consolidation of support
- 26 service functions such as information technology, human resources,
- 27 and accounting as a means of improving standardization and

- 1 efficiency.
- 2 (c) Seeking expenditure reductions whenever possible through

- 3 the streamlining of existing service delivery activities.
- 4 (d) Identifying efficiencies that can be gained via the
- 5 reduction or elimination of programs, policies, and practices which
- 6 have outlived their usefulness.
- 7 Sec. 219. (1) The department shall be available to meet on a
- 8 quarterly basis before the appropriate senate and house
- 9 appropriations subcommittees.
- 10 (2) The department shall provide all information necessary to
- 11 validate that the requirements of this part have been achieved.
- 12 (3) The department shall provide a corrective action plan
- 13 within 30 days of a quarterly report under this section for any
- 14 requirements of this part that have not been achieved. The
- 15 department shall provide a monthly status of correction action
- 16 plans.
- 17 (4) The department shall provide a summary of fund shifts,
- 18 that have been approved by the state budget office, that have
- 19 occurred between items listed in the schedule of programs mentioned
- 20 in part 1 on a quarterly basis to the senate and house
- 21 appropriations subcommittees.
- 22 (5) The department shall provide the following data to the
- 23 appropriate senate and house appropriations subcommittees:
- 24 (a) A list of major work projects, including the status of
- 25 each project.
- 26 (b) The department's financial status, featuring a report of
- 27 budgeted versus actual expenditures by part 1 line item including a

- 1 year-end projection of budget requirements. If projected department
- 2 budget requirements exceed the allocated budget, the report shall
- 3 include a plan to reduce overall expenses while still satisfying
- 4 specified service level requirements.
- 5 (c) Forensic laboratory system staffing levels and vacancies
- 6 and backlogs in all disciplines.
- 7 Sec. 220. The department shall provide the following data to
- 8 the appropriate senate and house appropriations subcommittees on an
- 9 annual basis:
- 10 (a) As it pertains to inspections conducted by the traffic
- 11 safety division, all of the following:
- 12 (i) The number of buses and vehicles inspected by the
- 13 department.
- 14 (ii) The number of buses and vehicles passing and failing
- 15 inspection.
- 16 (iii) The estimated number of buses and vehicles not inspected.
- 17 (b) A report on the status of assessments collected and
- 18 authorized under section 629e of the Michigan vehicle code, 1949 PA
- 19 300, MCL 257.629e, for the purpose of supporting the secondary road
- 20 patrol grant program. The report shall contain updated information
- 21 on collection levels, revised projected grant allotments to
- 22 counties for the year, a comparison of projected collections and
- 23 grant distribution levels with the funds appropriated in part 1 for
- 24 the secondary road patrol program, and the extent collection levels
- 25 have exceeded or failed to meet appropriated levels for the current
- 26 fiscal year or expenditure levels from the previous fiscal year.
- 27 Sec. 221. The appropriations in part 1 are for the core

- 1 services, support services, and work projects of the department,
- 2 including, but not limited to, the following core services: traffic

- 3 safety and enforcement, complaint and criminal investigations, fire
- 4 investigation, sex offender registry and enforcement, specialty
- 5 teams, civil disorder response mobilization, capitol security,
- 6 hazardous materials response training, intelligence gathering and
- 7 dissemination, state emergency operations center, criminal history
- 8 system, fingerprint and background checks, the law enforcement
- 9 information network, forensics, training and recruiting, and
- 10 establishing and monitoring law enforcement standards.
- 11 Sec. 222. The department shall notify the senate and house
- 12 appropriations subcommittees on state police and military and
- 13 veterans affairs and the senate and house fiscal agencies not less
- 14 than 90 days before recommending to close or consolidate any state
- 15 police posts. The notification shall include a local and state
- 16 impact study of the proposed post closure or consolidation.
- 17 Sec. 223. At least 60 days before beginning any effort to
- 18 privatize, the department shall submit a complete project plan to
- 19 the appropriate senate and house fiscal agencies. The plan shall
- 20 include the criteria under which the privatization initiative will
- 21 be evaluated. The evaluation shall be completed and submitted to
- 22 the appropriate senate and house appropriations subcommittees and
- 23 the senate and house fiscal agencies within 30 months.
- 24 Sec. 224. Funds appropriated in part 1 shall not be used by a
- 25 principal executive department, state agency, or authority to hire
- 26 a person to provide legal services that are the responsibility of
- 27 the attorney general. This prohibition does not apply to legal

- 1 services for bonding activities and for those activities that the
- 2 attorney general authorizes.
- 3 Sec. 225. (1) When the department provides contractual
- 4 services to a local unit of government, the department shall be
- 5 reimbursed for all costs incurred in providing the services,
- 6 including, but not limited to, retirement and overtime costs.
- 7 (2) The department shall define service cost models for those
- 8 services requiring reimbursement.
- 9 Sec. 227. The department shall define interoperability
- 10 standards to ensure effective communication between state, local,
- 11 regional, and federal agencies under public safety scenarios. The
- 12 department shall monitor compliance with these interoperability
- 13 standards by the agencies and notify the legislature and pertinent
- 14 agency management of noncompliance within 30 days of this
- 15 determination.
- 16 Sec. 228. Not later than November 15, the department shall
- 17 prepare and transmit a report that provides for estimates of the
- 18 total general fund/general purpose appropriations lapses at the
- 19 close of the fiscal year. This report shall summarize the projected
- 20 year-end general fund/general purpose appropriations lapses by
- 21 major departmental program or program areas. The report shall be
- 22 transmitted to the office of the state budget, the chairperson of
- 23 the senate and house standing committees on appropriations, and the
- 24 senate and house fiscal agencies.
- 25 Sec. 229. Within 14 days after the release of the executive
- 26 budget recommendation, the department shall provide the state
- 27 budget director, the senate and house appropriations chairs, the

- 1 senate and house appropriations subcommittees on state police and
- 2 military and veterans affairs, respectively, and the senate and
- 3 house fiscal agencies with an annual report on estimated state
- 4 restricted fund balances, state restricted fund projected revenues,
- 5 and state restricted fund expenditures for the fiscal years ending
- 6 September 30, 2012 and September 30, 2013.
- 7 Sec. 230. The department may pursue entering into an agreement
- 8 with Calhoun County to build a new facility in that county which
- 9 would serve as the new state police post for region 4 of district
- 10 5, as identified by the department.
- 11 Sec. 231. The department, in keeping with its role as the
- 12 general law enforcement agency of the state and as the law
- 13 enforcement agency of last resort for communities that are either
- 14 without local law enforcement resources or are seriously
- 15 underserved by local law enforcement resources, shall provide
- 16 general law enforcement assistance to those communities until
- 17 adequate law enforcement services can be provided to those
- 18 communities by other means.
- 19 Sec. 232. The department shall serve as an active liaison
- 20 between the department of technology, management, and budget and
- 21 local public safety agencies to facilitate the use of the MPSCS
- 22 towers by those local public safety agencies that have an interest
- 23 in using the towers as a part of their communication system.

24 SCIENCE, TECHNOLOGY, AND TRAINING BUREAU

- Sec. 301. (1) The department shall provide forensic testing
- 26 services to aid in criminal investigations.

- 1 (2) The department shall maintain the staffing and resources
- 2 necessary to provide forensic evidence with an average turnaround
- 3 time of 82 days assuming an annual caseload volume commensurate
- 4 with that received in fiscal year 2009-2010.
- 5 (3) The department shall hire and train 20 additional forensic
- 6 employees with the intent of reaching an average 30-day turnaround
- 7 for forensic evidence.
- 8 (4) If changes are made to the department's protocol for
- 9 retaining and purging DNA analysis samples and records, the
- 10 department shall post a copy of the protocol changes on the
- department's website.
- 12 Sec. 302. (1) The department shall develop and deliver
- 13 professional, innovative, and quality training that supports the
- 14 enforcement and public safety efforts of the criminal justice
- 15 community.
- 16 (2) The department shall maintain the staffing and resources
- 17 necessary to provide educational opportunities for personal and
- 18 professional growth to a minimum of 10,000 state and local law
- 19 enforcement employees and other public safety partners.
- 20 (3) The department shall maintain the staffing and resources
- 21 necessary to provide educational opportunities for personal and
- 22 professional growth to a minimum of 3,000 community members.
- 23 (4) The department shall define and implement methods with a
- 24 goal of reducing the cost of training services delivery by 20%.
- 25 These methods may include the pursuit of technology to reach
- 26 students throughout the state utilizing distance learning.
- 27 (5) The department shall place emphasis on recruiting MCOLES-

- 1 certified police officers for the trooper recruit school. Emphasis
- 2 shall be given in the hiring process to those officers who are on
- 3 layoff and possess valid MCOLES certification. Any emphasis given
- 4 in the recruiting and selection process shall be consistent with
- 5 the department's hiring standards and in accordance with civil
- 6 service rules.
