SENATE BILL No. 1230

August 15, 2012, Introduced by Senators EMMONS, KAHN, CASPERSON, GREEN and MOOLENAAR and referred to the Committee on Economic Development.

A bill to amend 1987 PA 96, entitled "The mobile home commission act," by amending section 16 (MCL 125.2316), as amended by 2006 PA 328.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 16. (1) A person shall not operate a mobile home park or
seasonal mobile home park without a license.

- (2) Upon completion, review, and approval of certifications, the department shall grant a license to operate a mobile home park or seasonal mobile home park.
- (2) (3)—A 3-year license TO OPERATE A MOBILE HOME PARK OR SEASONAL MOBILE HOME PARK shall be granted and renewed by the department based—upon APPROVAL OF the certifications and recommendations of the appropriate agencies and local governments AND THE OWNER'S COMPLIANCE WITH APPLICABLE REQUIREMENTS OF RULES
